This bid shall cover all labor, materials, and equipment required to install a central air conditioning and heating system at the Suburban warehouse according to the below specifications.

Section 3.0 – Quantities/Inspection:

Bidders must inspect the site and perform their own inspections in order to determine the proper quantity of materials and equipment required to complete this project. All quantities listed are estimates and shall not be used by contractors for bidding and construction.

Section 4.0 - License requirements:

A Louisiana State Contractor's License is required in the following categories:


- **Mechanical Work (Statewide)**

A LA State Contractor's License will be required in accordance with LSA R.S. 37-2150 et. seq. and such license number will be shown on the outside of the bid electronic envelope. Failure to comply will cause the bid to be rejected. When submitting the bid electronically, the license number must be entered in the appropriate field in the electronic procurement system. Failure to comply will cause the bid to be rejected.

Installation:

- Furnish and install outdoor American Standard 2.0 Ton, 14 SEER Outdoor Condensing Unit or equal
- Furnish and install American Standard 2.0 Ton Air Handler Unit or equal with 10 kw electric heat strip
- 60 amp indoor electrical service and 30 amp outdoor electrical service will be provided by the Parish in the required location by code. Coordination with the Parish is required for timing and location.
- Bidding contractor will be responsible for connecting to electrical service.
- Spin-in combination scoop and volume damper for all round taps.
- Aluminum side wall registers & ceiling diffusers with opposed blade volume dampers.
- Provide sufficient platform for A/C unit.
- Provide 30x20 rectangular filter grille for internal line return air plenum.
- Diffusers & registers shall be mounted in pre-insulated boxes.
- All seams and joints taped in ductwork.
- ½" thick Armaflex on suction applied on copper refrigerant lines as recommended by manufacturer.
- Fabricate sheet metal return, supply plenum and route R-6 flex duct with insulation to four (4) supply registers following other requirements.

- Air conditioning and thermostat controls shall be Honeywell or Lennox or approved equal.
- Thermostat location shall be 60" above the floor in the designated locations
- Outdoor condensing platform shall be mounted on a raised fabricated platform minimum 1 foot, and placed on a poured 5"-6" poured concrete platform.
- All registers to be placed square to room and are not below joists/bottom chords or in the way of box beams and light fixtures.
- Install condensate drain with a clean out tee at the air handler. The tee shall have a removable cap for clean out purposes.
- Adjustable hot and cold air vents (white in color).
- System start up, testing and adjustment.
- Warranty and Service Work.

Section 6.0 - Hours of Work:

Work shall be performed during normal working hours. All work must be scheduled with owner representative 5 days in advance. The successful bidder shall work normal building working hours (8:00am – 4:00pm) to provide a safe work environment at no extra charge to Jefferson Parish.

Section 7.0 – Cleaning Area and Safety:

Job site must be clean and free of all litter and debris daily and upon completion of the contract. Passageways must be kept clean and free of material, equipment, and debris at all times. Precautions must be exercised at all times to safeguard the welfare and safety of the general public, employees of Jefferson Parish, and other Parish officials.

Section 8.0 – Existing Structure

Should any cutting, patching, alteration, addition, or repairs to existing structure be required of this project, the successful bidder shall restore the alteration to its original condition, with the same type materials, finish, and workmanship.

Section 9.0 – Warranty:

1. Warranty includes manufacturer standard warranty.
