Section 2.0 – Scope:

We extend this bid to provide all labor, materials, equipment and any/all associated items needed to remove existing floor covering and cove base and install new bidder supplied floor covering and cove base in the two (2) public restrooms on the second floor of the Jefferson Parish Metairie Senior Center located at 265 North Causeway Boulevard, Metairie, LA 70001.

Section 3.0 –License Requirements:

The following licenses will be required for this bid:

License required for this bid issued by the Louisiana State Licensing Board for Contractors:

- Commercial License

And a Specialty license in one of the following categories:

- Stone, Granite, Slate, Resilient Floor Installations, Carpeting
- Flooring and Decking

Section 4.0 – Quantities/Inspection:

Bidders must inspect the site and perform their own measurements in order to determine the proper quantity of materials and equipment required to complete this project. All measurements given in these specifications are informational only.

Section 5.0 Submittals:

If bidder intends to provide materials other than what is specified in Section 7.0 bidder must include with their bid submittal all literature indicating the submitted equipment and materials are greater than or equal to the owner specifications.

Submittals shall include but not limited to the following information:

- Manufacturer
- Manufacture specifications
- Product data sheets

- Cove base shall be place on all four walls in each restroom.
- Only one restroom shall be inoperable at a time. Work shall be completed in the first restroom before work can begin on the 2nd restroom.
- Supply one full case of each floor tile and cove base for attic stock.

6.1 Removal of Floor Covering and Cove Base

- Remove and properly dispose existing floor tile and cove base.

6.2 Floor Preparation:

- Prepare existing subflooring as per new flooring manufacture guidelines
- BOSTIK WEBCRETE® 95 floor leveler shall be used to level floor surface, quantity of ten (10) bags total. All unused bags shall be turned over to owner at completion of the project.

6.3 Porcelain tile and cove base:

Supply and Install the following:

- DALTILE: EMERSON WOOD glazed porcelain 8" x 36" HICKORY PECAN EP05, to walls for base.
- Cap for tile base: Schluter-Rondec # B100AGB Brushed Antique Bronze.
- BOSTIK TruColor Grout pre-mixed, no sealing required, chemical and stain resistant grout shall be applied to all surfaces.
- 3/8" Beige Marble threshold for each bathroom.
- Newly installed tiles must be level with new door threshold to prevent trip hazards.

Work shall be performed after normal working hours from Friday 6:00 p.m. to Monday 5:00 a.m. Flooring must be able to be walked on for business on Monday at 6:00 a.m. Any unfinished flooring work must be safe to be walked on by the public. All work must be scheduled with owner representative 7 days in advance.

Section 9.0 – Cleaning Area and Safety:

Job site must be clean and free of all litter and debris daily. Passageways must be kept clean and free of material, equipment, and debris at all times. Inflammable materials must be removed from the job site daily, because storage will not be permitted on the premises. Precautions must be exercised at all times to safeguard the welfare and safety of the general public, employees of Jefferson Parish, and other Parish officials.

Section 10.0 – Existing Structure

A Pre-Construction Conference shall be held between the successful bidder and the owner before any work commences.

No materials shall be ordered until the successful bidder receives a written "Notice to Order Materials" from the Department of General Services.

No work shall be performed until the successful bidder receives a written "Notice to Proceed" to begin work, from the Department of General Services.




