

## BID BOND

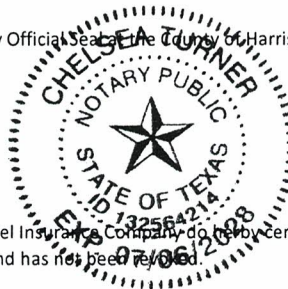
