- Install a 60 MIL fully adhered TPO roof according to the manufactures specifications
- Fabricate and install a new 24 gauge painted steel drip edge on the entire perimeter

Section 4.0 – Warranty:

All workmanship shall have a five (5) year warranty and twenty (20) year manufactures warranty in writing from the date of acceptance on the project against defects. The bidder must agree, upon written notice from the owner promptly and without charge, and to the satisfaction of the owner, to make changes, replacements, and corrections which may be required to make good all defects, within the warranty period, at no cost to the owner.

STANDARD INSURANCE REQUIREMENTS FOR BIDDING PURPOSES

All required insurance under this bid shall conform to Jefferson Parish Resolution No. 113646 or No. 113647, as applicable. Contractors may not commence any work under any ensuing contract unless and until all required insurance and associated evidentiary requirements thereto have been met, along with any additional specifications contained in the **Invitation to Bid**. Except as where otherwise precluded by law, the Parish Attorney or his designee, with the concurrence of the Director of Risk Management or his designee, may agree on a case-by-case basis, to deviate from Jefferson Parish's standard insurance requirements, as provided in this Section. Vendors requesting deviation therefrom shall submit such requests in writing, along with compelling substantiation, to the Purchasing Department prior to the bid's due date. Any changes to the insurance requirements will be reflected in the bid specifications and addenda. Prior to contract execution and at all times thereafter during the term of such contract, contractors must provide and continuously maintain all coverages as required by the foregoing Resolutions, and the contract documents. 
