In reference to Bid 50-00124008 One Time Purchase of Two Electric Compressors, Quality Compressed Air Services, Inc. will not be providing the following items due to the manufacturer not providing these items.

1. Five Year Pro-Rated Warranty- this warranty is no longer offered by the factory. The current warranty states that there will be a one year warranty on the package with a three year 100% warranty on the pump. The Head Valves will fall under the one year warranty. Champion Warranty Statement attached. (page SP-4 of original bid)
2. Stainless Steel flexible shielded welded tubing connection minimum one foot long for installation purposes will not be provided. (page SP-3 of original bid)
3. Pipe Extension beyond the base skid for oil drainage will not be provided (page 3 regarding SP-4 in Bid Addendum #1)



If a component failure is deemed a result of using non-genuine Champion parts and lubricants, warranty will not be allowed.**
