


## **CORPORATE RESOLUTION**

## **SECTION I**

### **INSTRUCTIONS TO BIDDERS**

#### **1. CHANGE IN CONTRACT QUANTITY**

The quantities shown are estimated quantities based upon the use of the Consolidated Waterworks District #1 (hereinafter referred to as "District") during the past year. The District reserves the right to either increase or decrease the quantities, to fulfill its needs. The Bidder declares that he understands that if the quantities of any of these items are increased, the undersigned proposes to furnish these units at the unit price set herein, and should the quantities be decreased he also understands that payment will be made on the actual quantities furnished at the price bid and will make no claim for anticipated profits for any decrease in the above mentioned items. Bid prices on the items listed will be firm for a period of one (1) year from the date of award to the successful bidder.

#### **2. EQUIVALENT PRODUCT(S)**

Whenever in specifications the name of a certain brand, make, manufacturer, or definite specification is utilized, the specification is being used only to denote the quality standard of products desired and that they do not restrict bidders to the specific brand, make, manufacturer, or specifications named; that they are used only to set forth and convey to prospective bidders the general style, type character, and quality of products desired; and that equivalent products will be acceptable. Any Bidder wishing to submit for consideration on an equivalent product(s) that he feels is equal to the product(s) specified may do so by submitting a sample of the product(s) and a letter indicating all differences that his product(s) may have from that specified. This letter and sample must be submitted for prior approval and received no later than ten (10) calendar days prior to the date the bids are to be received. No equivalent product(s) will be considered for this project without prior approval. Approved equivalent product(s) shall be issued by appropriate addendum prior to the bid date.

#### **3. SUBMITTAL ON ALL PROPOSALS OR INDIVIDUAL BID ITEMS**

Bidders may submit bids on all proposals or on individual proposal items.

#### **4. STATE AND LOCAL TAXES**

Consolidated Waterworks District No. 1 is exempt from any state and local sales taxes.

#### **5. FREIGHT CHARGES**

Bid price shall include all freight charges to deliver from point of shipment to Consolidated Waterworks District No. 1 at 8814 Main Street, Houma, Louisiana.

## **6. DELIVERY**

Successful bidder shall be required to make delivery of supplies in the following manner:

Proposal “C” and “D” – Boxes on pallets one half of total quantity bid per order from Purchasing Agent. Each proposal is independent from other proposal.

Proposal “E” thru “W”, “AA”, “BB” and “FF” thru “HH” – One half of total quantity bid per order from Purchasing agent. Each proposal is independent from other proposal.

Proposal “X” – 10 Saddles per order from Purchasing Agent. Not more than 10 Saddles per packing box.

Proposal “Y” - 300 Saddles per order from Purchasing Agent. Not more than 10 Saddles per packing box.

Proposal “Z” – 50 Saddles per order from Purchasing Agent. Not more than 7 Saddles per packing box.

Proposal “CC” – 10 Saddles per order from Purchasing Agent. Not more than 10 Saddles per packing box.

Proposal “DD” – 300 Saddles per order from Purchasing Agent. Not more than 10 Saddles per packing box.

Proposal “EE” – 20 Saddles per order from Purchasing Agent. Not more than 7 Saddles per packing box.

All other Proposals, ship total quantity when ordered by Purchasing Agent.

## **7. SELECTION OF LOW BIDDER**

The sum of all of the columns denoted “UNIT PRICE EXTENSION (*Quantity X Unit Price*)” for the complete list of items each contractor bid on, will be submitted on the LOUISIANA UNIFORM PUBLIC WORK BID FORM, on the row designated as “BASE BID: For all work required by the Bidding Documents (including any and all unit prices but not alternates) the sum of:” and used for informational purposes. Award of purchase contracts will be determined by the low bidder per item who meets the specifications established herein. Each of the items listed shall be considered a separate item bid upon. The low bidder per item will be selected based upon the lowest price bid for that item.

## **8. GENERAL PROVISIONS**

- A. The District reserves the right to reject any and all bids based upon violation of Louisiana Law or based upon the lowest responsible or acceptable bid being in excess of the Districts' budgetary estimates for this project or other reasonably valid fiscal considerations which make the District unable to award this contract.
- B. The District may elect to waive non-compliance with procedures set forth in the bid documents to the extent permitted by Louisiana Law as long as such waiver does not unreasonably affect another bidder.
- C. All bids must be signed and submitted or delivered to the District prior to the time specified as the time for receipt of bids, unless another method of bidding is specifically set forth in the specifications.
- D. The successful bidder will be expected to timely comply with the delivery of the object or objects to be purchased or the performance of the work or any combination thereof in a reasonable time period considering the reasonable needs and requirements of the District unless a specified time period is set forth in the specifications.
- E. Failure to comply with the timing provisions set forth in item "D" immediately above on the part of the contractor or supplier shall subject the contractor or supplier to any or all of the following relief in favor of the District:
  - 1. Specific Performance
  - 2. Damages
  - 3. Any combinations of these two elements

## **9. BID WITHDRAWAL**

At any time prior to the scheduled closing time for receipt of proposals, any bidder may withdraw his proposal. After the scheduled closing time for the receipt of proposals or before award of the contract, no bidder will be permitted to withdraw his proposal, unless said award is delayed for a period exceeding thirty (30) days or the date of the next regular meeting of the Board whichever is longer. Negligence on the part of the bidder in preparing the bid confers to no rights for the withdrawal of the proposal after it has been opened.

**1. MATERIAL SPECIFICATION**

Materials sought through this bidding process are intended to be used in conjunction with a public water supply. Brass materials designed to come in contact with the potable water system will be used as designed. Vendors shall submit on materials designed to meet the current Drinking Water Regulations.

Upon request, the manufacturer shall provide certification that the products meet the brass specification.

**A. LOW LEAD BRASS**

Brass curb stops, corporation stops, service line valves and fittings, and all other brass products coming in contact with potable water shall be manufactured with a designation indicating low lead within the catalog number. The brass alloy used for all surfaces coming in contact with potable water shall be UNS/CDA number C89833 as listed in ANSI/AWWA C800-05 Standard and the products produced with this alloy shall meet the ANSI/NSF-61 Standard certification complying with the current Drinking Water Regulations. Service saddles are exempt from the Low Lead Requirement.

These products shall have a low lead marking cast into the main body for proper identification.

**B. NORMAL BRASS**

Brass components that do not come in contact with potable water shall meet the requirements of AWWA C800-05, ASTM B62 and ASTM B584, using UNS/CDA number C83600.

In addition, all brass goods designed to hold internal water pressure shall be individually tested by the manufacturer as an integral part of the production process to ensure that they meet the pressure requirements established by AWWA Standard C800. This requirement shall apply to each individual product; “batch” testing is not allowed.
