JEFFERSON PARISH reserves the right to cancel all or any part of an order if not shipped promptly. No charges will be allowed for parking or cartage unless specified in the quotation. The order must not be filled at a higher price than quoted. JEFFERSON PARISH requires all products to be new (current) and all work must be performed according to standard practices for the project. All awards in excess of \$25,000.00 will require both a performance and a payment bond. The Pre-Bid Conference and inspection does not relieve the successful bidder from necessity of furnishing materials or performing any work that may be required to complete the work in accordance with the specifications without cost to the owner.

**Section 2.0 – Scope:**

We extend this proposal to cover the furnishing of labor, materials, shipping, moving of furniture and all other equipment necessary to remove and properly dispose of the existing carpet and baseboards to make way for the new contractor supplied and installed carpet tiles, rubber cove base, and transition strips in suite 333 of the Joseph S. Yenni Building, located at 1221 Elmwood Park Boulevard, Jefferson, LA, 70123.

**Section 3.0 – Quantities/Inspection:**

It is suggested that Bidders inspect the site and perform their own measurements in order to determine the proper quantity of materials required to complete the job.

**Section 4.0 – Bid Specifications:**

The successful contractor shall cover the furnishing of labor, materials, shipping, moving of furniture and all other equipment necessary to remove and properly dispose of the existing carpet and baseboards located in suite 333 of the Joseph S. Yenni Building to make way for the new contractor supplied and installed carpet tiles, rubber cove base, and transition strips as listed in these specifications for suite 333 at the Joseph S. Yenni Building, located at 1221 Elmwood Park Boulevard, Jefferson, LA, 70123.



Commercial carpet tile and cove base shall fit neatly against vertical surfaces, into breaks and recesses, against bases, and penetrations, and thresholds, against door frames. Contractor shall also provide and install new transition strips to meet ADA guidelines between flooring materials and doorways where needed.

All new contractors supplied and installed materials shall as specified and match with existing carpet tiles, cove base, and threshold transitional strips.

The adhesive for the cove base and carpet tiles shall meet or exceed manufacturer's guidelines and standards. The amount of adhesive applied shall be as recommended by product and adhesive manufacturer for applicable product backing. Cover only that amount of area that can be covered by the product within the recommended working time of the adhesive.

Spots and smears including glue shall be removed immediately from the product with solvent. Spots and smears shall also be removed from adjacent surfaces.

Contractor shall supply and install new Interface Satori style 5143 Meditate carpet tiles to the areas listed in the specifications.

Contractor shall use the Ashlar method of installation using tac tiles for this project.

Contractor shall supply and install new black low profile rubber transitional strips in all door thresholds and any other area required to complete this project.

Contractor shall install and supply all new wall base and pre-molded corners with Roppe 1/8" thick, 4" wide Type TS RP100 1/8" vulcanized SBR rubber black cove base with toe to match existing cove base. Cove base shall be constructed of first-quality materials and shall be smooth and free from imperfections which detract from its appearance. The base shall conform fully to the performance requirements of Standard Specifications F-1861, Type TS Group 1. All wall bases shall match existing product.

Bidders shall familiarize themselves with all existing conditions. Any questions concerning the project and/or specifications shall be addressed to Eric Romain at 736-6036 between the hours of 8:30 a.m. and 4:00 p.m., Monday through Friday.

The Contractor shall examine all surfaces to which the carpet tile and cove base is applied, and any conditions detrimental to the proper installation of tile, shall be corrected by the Contractor before the installation of the carpet tile. The bid must include a price per bag for a total of six (6) bags of floor patch, labor, and equipment to prepare floor for new carpet tile installation. The floor patch to be used shall be of premium grade such as ARDEX FETHEREDGE or owner approved equal. Unused bags will be credited to Jefferson Parish.

On a separate line, price the cost for a bag of ARDEX FEATHEREDGE and the labor to apply it, if additional bags are needed to patch the hallway floor.

**Section 4.1 – Work Schedule:**

The work that is to be performed on this project shall be performed during normal working hours. Normal working hours are from 8:00 a.m. to 4:30 p.m., Monday through Friday.

**Section 4.2 – Restoration:**

Should any cutting, patching, painting, alteration, addition, or repairs to existing structure, wall, floor, ceiling, or part of building be required of this project, the contractor shall restore the alteration to its original condition, with the same type materials, finish, and workmanship.

**Section 5.0 – Cleaning Area and Safety:**

Job site must be clean and free of all litter and debris daily and upon completion of the contract. Passageways must be kept clean and free of material, equipment, and debris at all times. Inflammable material must be removed from the job site daily, because storage will not be permitted on the premises. The use of onsite parish owned dumpsters will not be allowed for this project. Precautions must be exercised at all times to safeguard the welfare and safety of the general public, employees of Jefferson Parish, and other Parish officials.

**Section 6.0 – Warranty:**

All workmanship and materials must have at least one (1) year guaranty, in writing, from the date of acceptance of the project, against defects. The contractor must agree, upon written notice from the owner, promptly and without charge, and to the satisfaction of the owner, to make changes, replacement, and corrections which may be required to make good all defects in materials and/or equipment under its intended use, within the warranty period.

The contractor will also guaranty that he will hold the Parish of Jefferson harmless from any damage arising from faulty workmanship or materials performed and/or installed within the duration of the warranty.

**Section 7.0 – Permits:**

The successful bidder shall obtain any and all permits required by the Jefferson Parish Department of Inspection and Code Enforcement. The successful bidder shall also be responsible for payment of these permits. All permits must be obtained prior to the start of the project.
