By submitting a bid, vendor agrees to comply with all provisions of Louisiana Law, as well be in compliance with the Jefferson Parish Code of Ordinances, Louisiana Code of Ethics, applicable Jefferson Parish ethical standards and Jefferson Parish Resolution No. 113646 and/or Resolution No. 113647. 1. All bidders must attend the MANDATORY pre-bid conference and will be required to sign in and out as evidence of attendance. In accordance with LSA R.S. 38:2212(I), all prospective bidders shall be present at the beginning of the MANDATORY pre-bid conference and shall remain in attendance for the duration of the conference. Any prospective bidder who fails to attend the conference or remain for the duration shall be prohibited from submitting a bid for the project.
2. Attendance to this pre-bid conference is optional. However, failure to attend the pre-bid conference shall not relieve the bidder of responsibility for information discussed at the conference. Vendor makes no warranties either express or implied regarding title, quality or conformity of the Products, including without limitation no implied warranty of merchantability, no implied warranty of fitness for a particular purpose, and no implied warranty arising from any course of dealing, usage of trade or advertising, except the following express warranties with respect to all goods sold by Vendor and paid for by Jefferson: (i) the title conveyed is good, and its transfer rightful, (ii) the Products shall be delivered free of any security interest, lien or encumbrance, and (iii) the Products delivered will conform to the description, grade and condition of the Products invoiced. The manufacturer of the products may provide its own warranty. All such warranties will be passed on to Jefferson, to the fullest extent allowed. Vendor does not represent or warrant the existence or scope of manufacturer’s warranty.

In the event of any conflict or inconsistency between the terms of this Addendum and the contract, this Addendum shall control. Jefferson’s acceptance of Vendor’s bid shall constitute Jefferson’s complete and unequivocal acceptance of and agreement with this Addendum.
