LIMITED POWER OF ATTORNEY

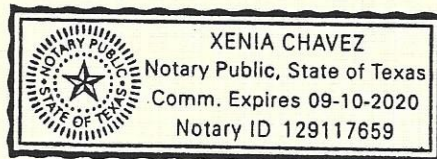
