The conditions of this Bond are such that if the Owner accepts the bid of the Contractor within the time specified in the bid documents, or within such time period as may be agreed to by the Owner and Contractor, and the Contractor either (1) enters into a contract with the Owner in accordance with the terms of such bid, and gives such bond or bonds as may be specified in the bidding or Contract Documents, with a surety admitted in the jurisdiction of the Project and otherwise acceptable to the Owner, for the faithful performance of such Contract and for the prompt payment of labor and material furnished in the prosecution thereof; or (2) pays to the Owner the difference, not to exceed the amount of this Bond, between the amount specified in said bid and such larger amount for which the Owner may in good faith contract with another party to perform the work covered by said bid, then this obligation shall be null and void, otherwise to remain in full force and effect. 5. For performance standards and standardization some items have been specified by brand and model numbers. These items shall be provided as requested and should be available for all manufacturers to supply. If a brand and model specific item is not available, then list it on the clarifications page along with what alternate item is being provided. (The Thibodaux Vol. Fire Dept. will be the sole decider to what is an approved equal)
6. A preconstruction conference shall be held at Thibodaux Fire Dept. to answer and clarify any questions the fire department or manufacturer has/needs in the construction of the apparatus.
7. Apparatus, to ensure proper break in of all components while still under warranty, shall be delivered under its own power. Rail or truck freight shall not be acceptable. A qualified delivery representative shall deliver the apparatus and remain for a sufficient length of time to instruct personnel in proper operation, care and maintenance of the equipment delivered. Note that any time during delivery up until final acceptance at TVFD Central Station in Thibodaux, bidder's insurance certificate will cover apparatus. Should some major accident happen during transit and major damage (at the discretion of the TVFD) occur, the TVFD does have the option to not accept the apparatus and require a complete rebuild at the bidder's expense.
8. Each proposal must be accompanied by a Bid Bond in the amount of 5% of the bid submitted as a proposal guarantee, which, it is agreed by the bidder, will be forfeited in the event their proposal is accepted and the contract is not executed. Bid bond shall be signed by an Officer of the manufacturing company. Personal or Company checks are not acceptable as a Bonding medium. Page 2 – Service Capabilities- Delta Fire & Safety nearest service location to Thibodeaux Volunteer Fire Department is 235 Eastpark Dr. Eunice La. 70535.

Service Center Service Capabilities: In shop and Mobile certified EVT technicians for repairs, services and annual testing of the following: Fire pumps, breathing air systems, extrication systems. We also provide custom fabrication and collision repair. Delta Fire & Safety specializes in preventative maintenance programs custom tailored to the department's needs on and off site.

Page 4 - Approved Custom Chassis Manufacturers - We are proposing this apparatus will be built utilizing a Spartan Emergency Response Metro-Star LTD 2-Door custom cab chassis.

Page 5 - Body Sub Frame Warranty – Clarification - This warranty is included as part of the Body Structure Warranty. The body subframe is integral to our Tri-Max Space Frame body design.

Page 5 - Apparatus Wheelbase – Clarification - Our proposed apparatus will have a wheelbase of 167.00 inches.

Page 5 - Apparatus Overall Length – Clarification – Our proposed apparatus will have an overall length of 371.00 inches (31'-11').

Page 6 – Front Windshield – Clarification – The Spartan Metro-Star chassis utilizes a two-piece windshield design.



Page 6 – Air Conditioning Package -Exception – Due to the design on the Metro-Star LTD 2-door cab with a transverse compartment the air condition & heater unit will be mounted at the rear of the engine tunnel. There is limited space to provide for an overhead style system.

Page 7 – Front Axle – Clarification – We are providing a 20,000 lb. rated Hendrikson SteerTek front axle.

Page 7 – Front Suspension – Clarification – We are providing a Hendrickson parabolic spring suspension rated for 20,000 lbs.

Page 7 – S-Cam Brakes – Clarification – We are providing Meritor 17” disc brakes on the front axle and S-Cam style brakes on the rear axle.

Page 8 – Frame Rails – Clarification – The Spartan chassis uses 10.25” high x 3.75” deep steel frame rails.

Page 8 – Vehicle Top Speed – Clarification – We are proposing a vehicle with a top speed of 68 miles per hour.

Page 8 - Engine, 450 HP., Cummins – Clarification – We are proposing the Cummins L9 450 HP diesel engine based on the availability at the time of this proposal submission. The following clarification is per information provided by Spartan Chassis. If an L9 engine is NOT available or cannot be provided for that specific quote or build slot at time of production, you will automatically be upgraded and charged for an X12 (or the X10 engine) with all costs associated with the upgrade being passed on to the end user. Page 8 – Auxiliary Engine Brake – Clarification – We are providing a variable geometry turbo (VGT) as an integrated auxiliary engine brake to offer a variable rate of exhaust flow, which when activated in conjunction with the compression brake shall enhance the engine's compression braking capabilities. The Jake exhaust style engine brake is no longer available on engines meeting the current EPA standards. The system we are providing comes with the Cummins engine and is manufactured for them by Jacobs.

Page 8 – Electrical System Point to Point – Exception – We are providing the Weldon V-Mux multiplex 12-volt electrical system in place of the 12 volt point to point system specified. The Weldon V-Mux is the standard system Spartan Emergency Response offers.

Page 8 – Vehicle Data Recorder/Seat Belt Warning – Clarification – We are providing a Weldon Vehicle Data recorder and seat belt warning system. This system will be integral to the V-Mux multiplex system with the information being accessed and displayed on the system screen.

Page 8 – Four (4) Group 31 Batteries – Clarification – We are providing Six (6) Harris BCI 31 925 CCA batteries with a 210-minute reserve capacity and 4/0 welding type dual path starter cables per SAE J541.

Page 9 – Battery Relocation – Clarification – We are locating the Six (6) battery system we have proposed to be mounted above the transmission across the frame rails. The battery storage will be under the the transverse compartment integral with the cab.

Page 9 – Federal “QB2” Siren – Clarification - We are providing a recessed mount siren in place of the pedestal mount siren specified. This change is due to the design required for the Three compartments specified in the front bumper with the full width, raised style compartment door.

Page 10 – Class 1 TSM Load Management – Clarification – The Class 1 TMS load management system will be part of the Weldon V-Mux multiplex electrical system.

Page 11 – InView 7” Color Monitor – Exception – The InView 360 cameras will be viewed utilizing the screen on the Weldon V-Mux multiplex electrical system screen.

Page 12 - 3/16” Aluminum Body Upgrade – Clarification - We are providing our Tri-Max™ Space Frame design, which serves as an incredibly durable, structural body framework in place of the formed 3/16” aluminum body specified.

This framework acts as a series of beams and columns that support and protect the body and its contents. The space frame design provides maximum torsional resistance and load capabilities. The entire space frame structure shall be welded together utilizing an A.W.S. Certified welding procedure.

The space frame design shall also be required because it provides energy absorbing impact zones in the structure, thus providing increased safety to the rest of the apparatus and personnel on board. Documented proof of this extra safety shall be required upon request.

The Tri-Max™ body structure shall consist entirely of closed section members, except where the body is mounted to the chassis. Closed section members (such as square, rectangular, triangular, or round tubes) are required because they provide maximum strength and torsion rigidity. This solid tubular structural style of design ultimately adds longevity to the body structure by eliminating flex and twists in material, creating less stress and fatigue.

BODY STRUCTURE MEMBERS



The space frame body shall have triangular shaped structural members in certain areas of the body. This shape is required to prevent loss of useable compartment space. Other body structure members shall be square or rectangular. Each structural member will have a nominal outside dimension of 2.50 inches (63.50 mm) in at least one direction. The body shall be designed for maximum strength to weight ratio; therefore the gauge of sheet metal and structural members varies from .125 inches (3.18 mm) to .250 inches (6.35 mm) throughout, dependent on the design requirement.

BODY MATERIAL TYPE

These alloys are required because it provides optimum all-around performance for strength, manufacturing properties, and corrosion resistance.

ECK® ANTI-CORROSION PROCESS

Absolutely no dissimilar metals shall be used in the body and its supporting substructure without being separated by Eck®, which prevents corrosion by providing a barrier between dissimilar metals, sealing out moisture and absorbing energy created by a dissimilar metal reaction.

FRONT BODY COMPARTMENT WALLS

The front compartment walls of both forward most compartments shall be sheet finished. No overlay material shall be visible from the interior of the compartments.

REAR BODY COMPARTMENT WALLS

The rear compartment walls of both rearward most compartments shall be sheet finished. No overlay material shall be visible from the interior of the compartments. Access panels from the rear walls shall be strategically placed to ensure access to the rear taillight clusters for any servicing that may be completed.

The top of the compartments shall be an integral portion of the body. No overlay material shall be visible from the interior of the compartments.

COMPARTMENT FLOORS

The body compartments shall be enclosed with aluminum sheet metal as specified above. The compartment floors shall have a 1.00-inch (25.40 mm) lip downward at the door opening side of the compartment. This lip shall integrate with a structural member on the bottom edge and form a “sweep-out” compartment. This design shall also allow for a structural flush fitting door frame and a complete door/weather seal.

COMPARTMENT LOAD CAPACITY



Each compartment shall have a minimum of one additional structural compartment floor support centered on the underside of the compartment floor. This additional member shall be integral with the rest of the body structure. Each compartment must be designed, and 3rd party analyzed to carry a working load of:

Full depth side compartment: 1,000 lbs (453.59 kg) per compartment

Half depth side compartment: 750 lbs (340.19 kg) per compartment

Rear center compartment (if applicable): 1,500 lbs (680.39 kg)

NOTE: These values are for design purposes only for individual compartment construction and are not meant to be used as an actual overall weight rating for equipment load per compartment for the specified apparatus. The apparatus shall be engineered such that the completed unit, when loaded to its estimated in-service weight, shall comply with the gross axle weight ratings {GAWR}, the overall gross vehicle weight rating {GVWR}, and the chassis manufacturer's load balance guidelines per NFPA.

FASTENERS

All bolts and nuts used in the finish construction of the apparatus shall be coated stainless steel which helps prevent dissimilar metal electrolytic reaction and corrosion. Any bolt extending into a compartment shall have an acorn nut attached or be protected in such manner where sharp edges are avoided.

FINITE ELEMENT ANALYSIS

The proposed body design must have completed a review and analysis by a legitimate 3rd party engineering firm. At a minimum, the 3rd party must have conducted a computer model finite element analysis of the proposed design. The analysis is to include real world working load scenarios. Analysis to cover both static and dynamic situations must be completed. The purpose of the finite element analysis is to ensure proper design of the apparatus body, and that it is capable of carrying the typical fire apparatus loads and those specified by NFPA for equipment. The analysis process must conclude that the body structure is properly designed and manufactured to provide longevity under normal conditions. The 3rd party must also validate the manufacturing processes are consistent with the design and analysis performed.

Page 12 – Body Subframe – Exception - Due to the Tr-Max Space frame design of our body structure. The subframe is an integral part of the tubular body construction, therefore there is no need for a separate steel subframe to support the body. Due to this integral design, there is no need for the subframe to be hot-dipped galvanized.

Page 12 – Body Width 101” – Clarification – Our standard body width is 99” wide from body side sheet to side sheet. The overall width of the body included the lower body rub rails is approximately 101.”

Page 12 -Body Length 210”- Clarification – We are proposing our standard 214” body length for this apparatus. This exceeds the minimum of the 210” specified.



Page 13 & 14– Exterior Body Compartments – Clarification – We are providing the following compartment dimension based on our 214” body length.

Compartment "L1"

There shall be one (1) full height compartment ahead of the rear wheels, directly behind the chassis cab on the left side of the apparatus.

The approximate interior dimensions of this compartment shall be 49.00 inches wide by 74.00 inches high with a lower depth of 25.50 inches and transverse in the upper portion.

The framed door opening shall measure approximately 46.50 inches wide by 70.00 inches high.

Compartment "L2"

There shall be one (1) full height compartment ahead of the rear wheels, directly behind the L1 compartment on the left side of the apparatus.

The approximate interior dimensions of this compartment shall be 49.00 inches wide by 74.00 inches high with a lower depth of 25.50 inches and transverse in the upper portion. Transverse floors to be raised to allow the cooler to fit in L2.

The framed door opening shall measure approximately 46.50 inches wide by 70.00 inches high.

Compartment "L3"

There shall be one (1) compartment directly over the rear wheels on the left side of the apparatus.

The approximate interior dimensions of this compartment shall be 62.00 inches wide by 44.50 inches high and be transverse.

The framed door opening shall measure approximately 62.00 inches wide by 40.50 inches high.

Compartment "L4"

There shall be one (1) full height compartment behind the rear wheels, on the left side of the apparatus.

The approximate interior dimensions of this compartment shall be 49.00 inches wide by 74.00 inches high x 25.50 inches deep.

The framed door opening shall measure approximately 46.50 inches wide by 70.00 inches high.

Compartment "R1"

There shall be one (1) full height compartment ahead of the rear wheels, directly behind the chassis cab on the right side of the apparatus.

The approximate interior dimensions of this compartment shall be 49.00 inches wide by 74.00 inches high with a lower depth of 25.50 inches and transverse in the upper portion.



The framed door opening shall measure approximately 46.50 inches wide by 70.00 inches high.

Compartment "R2"

There shall be one (1) full height compartment ahead of the rear wheels, directly behind the R1 compartment on the right side of the apparatus.

The approximate interior dimensions of this compartment shall be 49.00 inches wide by 74.00 inches high with a lower depth of 25.50 inches and transverse in the upper portion. Transverse floors to be raised to allow the cooler to fit in L2.

The framed door opening shall measure approximately 46.50 inches wide by 70.00 inches high.

Compartment "R3"

There shall be one (1) compartment directly over the rear wheels on the right side of the apparatus.

The approximate interior dimensions of this compartment shall be 62.00 inches wide by 44.50 inches high and be transverse.

The framed door opening shall measure approximately 62.00 inches wide by 40.50 inches high.

Compartment "R4"

There shall be one (1) full height compartment behind the rear wheels, on the right side of the apparatus.

The approximate interior dimensions of this compartment shall be 49.00 inches wide by 74.00 inches high x 25.50 inches deep.

The framed door opening shall measure approximately 46.50 inches wide by 70.00 inches high.

Compartment "B1"

There shall be one (1) compartment located at the rear of the apparatus.

The approximate dimensions of this compartment shall be 48.00 inches wide by 74.00 inches high and shall have a depth of 46.50 inches.

The framed door opening shall measure approximately 43.00 inches wide by 69.00 inches high.

Page 14 – Top Side Cascade Bottle Compartments – Clarification – We are providing the following for the storage of Eight (2) 6000 PSI breathing air storage cylinders.

One (1) set of upper storage compartments will be provided and installed on the left & right side of the apparatus body. Each compartment shall be approximately 165.00 inches long. The depth of the compartments shall be determined by the hose bed wall height. The compartment shall extend beyond the apparatus body roof and walking surface and provide a vertical edge to prevent water intrusion. An adhesive



backed bulb seal shall be applied to the underside perimeter of the lid, excluding the hinge side, to ensure a positive seal.

The upper compartments shall not be vented. There shall be plastic tubing installed for adequate drainage that is routed from corners of the upper compartment floors down to below the lower compartment floor level.

Two (2) access doors with an approximate door opening of 78.75 inches by 22.00 inches shall be provided. The formed doors, incorporating broken edges of 45 degrees or less, shall extend over the compartment edge approximately 1.00 inch to minimize water penetration. Each door shall be secured by push button weather resistant (C2) South Co Brand style latches. The doors shall be fabricated of embossed aluminum diamond plate and be secured by a stainless-steel hinge. If deemed necessary due to width, the doors shall be reinforced to act as a suitable walking or standing surface. Each door shall be held open by a gas charged strut on each side and permit full access to the compartment along its length.

The struts shall be concealed inside the compartment when the door is in the closed position. The compartments shall be constructed as part of the body and be accessible from the upper body walkway area.

If the door is not properly closed and the parking brake is released, it shall activate the "Door Open" indicator light in the cab to warn the crew.

Page 14 - Four Tool Boards for SCBA Mounting- Clarification- We are proposing a Two (2) Floor mounted roll-out tray. Each roll-out tray will have a vertical center wall with unistrut mounted to both sides for mounting the SCBA brackets. The tray will provide storage for the face masks for each SCBA unit. One tray will be mounted in compartment L2 and one will be mounted in compartment R2.

Page 15 – Ten (10) Place SCBA Spare Bottle Storage – Clarification – We are proposing a total of Eight (8) vertically storage to right side of the rear compartment due to the layout needed for the fill station, cascade control panel and booster pump.

Page 15 – Storage Bin for Tent & Chairs – Clarification - We have proposed storage slots be located in the cab transverse compartment on the right side. The department will need to confirm make, model and storage dimensions prior to order submission.

Page 15 – 10” Rear Step – Clarification – We are posing our standard 13.5” deep rear step with cast aluminum end cap for mounting the lower rear zone B & D rear warning light.

Page 16 – 15 KW PTO Generator – Clarification – We are proposing a Smart Power HR 15000 PTO hydraulic generator.

Page 16 – Rear Wheel Storage for Fire Extinguishers – Clarification – We are proposing our "Smart Storage Compartments" for the rear wheel well. This custom storage allows for different storage configurations. We ha proposed using this storage system for the fire extinguishers and wheel chocks. The department will approve the final configuration prior to order submission.
