**Section 2.0 – Scope:**

We extend this bid to cover all labor, materials and necessary essentials to sand and refinish the gym floor at Girard Playground, 5300 Irving St., Metairie, LA 70003

**Section 3.0 – Quantities/Inspection:**

Bidders must inspect the site in order to determine the proper quantity of materials and equipment required to complete this project.

**Section 4.0 – Bid Specifications:**

The successful bidder shall supply all labor, materials, and necessary essentials to perform the following at Girard Playground, 5300 Irving St, Metairie 70003:

- Contractor shall prep and screen approximately 6,500 square feet of gym floor.
- Furnish and install two coats of Bona sports poly waterborne finish or equal.
- Furnish and Install touch up paint on the gym floor.
- All work must be done in a workmanship like manner

**Section 5 – Hours of Work:**

Work shall be performed during normal working hours. All work must be scheduled with owner representative 5 days prior to execution. The successful bidder shall work normal building work hours (8:00 am – 4:00 pm) to provide a safe work environment at no extra charge to Jefferson Parish.

**Section 6 – Cleaning and Safety:**

Job site must be clean and free of all litter and debris daily and upon completion of the contract. Passageways must be kept clean and free of material, equipment, and debris at all times. Inflammable material must be removed from the job site daily, because storage will not be permitted on the premises. Precautions must be exercised at all times to safeguard the welfare and safety of the general public, employees of Jefferson Parish, and other Parish Officials.

Should any cutting, patching, alteration, addition, or repairs to existing structure, wall, floor, ceiling, or part of building be required of this project, the successful bidder shall restore the alteration to its original condition, with the same type materials, finish, and workmanship.

### **Section 8.0 – Warranty:**

6 months labor and material on the gym floor covering the adhesion of the clear coats: does not cover scratches, wear and tear, etc.

### **Section 9.0 – SDS:**

The bidder shall notify the Jefferson Parish Department of Recreation contact person of any hazardous substances that will be brought to and/or used at the workplace. The bidder shall provide SDS as per this requirement to the Director of Jefferson Parish Recreation Department.

### **Section 10.0 – Pre-Construction Conference and Notice to Proceed:**

A Pre-Construction Conference shall be held between the successful bidder and the owner before any work commences. No work shall be performed until the successful bidder receives a written “Notice to Proceed” to begin work from the Department of Recreation.

### **Section 11.0 – Construction Term:**

Upon receiving a notice to proceed, the bidder agrees that work shall be completed as follows: Vendor agrees to commence actual physical work on the site with an adequate force and equipment within 5 days from the date of Notice to Proceed.
