

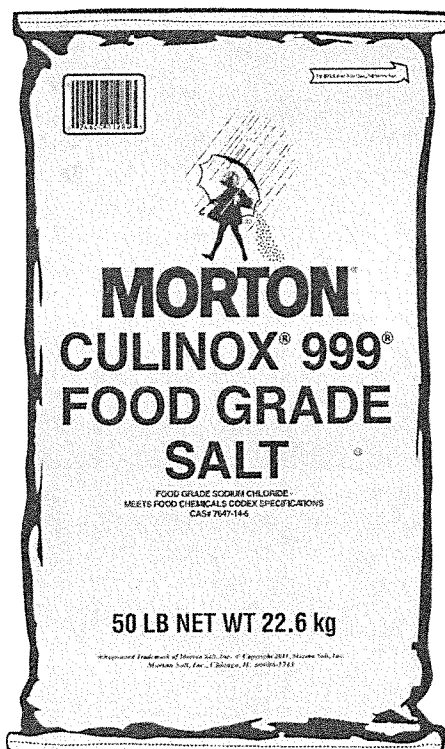

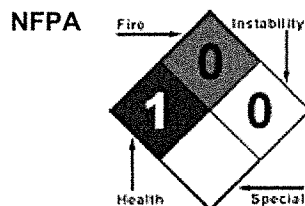

TECHNICAL INFORMATION

The bidder shall submit material safety data sheets and product data sheets within 10 calendar days after the bid opening.

INSURANCE REQUIREMENTS - BIDS

All insurance requirements shall conform to Jefferson Parish Resolution No. 113646 or No. 113647. The contractor shall not commence work under this contract until he has obtained all insurance and complied with the requirements of the specifications and said Parish Resolutions.
