JEFFERSON PARISH reserves the right to cancel all or any part of an order if not shipped promptly. No charges will be allowed for parking or cartage unless specified in the quotation. The order must not be filled at a higher price than quoted. **Section 2.0 - Scope:**

We extend this bid to provide labor, equipment, and materials necessary to perform the following work in the Administrative Building of the Traffic Engineering Division:

- Remove and discard existing carpet and tile (excluding restrooms)
- Clean and prep for new flooring (if needed)
- Dismantle and remove office furniture from offices
- Remove and replace shoe and/or baseboard molding for floor removal and installation
- Install new carpet tiles and floor tiles.

**Section 3.0 –License Requirements:**

**Section 4.0 – Quantities/Inspection:**

Bidders must inspect the site and perform their own measurements in order to determine the proper quantity of materials and equipment required to complete this project. All measurements given in these specifications are informational only.

**Section 5.0 - Bid Specifications:**

The successful bidder shall supply all labor, and necessary essentials to perform the following:

- Remove and discard existing carpet and tile (excluding restrooms)

**Section 6.0 – Warranty:**

All workmanship shall have a one (1) year warranty in writing from the date of acceptance of the project against defects. The bidder must agree, upon written notice from the owner promptly and without charge, and to the satisfaction of the owner, to make changes, replacements, and corrections which may be required to make good all defects, within the warranty period, at no cost to the owner.

**Section 7.0 – Permits:**

The successful bidder shall obtain any and all permits required by the Jefferson Parish Inspection and Code Enforcement Department and/or the City of Gretna. The contractor shall also be responsible for payment of these permits. All permits must be obtained prior to the start of the project. Certificate of Final Inspection must be submitted to and approved by the Department of Traffic Engineering before final payment is rendered.

All required insurance under this bid shall conform to Jefferson Parish Resolution No. 113646 or No. 113647, as applicable. Contractors may not commence any work under any ensuing contract unless and until all required insurance and associated evidentiary requirements thereto have been met, along with any additional specifications contained in the bid. Except as where otherwise precluded by law, the Parish Attorney or his designee, with the concurrence of the Director of Risk Management or his designee, may agree on a case-by-case basis, to deviate from Jefferson Parish's standard insurance requirements, as provided in this Section. Vendors requesting deviation therefrom shall submit such requests in writing, along with compelling substantiation, to the Purchasing Department prior to the bid's due date. Any changes to the insurance requirements will be reflected in the bid specifications and addenda. Prior to contract execution and at all times thereafter during the term of such contract, contractors must provide and continuously maintain all coverages as required by the foregoing Resolutions, and the contract documents. Failure to do so shall be grounds for suspension, discontinuation or termination of the contract.

Note: This category may be omitted if bidders do not/will not utilize company vehicles for the project or do not possess company vehicles. Bidder must request an automobile insurance declaration affidavit prior to the bid opening date. **DEDUCTIBLES**

No insurance required shall include a deductible not greater than \$10,000.00. The cost of the deductible shall be borne by the contractor.

NOTE: If the vendor requires a change in deductibles, the request must be submitted in writing to the Purchasing Department prior to the due date of the bid. Such request shall be reviewed by the Parish Attorney's Office with the concurrence of the Director of Risk Management.

**UMBRELLA LIABILITY COVERAGE**

An umbrella policy or excess may be used to meet minimum requirements.

**FOR CONSTRUCTION AND RENOVATION PROJECTS:**

The following are required unless otherwise specified in the bid. Such insurance is due upon contract execution.

**1) OWNER'S PROTECTIVE LIABILITY**

To be for the same limits of liability for bodily injury and property damage liability established for commercial general liability.

**2) BUILDER'S RISK INSURANCE**

The contractor shall maintain Builder's Risk Insurance at his own expense to insure both the owner (Parish of Jefferson) and contractor as their interest may appear.
