SPECIFICATIONS

16 INCH & 24 INCH FLANGED 100% PORT PLUG VALVES

JEFFERSON PARISH DEPT. OF SEWERAGE

GENERAL

The valves specified for this application shall be Pratt/Milliken number 1600-601FN1AGHW+NT (16 inch) and Pratt/Milliken number 2400-601FND1AGHW+NT (24 inch), or approved equals. The specified valves will be utilized in wastewater installations, where the pumped media can contain fouling or abrasive solids. The specified valves are rectangular 100 percent Port Eccentric Plug valve.

Plug Valves shall be of the non-lubricated, eccentric type and shall be designed with a working pressure of 150 psi. The valves shall provide tight shut-off at rated pressure.

VALVE BODY

The plug valve body shall be cast iron ASTM A126 Class B with welded-in overlay of at least 95% nickel alloy content on all surfaces contacting the face of the plug. Sprayed, plated, nickel welded rings or seats screwed into the body will not be accepted.

VALVE PLUG

The 16 inch valve plug shall be ductile iron ASTM A-536, Grade 65-45-12. The 24 inch valve plug shall be ductile iron ASTM A126 Class B cast iron, with Buna N resilient seating surface to mate with the body seat.

VALVE FLANGES

Valve flanges shall be manufactured in accordance with ANSI B16.1 Class 125.

VALVE BEARINGS

Plug valve shall be furnished with permanently lubricated sleeve type bearings conforming to AWWA C517. Bearings shall be of sintered, oil impregnated type 316 stainless steel ASTM A-743 Grade CF-8M or bronze ASTM B-127.

VALVE SHAFT SEALS

Valve shaft seals shall be of the "U" cup type, in accordance with AWWA C-517. Seals shall be self-adjusting and re-packable without moving the bonnet from the valve.

VALVE ACTUATORS

Valves shall be provided with worm gear type manual actuators. All buried valves shall be provided with worm and gear actuators suited for the intended service. Valve actuators shall be fully grease packed and have stops in the open/close position. The actuator shall have a mechanical stop which will withstand an input torque of 450 lbs. against the stop. The actuator shall be able to provide 1.25 times the required operating torque under full rated line pressure combined with a flow velocity of 8 feet per second.
