A pre-bid conference was held on September 26, 2016 at 10:00 am. The pre-bid meeting memorandum and sign-in sheet are provided as attachments to this addendum.

General

This project is funded through a Louisiana Department of Health and Hospitals Drinking Water Revolving Loan. The project is subject to the Davis Bacon Act and the Davis Bacon Wage Decision. The most recently updated Davis Bacon Wage Decision is included in the specifications and these minimum wages will be required for the listed job classifications on this project.

In some locations it may be necessary to remove and replace existing fencing along the right of way to install the new waterline. Approval shall be obtained from the Engineer before any fence can be removed for waterline installation. The permanent fence along the right of way shall be returned to its original condition following installation of the water line in locations where fence is removed. A fencing bid item for any kind of existing fence has been added to the bid form and will be paid for on a linear foot basis.

Items have been added to the project for handicap ramps and concrete roadway, walks and curb removal and replacement. Details for these items are included as an attachment to this addendum. Only the details that apply to this project in these attachments shall be used.

Handicap ramps will be installed in locations directed by the Engineer. Approval shall be obtained from the Engineer before any handicap ramps are installed. Another critical stipulation is that all excavation work is performed and backfilled while the state of the Mississippi River is below elevation +11.0 feet on the Carrollton gage, at New Orleans, Louisiana. All excavations need to be backfilled to natural ground prior to the river stage rising to +11.0 feet on the Carrollton gage, at New Orleans, Louisiana.

On the day the Carrollton gage reaches +11.0 feet contract time will be suspended. Contract time will resume on the day the Carrollton gage recedes below +11.0.

A permit from the Louisiana Department of Transportation and Development (DOTD) has been applied for. The engineer is currently coordinating with DOTD on the issuance of this permit.

Command Construction Questions and Answers

Question 1: Please advise on the liquidated damages for the subject project.

Answer 1: The liquidated damages information is located on the second page of the Important Notice to All Bidders – Bid Requirements. Upon notice to proceed the bidder agrees that all work shall be completed within 180 calendar days. The bidder agrees to pay as liquidated damages the sum of \$500 per day each consecutive calendar day after the agreed date of completion that the work remains substantially incomplete.

Question 2: Could you please clarify when the DBA/Debarment/Lobbying forms are to be submitted?

Answer 2: These documents do not have to be submitted with the bid but will be required from the apparent low bidder following the bid opening.

Global Contractors Questions and Answers

Question 1: I found the 180 calendar days for the project but could not locate what the Liquidated Damages are. It was not listed in the "Agreement".

Answer 1: See answer to question 1 under Command Construction Questions and Answers.

Question 2: Would you entertain putting a bid item for Sand? Depths can vary from drawings during installation.

Answer 2: Depths of the waterline installation are shown in the profile of the drawings. Calculate your sand quantity accordingly based on the depths of installation shown. No separate item for sand will be added. It is considered incidental to the unit price.

Question 3: Would you entertain putting an item for fence? The waterline comes fairly close in some spots and the fence will have to be replaced.

Answer 3: Item S-010 Fence Any Kind has been added.

Question 4: What is the existing waterline made of? AC? If so laying the new line next to the AC line is problematic at best. AC pipe is very brittle and also has short pipe lengths (6' I think). If room allows can we shift away for the existing AC waterline to avoid breaking it?

Answer 4: The existing waterline is AC pipe in some locations and cast iron in other locations. The existing waterline locations shown on the plans are approximate and will have to

be verified in the field by the contractor. Any proposed adjustments to the new waterline alignment shall be approved by the Engineer before waterline installation begins.

Question 5: What is the size and type of the two waterlines on Modern Farms Rd? The chart on Sht. 34 calls out 12" connection. Sht. 25 calls out a (2) 12" x 8" Tees which would indicate an 8" line.

Answer 5: The size of the waterline at Sta. 201+52.18 is 12" in diameter. The type will have to be verified in the field by the contractor. A 12"x12"x12" tee will be required for this tie-in. The size of the waterline at Sta. 201+91.58 is 2" and will be paid as a water service connection up to 2".

Question 6: My quantity takeoff for Transition Couplings are as follows: (2) 12", (15) 8" and (1) 6". This does not match the bid item quantity. I assumed Modern Farm had (2) 8" transition couplings not 12.

Answer 6: The quantities have been changed and the changes are included as part of this addendum. The new quantities are (1) 6", (13) 8" and (3) 12".

Question 7: I came up with (45) 12" gate valves. Bid item calls for 42 ea 12" gate valves. I did not assume Modern Farm was 12" as shown on Sht. 34.

Answer 7: The quantity has been changed to (46) 12" gate valves.

Question 8: In the specifications, Instruction to bidders Par. B Price (4)...Is this a tax exempt job?

Answer 8: This project is not sales tax exempt.

Question 9: In the specifications, Instructions to bidders Par. B Price (5)...2%, 10 days...Does this mean 2% discount if paid within 10 days? Does this apply to our invoices?

Answer 9: This does not apply to the Contractor's invoices on this project.

Question 10: Could you please specify all forms that need to be included with the bid?

Answer 10: The Important Notice to All Bidders and the Changes to Jefferson Parish Bidding Procedures documents as part of this addendum specify all forms that need to be included with the bid.

Question 11: Is this a Buy American Project?

Answer 11: No

Question 12: Should the mainline tee be included with the fire hydrant assembly or will it be paid under the fitting item?

Answer 12: The main line tee shall be included with the fire hydrant assembly bid item.

Question 13: Are the ductile iron fittings to be paid by actual weight less accessories?

Answer 13: Yes, ductile iron fittings shall be paid by actual weight. Accessories are considered incidental to the fittings installation.

Boh Bros. Construction Questions and Answers

Question 1: Sheet No. 33 Water and Sewer Force Main Standard Trench Detail Final Backfill Cover lists ***, **** as acceptable backfill materials. Which one should we use? **** says River Sand within Street Right of Way which is property line to property line. So all water lines installed would be within the right of way. *** & **** contradict each other. Also, a large portion of the water line is to be installed in the bottom of the existing ditch and in the slope of the ditch wall. River Sand backfill will surely be washed away as soon as we have a large rain event. Please clarify your intention as it relates to the Final Backfill of the water lines.

Answer 1: All backfill shall be river sand since all installations will be within the street right of way. In the case of waterline installed in the bottom of existing ditches and slopes of the ditch wall river sand will be used as backfill however the top six inches of the trench shall be backfilled with select excavated material to prevent the river sand from washing away during rain events.

Question 2: Will all exiting ground cover that is disturbed to install water line be required to be restored with grass sod or seeding?

Answer 2: Existing established residential lawns will require sod. All other areas will require seed.

Question 3: Page 02230-3 says we should notify St. Bernard Parish Sewer & Water Division? Is this correct?

Answer 3: All references to St. Bernard Parish Sewer and Water Division on page 02230-3 are incorrect. This should be the Jefferson Parish Department of Water. Water General Superintendent, Tyrell Chatman needs to be alerted by the Contractor prior to the performance of any work impacting existing water utility features. Tyrell's office phone number is 838-4315.

Question 4: Page 02230-3 says a Class IV Water Distribution Operator Certificate license shall be required to oversee water line install. Will someone from Jefferson Parish water department have this license and is there any fees associated with same?

Answer 4: The Contractor will have to supply the Class IV Licensed Water Distribution Operator to operate valves or complete a tie-in on any active (live) water distribution or water supply system in the Parish. If the Contractor does not have a Class IV Water Distribution

Operator on staff he can hire a sub-contractor that does have the certification to oversee the installations and provide this required license.

Question 5: Some chain link fences and ornamental fences will be in conflict/close proximity to our water line installation. How will the contractor be compensated to remove/replace any removed/damaged fencing?

Answer 5: An item has been added for fencing.

We have received a letter request, dated May 11, 2016, from Digital Engineering, Inc., on behalf of Jefferson Parish Department of Water, concerning permission to replace 13,100 linear feet of a water line from Willswood Lane to Rivet Boulevard landward of the right descending Mississippi River levee, between second order levee stations 120+00 and 257+00, at Westwego, Louisiana, in Jefferson Parish.



In addition to liquidated damages, in accordance with Section 6.02, "Labor; Working Hours," whenever Contractor's work requires inspections in excess of the budgeted amount for inspection, Contractor shall reimburse Owner for the additional costs incurred by the Owner with respect to inspection of the contracted project provided the additional costs for inspections are above the budgeted amount for the contracted project.

For this project, the Project Representative Services, in accordance with the terms of the Engineer's agreement with the Owner, provides that the average hourly rate to be charged for resident inspection for this construction project is \$ 65.00 and the reasonable budget for such inspections is \$ 90,000.00 (the overtime rates shall be \$ 78.00 per hour). The cost of inspection in excess of this budgeted amount shall be assessed against Contractor's progress payments, all in accordance with LSA R.S. 38:2216(L)(2).

It shall be the duty of every parish officer, employee, department, agency, special district, board, and commission; and the duty of every contractor, subcontractor, and licensee of the parish, and the duty of every applicant for certification of eligibility for a parish contract or program, to cooperate with the inspector general in any investigation, audit, inspection, performance review, or hearing pursuant to this chapter. Every parish contract and every bid, proposal, application or solicitation for a parish contract, and every application for certification of eligibility for a parish contract or program shall contain a statement that the corporation, partnership, or person understands and will abide by all provisions of this chapter.

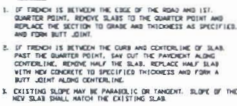

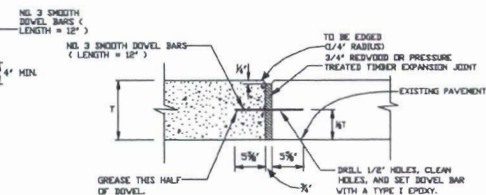
ELEVATION VIEW OF SIDEWALK

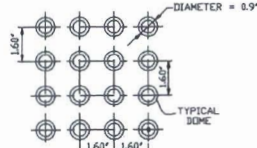
PLAN OF TYPICAL SIDEWALK

Global Contractors Questions and Answers

Question 1: Asphalt removal and replacement is somewhat confusing. A new Asphalt Restoration drawing was issued with addendum no. 1 and should take precedence. It calls for 6" (previously 12" polymer). It also calls out to use a 6" binder course for temporary 6" binder to be removed prior to permanent asphalt replacement. Can you add an item for saw cut? Can you add an item for the temporary binder course? Will the Traffic Maintenance Aggregate Item still be used and paid for prior to the temporary asphalt? Can you delete Specification Section 02070 Asphalt Concrete Pavement Patching and replace with a new Measurement and Payment to reflect the new asphalt restoration drawing? Section 02070 calls for 12" thick Polymer Asphalt and the new drawing calls for 4" Binder and 2" Type III wearing course.

Answer 1: A new asphalt patching detail is included in this addendum and the bid items, measurement and payment and asphalt concrete pavement patching technical specification has been revised to clarify asphalt removal and replacement.

Question 2: Drawing Sheet 35 Typical Section Trench near edge of Roadway: Does this detail still apply? Does the 12" thick Asphalt still apply? Does the mill and overlay still apply? How will all this be paid? This detail refers to Drawing Sht 36 which is "Drainage Pipe Details" (Trench Width OD + 4'). Does this detail only apply to drainage pipe installations? I am assuming we are to go by the Waterline Trench Detail on Drawing Sht 33 (Trench Width OD +2').

Answer 2: See answer to question number 1. Trench near edge of roadway detail has been removed.

Subterranean Construction, LLC

Question 1: Can you please re-visit your answer to Boh Brothers question 1 regarding sand backfill. I understand that the Jefferson Parish standard detail says to backfill with sand in streets right of way but if that was the case then every water and sewer line in the parish would get backfilled with sand because they are all in the street right of way. When we are doing subdivisions we only backfill the drain with sand because it is close to the back of curb, all sewer and water lines are backfilled with existing material. Also, by backfilling entirely with sand most of the mud will have to be loaded on trucks and hauled off which to me will change the scope of the project and require ongoing lane closures. I can't recall if your firm engineered the last phase of this project but I can tell you on that project the contractor backfilled with the existing material.

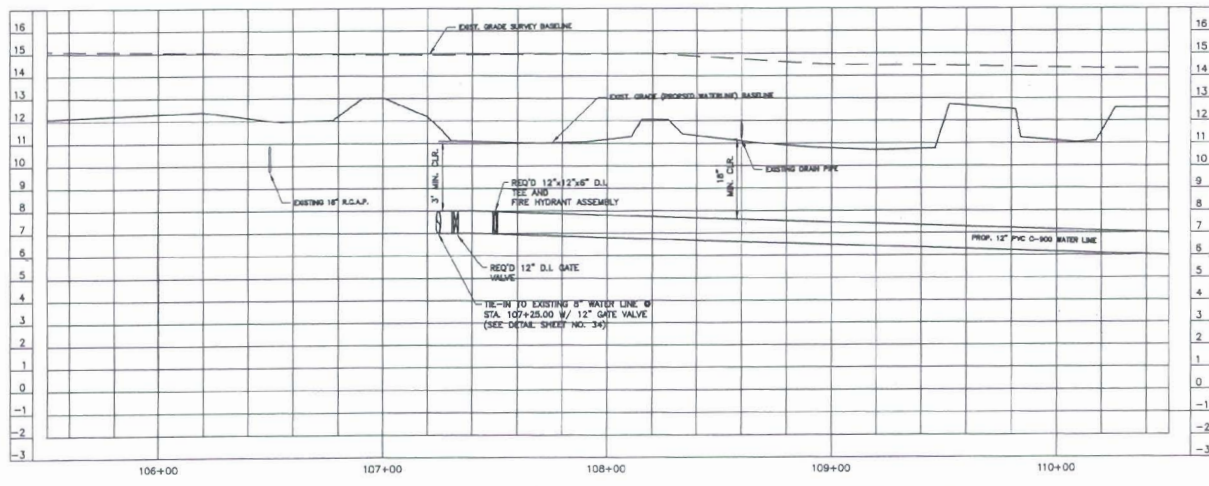
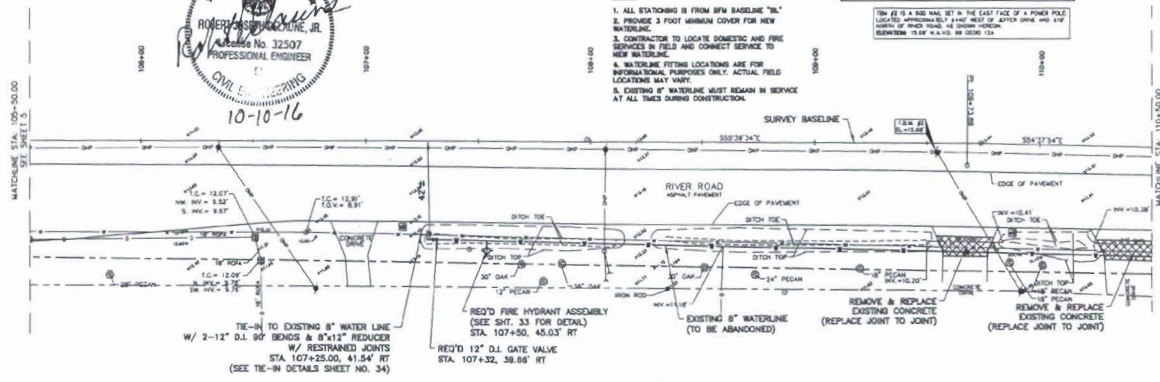

TRENCH UNDERNEATH DITCH

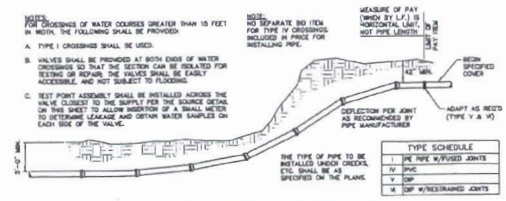


CONCRETE BOLLARD DETAIL

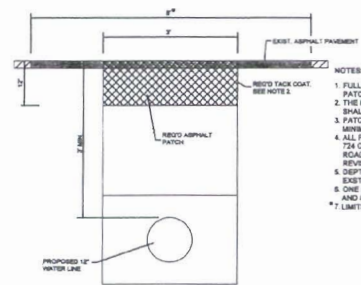

Any changes to the limits or scope of the proposed work must be submitted for additional review. The Levee District must be contacted in writing prior to commencement and at the end of activities. The applicant is responsible for obtaining and providing copies of any permits or lease agreements necessary from the U.S. Army Corps of Engineers, the U.S. Coast Guard, the Louisiana State Land Office, the Louisiana Department of Transportation and Development, the Louisiana Department of Natural Resources - Office of Coastal Management, the Louisiana Department of Wildlife and Fisheries, the Parish Government and/or any other applicable agencies, as well as documented approval from the area landowner(s) prior to the initiation of the work. The applicant is responsible for adhering to the provisions of any existing permits. 4. That the cutting of trees be kept to the minimum deemed necessary to accomplish the proposed project.
5. That no equipment, vehicles, or materials of any kind are parked or stored on the levee or on its slopes without prior approval from the levee district.
6. That all directional drilling activities must be coordinated and performed with the approval and monitoring of the U.S. Army Corps of Engineers.
7. That if an existing pipeline is being replaced, and will not serve any future use, it must be immediately removed or properly abandoned. Any voids resulting from abandonment of the pipeline section in the area located within 40 feet of the floodside levee toe, and 15 feet of the protected side levee toe, must be completely sealed with cement-bentonite slurry in accordance with the slurry description specified in the State of Louisiana's "Water Well Rules, Regulations and Standards" (November 1985) in Chapter 2, Section 2.6.1.0, Item A.

1.01 DESCRIPTION

This section of the specifications includes the furnishing of all labor, materials, equipment, and the performance of all asphalt work required for the construction of the roadway in accordance with plan details and Sections 501, 503, 504, 505, 1002 and 1003 of the Louisiana Standard Specifications for Roads and Bridges, 2006 Edition and its latest revisions.

1.02 MATERIALS
