

Padding shall be provided to protect the bottom and 15" up each side of the backboard to meet or exceed all NCAA, NFHS, and professional requirements.

The padding shall provide a full 2" thickness from the bottom and sides of the backboard frame. The front and back surfaces of the backboard frame shall be further protected by a 1" thick lip extending 3/4" up from bottom and sides of backboard.


New molding process shall produce a super tough "skin" on the outside of the foam padding for long life. Pre-molded square corners provided for improved player safety. Molded-in steel track and bolt-on attachment system shall eliminate regluing or taping.

Padding shall fit all official rectangular glass backboards.

Available in NCAA-approved

Grey color. Also available in Dark/Royal Blue, Red/Scarlet, Navy Blue, Marine/Columbia Blue, Kelly Green, Yellow, Forest Green, Orange, Purple, Black, and Maroon.

Padding shall feature a 8-year warranty when installed indoors.
