Changes to Jefferson Parish Bidding Information

The Jefferson Parish Purchasing Department would like to make vendors aware of the following changes:

Total Bid Price Must Include the Cost of Naming Jefferson Parish as Additional Insured:

Bidder acknowledges that Bidder recovered the cost of any required insurance in the contract price as required by La.R.S. 9:2780.1 and that Bidder recovered any such cost for the purposes of insuring an obligation to indemnify Jefferson Parish, defend Jefferson Parish, or hold Jefferson Parish harmless and that Bidder's indemnity liability is limited to the amount of the proceeds that are payable under the insurance policy or policies that Bidder has obtained.

Electronic Procurement: Beginning November 1, 2020, Jefferson Parish will no longer accept manual bid submissions; and will only accept bid submissions electronically via our e-Procurement system, Central Bidding. Central Bidding can be accessed by visiting either www.centralbidding.com or www.jeffparishbids.net. All bidders will be required to register with Central Bidding. Probable Construction Cost: Per Jefferson Parish Administrative Policy, the probable construction cost is not revealed in the Jefferson Parish Bidding Documents. Jefferson Parish Administrative Policy has changed and a range of the probable construction cost will be stated in the Jefferson Parish bidding document, entitled Important Notice to All Bidders – Bid Requirements. Per Louisiana Public Bid Law, the probable construction cost will be read at the bid opening.

Insurance Requirement: All bidders must provide proof of valid insurance in the required amounts as stated in the Standard Insurance Requirements for bidding purposes. Failure to provide the proof of valid insurance in all of the required coverage amounts will result in bid rejection.

Two (2) year contract for the supply of base course crushed concrete for the Jefferson Parish Department of Public Works - Streets and all Jefferson Parish agencies and municipalities.

LIMESTONE (GRAY & SACTUN/MEXICAN)

SPECIFICATIONS:

Aggregates shall comply with section '1003 Aggregates' of Louisiana Standard Specifications for Roads and Bridges 2006 edition and any further revisions.

Base Course Aggregate:

The material shall conform to the following gradation:

Specifications shall follow section 301-base course of Louisiana Standard Specifications for Roads and Bridges and referenced sections, under "stone" in addition, the material shall be calcitic or dolomitic with calcium carbonate not less than 85 percent and the silica content (impurities) not to exceed 5 percent.

Recycled Portland cement concrete shall be used from approved stockpiles. Stockpiles of crushed concrete shall be uniform and free of soils, reinforcing steel, debris, excessive amount of asphaltic materials and other foreign matter. Material sampling shall be in accordance with the requirements for stone by the Louisiana Department of Transportation and Development,

Section 301 of The Materials Sampling Manual Crushed Concrete shall conform to the abrasion and soundness requirements of Subsection 1003.01 of the Standard Specifications for Roads and Bridges. Recycled Portland cement concrete will be paid for by the cubic yard in approved hauling vehicles. Self-hauled will be paid by the ton of material loaded into owner's vehicle at vendor's plant. Any prospective bidder who fails to attend the conference or remain for the duration shall be prohibited from submitting a bid for the project.
2. Attendance to this pre-bid conference is optional. However, failure to attend the pre-bid conference shall not relieve the bidder of responsibility for information discussed at the conference. 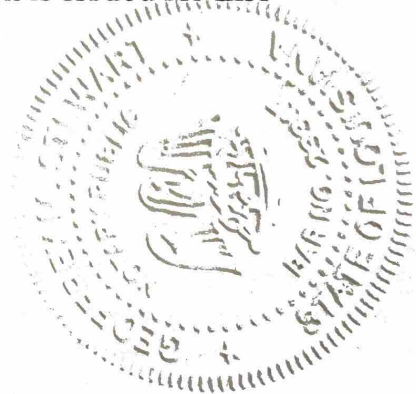

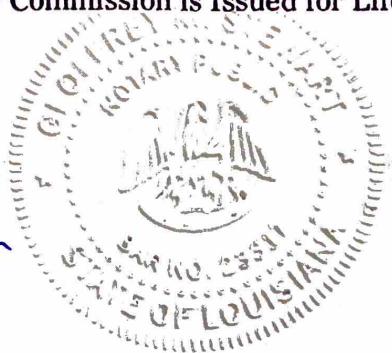
