### **Changes to Jefferson Parish Bidding Information**

The Jefferson Parish Purchasing Department would like to make vendors aware of the following changes:

**Total Bid Price Must Include the Cost of Naming Jefferson Parish as Additional Insured:**

Bidder acknowledges that Bidder recovered the cost of any required insurance in the contract price as required by La.R.S. 9:2780.1 and that Bidder recovered any such cost for the purposes of insuring an obligation to indemnify Jefferson Parish, defend Jefferson Parish, or hold Jefferson Parish harmless and that Bidder's indemnity liability is limited to the amount of the proceeds that are payable under the insurance policy or policies that Bidder has obtained.



**Electronic Procurement:** Beginning November 1, 2020, Jefferson Parish will no longer accept manual bid submissions; and will only accept bid submissions electronically via our e-Procurement system, Central Bidding. Central Bidding can be accessed by visiting either [www.centralbidding.com](http://www.centralbidding.com) or [www.jeffparishbids.net](http://www.jeffparishbids.net). In accordance with LSA R.S. 38:2212(l), all prospective bidders shall be present at the beginning of the MANDATORY pre-bid conference and shall remain in attendance for the duration of the conference. Any prospective bidder who fails to attend the conference or remain for the duration shall be prohibited from submitting a bid for the project.
2. Attendance to this pre-bid conference is optional. However, failure to attend the pre-bid conference shall not relieve the bidder of responsibility for information discussed at the conference. 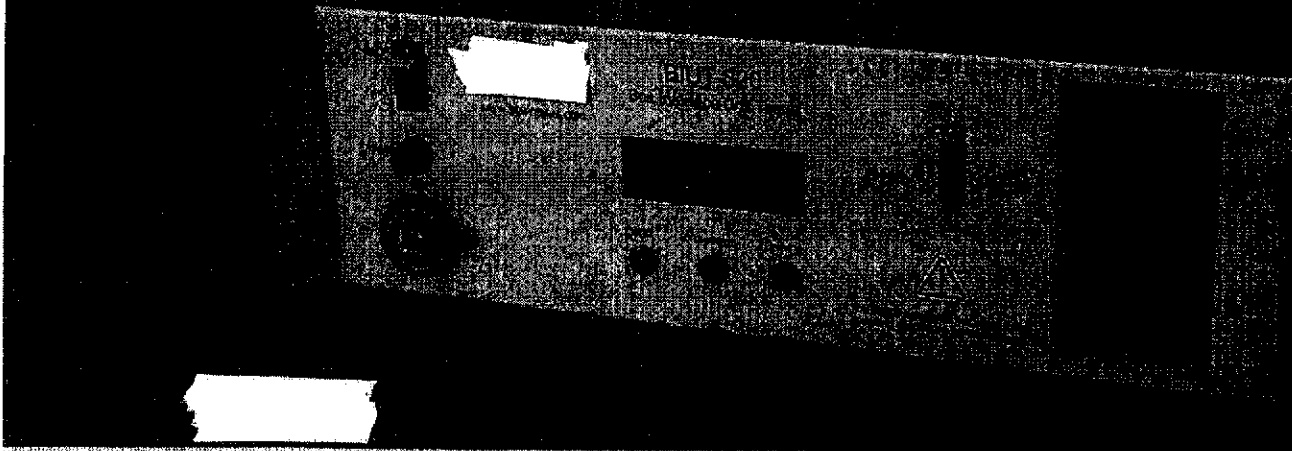

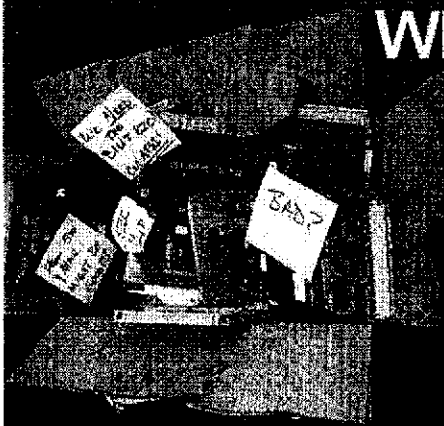

**1. BIU Tester General**

The NEMA TS2 BIU tester is designed to run a complete set of standards-based tests on a NEMA TS2 Bus Interface Unit (BIU). This set of tests will confirm the performance of the BIU to the timing and functions defined by the NEMA TS2-2003 standard. The tester shall include all hardware, firmware, cabling, and accessories required to test a NEMA TS2 Bus Interface Unit and save a test report to the tester's memory. The tester shall be capable of downloading saved test reports to a compatible computer provided by the operator. The Tester shall include an Operating Manual describing all steps in the setup of the Tester as well as unlimited telephone technical support for the purchasing agency or firm.

**2. BIU Tester Description**

**BIU Connections**
