Terms and Conditions**

1. **Execution of Bid:** Bid must contain an original signature of an individual authorized to bind the bidder. Bid must be typed or written in ink. All corrections made by the bidder to the bid must be initialed by the person signing the bid. All illegible entries, pencil bids or corrections not initialed will not be tabulated. The original bid conditions and specifications cannot be changed or altered in any way. Altered bids will not be considered. The Orleans Parish Criminal Sheriff's Office reserves the right to be the sole judge of what is acceptable.
2. **No Bid:** If not submitting a bid, respond by returning this Bidder Acknowledgment form, marking it "NO BID", no later than the stated bid opening date and hour, and explain the reason in the space provided. Failure to respond without sufficient justification may be cause for removal of the bidder's name from the bid mailing list.
3. **Bid Opening:** Shall be in public, on date, location and time specified on the bid form. It is the bidder's responsibility to assure all numbered pages of the bid, all attachments thereto and all addenda released are received prior to submitting a bid. All bids are subject to the conditions specified herein on the attached bid documents and on any addenda issued thereto.
4. **Addenda to Bid:** The Orleans Parish Sheriff's Office (herein called OPSO) reserves the right to amend this bid up to seventy-two (72) hours prior to the bid opening date indicated. Only written addenda will be binding. The OPSO is not bound by an oral representations, clarifications, or changes made in the written specifications by OPSO employees, unless such clarifications or changes are provided to bidders in written addendum form.
5. **Prices Quoted:** Deduct trade discounts and quote firm net prices. Give both unit and extended total if requested. Prices must be stated in units to quantity specified in the bidding specifications. In case of a discrepancy in computing the amount of the bid, the unit price quoted will govern and the total will be adjusted accordingly. All prices quoted shall be F.O.B. destination, freight prepaid. (Bidder pays and bears freight charges. Bidder owns goods in transit and files any claims), unless otherwise stated in Special Conditions. Cash discounts for prompt payment will not be considered in determining the lowest net cost for bid evaluation purposes.
6. **Withdrawal of Bids:** Bidders may request withdrawal of bid submittal prior to the scheduled bid opening time provided the request for withdrawal is submitted to the Director of Purchasing in writing. No bids may be withdrawn for a period of ninety (30) days after the date of opening.
7. **Mistakes:** Bidders are expected to examine the specifications, delivery schedules, bid prices and extensions, and all instructions pertaining to supplies and services. Failure to do so will be at a bidder's risk.
8. **Taxes:** The OPSO is exempt from Federal Excise and State Sales Taxes on direct purchases of tangible personal property. This exemption does not apply to purchases of tangible personal property made by contractors who use the tangible personal property in the performance of contracts for the OPSO. Contractors doing business with the Sheriff's Office shall not be exempted from paying sales tax to their suppliers for materials to fulfill contractual obligations with the Sheriff's Office nor shall any contractor be authorized to use the Sheriff's Office tax exemption number in securing such materials.

9. **Delivery:** Unless actual date of delivery is specified (or if specified delivery can not be met) show number of days required to make delivery after receipt of purchase order in space provided. Delivery time may become a basis for making an award. Delivery shall be within the normal working hours of the user, Monday through Friday, excluding holidays, unless otherwise specified and incorporated into contract document. Delivery shall be to the location specified in the bid specifications.
10. **Conditions and Packaging:** Unless otherwise stated in the special instructions to bidders or the bid sheets, or specifically ordered from an accepted price list, deliveries must contain only NEW, UNUSED, AND NOT DISTRESSED merchandise. The merchandise will be the current standard production model available at the time of the bid. The goods must be suitably packaged for shipment by common carrier. Each container or multiple units or items otherwise packaged shall bear a label, imprint, stencil or other legible markings stating name of manufacturer or supplier, purchase order number, and any other markings required by specifications, or other acceptable means of identifying vendor and purchase order number.
11. **Inspection, Acceptance & Title:** Inspection and acceptance will be at destination unless otherwise provided. Title to or risk of loss or damage to all items shall be the responsibility of the successful bidder until acceptance by the buyer, unless loss or damage results from negligence by the buyer. If the materials or services supplied are found to be defective or not conforming to specifications, the Sheriff's Office reserves the right to cancel the order upon written notice to the seller and return product at bidder's expense.
12. **Safety Standards:** All manufactured items and fabricated assemblies shall comply with applicable requirements of Occupational Safety and Health Act and any standards thereunder.
13. **Open-End Contract:** No guarantee is expressed or implied as to the total quantity of commodities/services to be purchased under any open end contract. Estimated quantities will be used for bid comparison purposes only. The OPSO reserves the right to: issue purchase orders as and when required, or issue a blanket purchase order for individual agencies and release partial quantities. No delivery shall become due or be acceptable without a written order unless otherwise provided in the contract. Such order will contain quantity, time of delivery and other pertinent data. However, on items urgently required, the seller may be given telephone notice, to be confirmed by an order in writing.
14. **Contact Period (Open-End Contract):** The initial contract period shall start with the expiration date of the previous contract or date of award, whichever is latest and shall terminate 120 (one hundred and twenty) days from that date, unless otherwise stated within the specifications. The contractor will complete delivery, and the OPSO will receive delivery on any orders mailed to the contractor prior to the date of expiration. The Director of Purchasing may renew this contract subject to vendor acceptance, satisfactory performance, and determination that renewal will be in the best interest of the OPSO. Notification of Intent to Renew will be mailed thirty (30) calendar days in advance of expiration date of this contract. All prices, terms and conditions shall remain firm for the initial period of the contract and form any renewal period unless subject to prices adjustment specified as a "special condition" hereto. In the event services are scheduled to end because of the expiration of this contract, the Contractor shall continue the service upon the request of the Director of Purchasing. The Contractor shall be compensated for the services at the rate in effect when this extension clause is invoked by the OPSO.
15. **Contracts for Services:** The timeline for capital improvements, maintenance and service contracts will be enumerated in the bid packet. The commencement and length of these contracts will be stated in the scope of the bid, along with any extension clauses concerning these services

16. **Payment:**
- A. **Payment from OPSO to Contractor:** Payment will be made by the OPSO after commodities/services have been received, accepted and properly invoiced as indicated in contract and/or order. **Invoices must bear the purchase order number.**
 - B. **Payment from Contractor to Subcontractor and Materials Supplier:** When a contractor received from OPSO any payment for contractual services, commodities, materials, supplies, or construction contracts the contractor shall pay such moneys received to each Subcontractor and Material Supplier. Payment is the sole responsibility of the Contractor, and the OPSO will not intervene in any payment disagreements.
17. **Manufacturer's Name and Approved Equivalents:** Manufacturer's names, trade names, brand names, information and/or catalog number listed in a specification are for information and establishment of quality level desired and are not intended to limit competition. The bidder may offer any brand which meets or exceeds the specifications for any item(s). If bids are based on equivalent products, indicate on the bid form the manufacturer's name and catalogue number. Bidder shall submit with his bid complete descriptive literature and/or specifications. The bidder should also explain in detail the reason(s) why and submit proof that the proposed equivalent will meet the specifications and not be considered an exception thereto. **The OPSO reserves the right to be the sole judge of what is equal and acceptable.** Bids which do not comply with these requirements are subject to rejection. If the bidder fails to name a substitute it will be assumed that he is bidding on goods as listed in the specifications, and he will be required to furnish such goods.
18. **Variations to Specifications:** Bidder must indicate any variance to our specifications, terms, and/or conditions, not matter how slight. If variations are not slated in the Bid, it will be assumed that the product or service fully complies with our specifications, terms, and/or conditions. The OPSO will not interpret variances based on any attached sales or manufacturer's literature unless otherwise specified herein by the OPSO.
19. **Interpretations:** Any questions concerning conditions and specifications shall be directed in **writing** to the Director of Purchasing. No interpretation(s) shall be considered binding unless provided to all Bidders in writing by the Director of Purchasing.
20. **Awards:** If a specific basis of award is not established in the Invitation for Bid, the award shall be to the responsible bidder with the lowest responsive bid meeting the written specifications. As the best interest of the OPSO may require, the right is reserved to make award(s) by individual commodities/services, group of commodities/services, all or none or any combination thereof. When a group is specified, all items of the group must be bid. A bidder desiring to bid "No Charge" on an item in a group must so indicate, otherwise the bid for the group will be construed as incomplete and may be rejected. However, if bidders do not bid all items within a group, the OPSO reserves the right to award on an item by item basis. When a group bid is indicated for variable quantities and the bid for the group shows evidence of unbalanced bid prices, such bid may be rejected. The Director of Purchasing reserves the right to waive technicalities and irregularities and to reject any or all bids, or any part of any bid.
21. **Warranty:** The bidder should specify any warranty applicable to the items bid, and attach any warranty form.

22. **Samples:** Samples of item, when required, must be furnished free of charge to the OPSO. Each individual sample must be labeled with bidder's name, manufacturer's brand name and be delivered **seventy-two (72) hours or three (3) days** prior to the bid opening unless the schedule indicates a different time or unless submission is required before the bid opening. If samples are required subsequent to the bid opening, they should be delivered within three (3) calendar days of the request. The OPSO will not be responsible for returning samples.
23. **Patents and Royalties:** The bidder, without exception, shall indemnify and hold harmless the OPSO and its employees from liability of any nature or kind, including cost and expenses for or on account of any copyrighted, patented or unpatented invention, process, or article manufactured or used in the performance of the contract, including its use by the OPSO.
24. **Assignment:** Contractor shall not transfer or assign the performance required by this bid without the prior written consent of the Director of Purchasing. Any award issued pursuant to this bid invitation and the monies which may become due hereunder are not assignable except with the prior written approval of the Director of Purchasing.
25. **Indemnification:** The contractor shall indemnify, hold harmless, and defend the OPSO, its officers, agents and employees from and against all claims, damages liability, judgements or causes of action including costs, expenses, and attorneys fees incurred as a result of any error, omission or negligent act by the Contractor its officers, employees, agents, subcontractors or assignees arising out of this bid.
26. **Equal Employment Opportunity:** No contractor shall discriminate against any employee or applicant for employment because of race, religion, color, sex or national origin, or physical or mental handicap if qualified. Contractor shall take affirmative action to ensure that applicants are employees are treated during their employment without regard to their race, religion, color, sex or National origin, or physical or mental handicap. Such actions shall include but not be limited to the following: employment, upgrading, demotion, or transfer, recruitment or recruitment advertising, layoff or termination, rates of pay or other forms of compensation; and selection for training, including apprenticeship. The contractor agrees to post in conspicuous places available to employees and applicants for employment, notices setting forth the provisions of this non-discrimination clause. The Contractor further agrees that he/she will ensure that subcontractors, if any, will be made aware of and will comply with this nondiscrimination clause.
27. **Minority Business Enterprise and Local Small Business Enterprise Participation:** The OPSO is strongly committed to ensuring the maximum participation of qualified local minority business enterprises (MBEs/SBEs) as defined in the OPSO program as contractors and subcontractors for the procurement of goods and services.

Notification is hereby given that qualified local minority business and qualified local small business enterprises are encouraged to participate by submitting a bid/proposal package for this project. Bidders/Proposers are hereby notified that qualified local minority business enterprises and qualified local small business enterprises shall have the maximum opportunity to compete for and perform such contracts and subcontracts and provide material supplies for such contracts and subcontracts. List all subcontractors and material suppliers, including qualified local minority business enterprise and qualified local small business enterprise subcontractor and material suppliers that will participate in the project.

Enforcement of Program: Any individual or entity that engages in fraud, misrepresentation, or wrongful conduct, whether by act or omission, related to its participation in, or eligibility to participate in the OPSO's qualified local MBE/SBE obligations under a contract, shall be in violation of the program. This determination shall be solely at the discretion of the OPSO. Violators may be subject to, on an individual and/or entity basis, debarment or suspension from participating in the OPSO's contracts in accordance with OPSO policy and procedures.

28. **Local Preference:** The OPSO pursuant to its Purchasing Authority may grant a preference to vendors whose business location is in Louisiana and minority or disadvantaged vendors. The Vendor shall have the burden of demonstrating that it maintains an office or other site where it operates, conducts, engages in or carries on all or a portion of its business within Louisiana.
29. **ADA Compliance:** "Persons with disabilities who require reasonable accommodation to participate in OPSO programs and/or services may call The Human Resources Department at 504-827-8505.
30. **Public Entity Crimes:** "A person or affiliate who has been placed on the convicted vendor list following a conviction for a public entity crime may not submit a bid on a contract with a public entity for the construction or repair of a public building or public work, may not submit bids on leases of real property to a public entity, may not be awarded or perform work as a contractor, supplier, subcontractor, or consultant under a contract with any public entity, and may not transact business with any public entity" for a period of thirty-six (36) months.
31. **Protest:** Notice of intent to award a contract will be available for review by interested parties in the Purchasing Department no later than ten (10) days after the bid opening. Any actual or prospective bidder who is aggrieved in connection with the pending award must file a protest within (5) business days after the intent to award is available for review, or any right to protest is forfeited.
32. **Disclosure Statement:** Vendor shall disclose below, to the best of his/her knowledge, any OPSO officer, employee, or any relative of any such officer or employee, who has a material interest in the vendor's business or its parent company, any subsidiary, or affiliated company, whether such official is in a position to influence this procurement or not. Failure of a vendor to disclose any relationship described herein shall be reason for debarment.

Section 1: Bids

The date, time and place of all bid openings will be shown on all invitations to bid. All bids will be opened at 10:00:00 hours C.S.T. on the specified date.

All bids will be submitted sealed to the OPSO by 1000 hours C.S.T. on the date specified for bid opening. Bids or amendments thereto received after the specified date and time for opening bids, or bids received unsealed, will not be evaluated. A notation will be made as to time received. The unopened bids will be returned to the bidder unopened.

Bids will be submitted **signed** and only on the bid proposal forms provided. All bid documents received by the vendor must be returned to OPSO. All information required on the bid form must be supplied in order to constitute a complete bid.

The bidder is solely responsible for the timely submission of bids. Bid documents may either be sent by certified mail, return receipt requested, by express delivery such as Federal Express, etc., or hand delivered to the purchasing department at 3000 Perdido Street., 1st floor between the hours of 7:30-4:00, Monday through Friday. A receipt for all bids submitted will be supplied. Bids may be submitted through the electronic procurement system utilized by the OPSO, but shall include and conform to all bidding requests of signatures, letters, forms, and all proper documentation mandatory for this bid submission. A bidding checklist is included with all bids to help provide information concerning these documents. Bids forwarded in any other fashion will be returned unopened.

The prices quoted will include handling and delivery to any specified detention or administrative site under the control of OPSO.

Errors in quoted prices or in preparation of the bids will not relieve the vendor of the responsibility to fulfill the obligations set forth in this bid except as provided under Louisiana Revised Statutes.

Vendors who fail to respond after having been invited to bid on three consecutive occasions will be dropped from the bidders' list. A vendor will be reinstated upon receipt of a written request.

All contracts will be for a minimum period of 120 days. The perishable portion of the bid will be for a minimum of 168 days with an option to renew by mutual consent for a total of three (3) additional cycles for a total perishable contract term of two (2) years. If renewing these perishable items, the OPSO shall contact the vendor (30) days before the end of the cycle. The renewing of the perishable items will be at the price agreed to at the beginning of the award with no cost adjustments.

Bid results will be forwarded to all participating vendors within 10 working days of bid opening. The provision of winning items will be within ten (10) days of the receipt of the initial award. Submission of a blank bid will not entitle a vendor to receive a copy of bid results; however, bid results may be viewed during normal business hours in the Purchasing Agent's office by appointment only.

In keeping with Federal Guidelines for reimbursement, if less than three (3) prices are received for an item, the OPSO shall contact various vendors to receive a total of three (3) prices to accurately judge the price as cost reasonable.

Section 2: Commodity Descriptions

All products offered will have been processed and packed in accordance with good commercial practice and will be in excellent condition at time of delivery. The determination of acceptable delivery condition of items presented is the sole responsibility of the OPSO, and its decisions are final. All items offered will conform, in all respect, to all applicable standards promulgated under the Federal Food, Drug and Cosmetic Act in effect at the time of delivery.

The acceptableness of product received is the responsibility of the seller to conform to all commodity requirements. The food delivered shall be exactly the product noted on the vendor's bid submission. **DISTRESSED, OR PREVIOUSLY SOLD (RE-SALE) MERCHANDISE IS NOT ACCEPTABLE.** All products should include packaging that is sealed on the inside and outside to prevent any and all foreign contamination.

Labeling requirements on every package should include notations of the following:

- product name
- standard of identity, brand or grade of product
- manufacturer or distributor of said product
- address including city and state of manufacturer/distributor
- net weight of container
- ingredient statement.

All products when quoted on this bid and all addendums must state country of origin under the price quoted. **If not noted, it will be assumed that the product is an imported product.** Please note Section 5 that concerns the OPSO Buy American Policy. To the maximum extent practical, OPSO buys American made products.

Perishable items will follow labeling requirements as stated in the perishables terms and conditions section. All packages must conform to all of these specifications unless mutually agreed by the Food Service Director and vendor.

In an effort to maintain transparency in bidding canned goods, a letter from the manufacturer stating the grade of the bid product **MUST BE INCLUDED WITH the bid documents.** If not included with the bid documents submitted, the next responsible vendor who fulfills all of the qualifications will receive the award. It is the desire of the OPSO for all products received to fulfill the minimum grading specifications quoted in this document. If at any time a product is sent to the OPSO that does not conform to the minimum specifications, that vendor will have the **ENTIRE** contract terminated for default. This vendor will then have to wait one calendar year for the approval of the Director of Purchasing to join an Invitation to Bid.

Samples will be required if a vendor wishes to submit a bid for an "equivalent" product. The sample must be supplied by the vendor to the OPSO. Deliver to the OPSO warehouse at 3000 Perdido Street between the hours of 0700 and 1500, Monday through Friday. Samples will be supplied no later than **three working days** prior to the date specified for the bid opening so that the award of bids will not be delayed by the evaluation process. These samples should be marked "Sample" with vendor information, product specifications, and nutritional analysis. The samples will be marked with time and date of delivery and sent to the Food Service Director for testing.

Vendors should notify OPSO as soon as possible if they wish to supply an equivalent product in lieu of any specified by OPSO. OPSO is the sole judge of equivalence and its decisions are final. Samples will be representative of the product to be supplied should the bid be awarded. Reimbursement will be made for all samples requested.

Bids will not include state and local sales taxes. Bids will be priced by the unit quantity specified for each item, i.e., case lot, per pound, etc. Any bid not conforming to these specifications will not be considered. Alternates will not be considered without the written consent of OPSO.

Successful bidders will be authorized to conduct business in the State of Louisiana by the Office of the Secretary of State of Louisiana. Proof of such documentation will be provided to OPSO by the vendor upon request.

Section 3: Contract Conditions

Contracts may be terminated at any time by mutual written consent. Contracts may be terminated at any time by OPSO if any contract terms are violated in any manner. Formal notification will be made to the vendor concerned. Contracts may be terminated for convenience with a (30) thirty day notice to the vendor.

Failure to provide commodities in accordance with any terms will result in termination of contract and withholding of any payments owed until the issue is completed to the satisfaction of the OPSO Purchasing Director.

If a product is ordered and not supplied within the proper time frame (**2 weeks ARO**), the OPSO has the right to cancel the contract and go to the next vendor who can supply the item within the proper time frame. The first vendor will be responsible to pay the difference between the cost of his/her price for the item, and that of the most timely supplier for the remainder of that delivery period. These penalties involved will be deducted from any amounts owed to the vendor by OPSO before payment is made to the vendor. The vendor will be banned from bidding in any OPSO bid for the minimum period of one year. The vendor will not be allowed to reenter the bid process after the one year period until he demonstrates to the satisfaction of the Purchasing Agent that he is able to fulfill any future obligations.

In the case of any commodity dispute, the ruling of the OPSO Food Service Director is final.

Section 4: Deliveries

All products will be ordered on a weekly basis and will be delivered and accepted within two weeks of that order. Any unauthorized shipments will be refused. Deliveries will be made between the hours of 0700 to 1500, Monday through Friday. The OPSO warehouse is closed for lunch daily between 1130 and 1200 hours. These deliveries will be first-come and first-serve. All deliveries will be subject to reweighing. Payments for affected shipments will be made on the basis of net weight of products delivered.

The OPSO is not responsible for unloading of deliveries. The OPSO becomes responsible for these products upon the placement on the OPSO dock area. OPSO personnel are not allowed onto or into any delivery vehicle for security reasons. The OPSO is a secure facility and no deliveries shall take place without the approval or acknowledgment of the Warehouse Director.

Deliveries for all perishable items will be at the direction of the Food Service Director or his designee. The vendor shall follow the OPSO post orders concerning food rotation, delivery, and ticket deliveries.

Both vendor and OPSO personnel will sign dray receipts to verify the amount of product delivered. Dray receipts will note date and time of delivery. Any written comments concerning shortages, errors, or damages will be made at the time of delivery. After receipt of goods, any problems with product quality will be noted, forwarded, and filed with the Purchasing Department. This form will be forwarded to the vendor involved.

All meats must be federally and state certified according to Institutional Meat Purchase Specifications. **A original copy of this certification must accompany every shipment.** If your company has questions concerning grading and the certification of meat products, it should contact the Louisiana Department of Agriculture and Forestry, Grading and Certification, Baton Rouge, LA, (504) 922-1358. Fees for grading and certification will be the responsibility of the vendor.

When delivered products appear to be inferior to products specified, OPSO reserves the right to submit the items in doubt to the nearest local or regional U.S.D.A. office for official inspection and grading. The expense of the inspection will be deducted from any amount owed to the vendor by OPSO before any payment is made.

In cooperation with the United States Department of Agriculture, in conjunction with the Department of Health and Human Services, the U.S.D.A. School Meals Initiative for Healthy Children requires a nutrient analysis of all food products purchased by OPSO.

Submission of any bid indicates acceptance of all terms and specifications contained in this bid package by the vendor.

Section 5: Buy American Policy

In accordance to the Child Nutrition Reauthorization Act of 1998 (PL 105-336), the purchase of United States produced foods is supported. The long standing "Buy American" requirement of the Federal Child Nutrition Program will be adhered to by the OPSO. Orleans Parish Sheriff's Office General Contractual Conditions

Purpose: The policies and procedures presented herein are intended to provide for uniformity, economy, and timeliness in the acquisition of goods and services for the Orleans Parish Sheriff's Office in a manner consistent with generally accepted purchasing practices and legally mandated federal, state, and local statutes, ordinances, and codes.

The Purchasing Department shall be responsible for coordinating and controlling policies and procedures within its delegated authority.

Policy: It is the policy of the Orleans Parish Sheriff's Office to provide at the time and place needed in the proper quantity and of the proper quality, all goods and services required for the organization's operations. Goods and services shall be procured at the lowest possible cost consistent with prevailing economic conditions while establishing and maintaining a reputation for fairness and integrity. The procurement of goods and services shall be achieved within the mandates of federal, state, and local statutes, ordinances, and codes.

Contradiction of Laws: The Orleans Parish Sheriff's Office, if there is a contradiction of Federal and State Statutes will revert from Federal to State Law, or whichever is the most stringent possible.

Disadvantaged Business Enterprise: It is the policy of the Orleans Parish Sheriff's Office to provide for the maximum opportunity for Disadvantaged Business Enterprise to participate in the performance of contracts.

The Contractor agrees to ensure that DBE's, as defined in 49CFR26, have the maximum opportunity to participate in the performance of this contract and any subcontracts that may be let. In this regard, the contractor shall take all necessary and reasonable steps in accordance with 49CFR26 to ensure that DBE's have the maximum opportunity to compete for and perform services relating to this contract. Furthermore, the consultant shall not discriminate on the basis of race, color, national origin, or sex.

Employment Standards: It is also the policy of the Orleans Parish Sheriff's Office to provide for employment standards as approved for by the United States Governments. If any company wishes for an entire copy of this act, they may contact the Purchasing Department for a copy of this Act.

PERISHABLE TERMS AND CONDITIONS

1. Length of Bid: Only this portion of the Inmate bid will be for a period of 168 days with an option to renew 3 (three) additional times for a total bid period of two (2) years. It is the option of the OPSO with vendor mutual consent to renew. If the option to renew is utilized, OPSO will contact the vendor (30) days before the contract expires.
2. Amount of Bid Item: The amounts given below reflect approximations for items used during this time frame. Delivery amounts will be updated weekly with communication between the vendor and the Food Service Director or his designee. If at any time, a shortage of product occurs, it is the responsibility of the vendor to provide the product in a time frame agreeable to the Food Service Director or his designee.
3. Delivery Requirements: Perishables must be delivered to the correct site as shown at the Mandatory Pre-Bid Conference: Bread (2801 Perdido St. Warehouse bread container), and Milk (2801 Perdido St. Warehouse bread container). At each delivery, the driver must contact the appropriate OPSO personnel and follow all standard operating procedures. Following the offloading and rotation of product, the delivery receipt must be given to OPSO warehouse personnel to be considered a complete delivery.

Milk and bread deliveries shall be Monday, Wednesday, and Friday between the hours of 0700 and 1400 hours. Population variations and emergency situations will affect all deliveries amounts and times.
4. Containers: The vendor/delivery personnel must remove all delivery containers on a daily basis. The OPSO will not be held responsible for any delivery containers left at the OPSO location.
5. Standard Operating Procedures: Are available upon request from the Food Service Director or his designee and will be given out at the Mandatory Pre-bid Conference. Failure to follow these security procedures will cancel this contract immediately.
6. Vendor Contact: As a perishable item, the OPSO wishes for success in all of our endeavors. The OPSO shall have daily contact numbers (and email if used for all delivery personnel, salesman, and distribution personnel). Emergency phone numbers shall also be formally communicated by both parties.
7. Failure to Provide Service: If at any time, a vendor fails to provide the service contracted upon by mutual consent of OPSO and the winning vendor, the contractor will be given a written notice of contract violation. If not resolved to the satisfaction of the Food Service Director the contract will be considered cancelled. The OPSO will then follow contract conditions as noted in Section 3, Page 9.
8. Packaging of Product: Bread shall be packaged in unmarked, clear bags, without any vendor advertising. Package dates and "good till" dates shall be well marked and easily readable. The container shall contain only 8 oz. of fluid milk. No variations to the milk container will be considered.
9. Credit for inferior merchandise: If merchandise is deemed unwholesome and unacceptable to the OPSO Food Service Director, a credit to the OPSO account shall be made in a reasonable time. OPSO will provide samples of the affected product and an approximate amount of product in OPSO possession. The OPSO expects a either a credit or a replacement for the affected product. The communication of such problems will be communicated and documented to allow maximum communication and transparency.

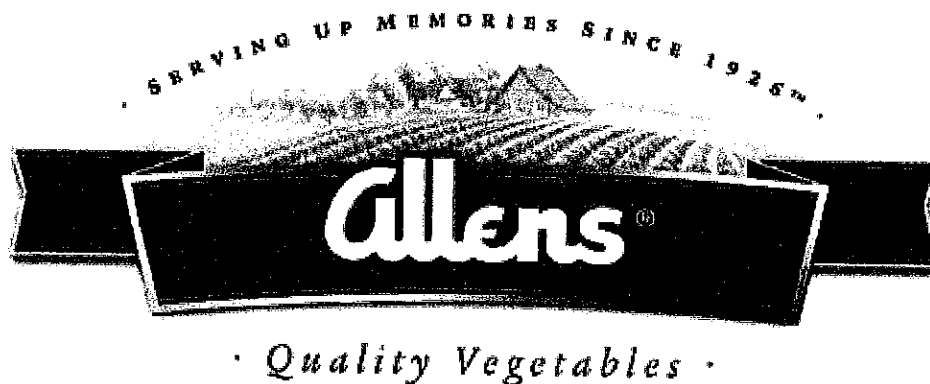


