CLARIFICATION TO THE BID SPECIFICATIONS:

Question:

Regarding the workers compensation insurance, if we will have subcontractors manage the vast majority of the job and they have their own Worker's Compensation insurance, does the prime bidder need it's own WC insurance? Or can we provide the subcontractor's WC insurance?

Answer: The prime bidder must possess and maintain the required workers compensation insurance until the project has been completed.

Question:

Regarding the comprehensive automobile liability insurance, if for example we will not utilize any company employees or company vehicles hauling on the job, and we have subcontractors hauling the materials, then do we need to provide comprehensive automobile liability insurance? Again we can provide the subcontractors automobile liability insurance.

Answer:

The prime bidder must possess and maintain the required comprehensive automobile liability insurance until the project has been completed.

Question:

In the previous RFQ that was cancelled it was indicated "Contractor shall provide needed equipment to load material at stockpile and spread material at dump site as instructed by Parish Personnel" Is this not the case anymore? Are we not responsible for loading the materials at the stockpile site? Answer: As stated on page SP-1, "All material is to be loaded by Jefferson Parish personnel at the stockpile....." Are we not responsible for spreading the materials at the dump site? Only dumping it?

Answer:

Contractor shall provide needed equipment to load material at stockpile and spread material at dump site as instructed by Parish Personnel. Spreading will consist of simple leveling and will not be tested or required to be placed in lifts.





Bidders may submit bid responses at this location, pending authorization in each bid package. **Bidders should carefully read and must respond accordingly per the requirements of the bid packages. NOTE: Bidders submitting bids on the day of bid opening, bidders must submit at the West Bank location only.**

Other Changes Continued:

- For all advertised sealed bids, written evidence of signature authority must be included with bid submission.
- Current W9 Forms and vendor applications may be submitted at any time; however, if your company is not registered and/or a current W-9 form is not on file, a current W-9 form must be supplied upon contract execution, should you be awarded a contract and/or issued a purchase order.

Specifications

This contract is for the hauling of 100,000 cubic yards of stockpile soil from the Jefferson Parish Drainage Department stockpile at Dickory Avenue and Earhart Expressway to 5801 Leo Kerner Parkway, Marrero LA 70072. All material is to be loaded by Jefferson Parish personnel at the stockpile site, hauled and dumped by the successful bidder to 5801 Leo Kerner Parkway where parish personnel will receive it. Contract time is six (6) months. Hauling is restricted to between 9am and 3pm. The hauling route must be from Dickory Avenue to the Earhart Expressway, Earhart to Clearview, Clearview to Highway 90, Highway 90 to Westbank Expressway, Westbank Expressway to Barataria Boulevard, Barataria Boulevard to Leo Kerner Parkway. The deposition of mud and other debris on public roads shall be minimized to the extent possible. If a serious deposition of dirt has occurred and the contractor has not cleaned area/areas to Jefferson Parish's satisfaction, then the Parkways Department will send a sweeper to the location and charge the contractor an hourly rate of \$125.00 for cleaning area/areas. This hourly rate will include travel time to the location, clean up time and travel time, back to the sweeper's initial location. The charge will be withheld from the invoice payment for that cycle which incident occurred.

A Louisiana Contractor's License is required with classification: Heavy Construction.

A performance bond in the amount of \$500,000.00 is required.

A bid bond in the amount of \$5,000.00 is required.

STANDARD INSURANCE REQUIREMENTS – PUBLICLY ADVERTISED BIDS

All required insurance under this bid shall conform to Jefferson Parish Resolution No. 113646 or No. 113647, as applicable. Contractors may not commence any work under any ensuing contract unless and until all required insurance and associated evidentiary requirements thereto have been met, along with any additional specifications contained in the advertised bid. Except as where otherwise precluded by law, the Parish Attorney or his designee, with the concurrence of the Director of Risk Management or his designee, may agree on a case-by-case basis, to deviate from Jefferson Parish's standard insurance requirements, as provided in this Section. Vendors requesting deviation therefrom shall submit such requests in writing, along with compelling substantiation, to the Purchasing Department prior to the bid's due date. Any changes to the insurance requirements will be reflected in the bid specifications and addenda. Prior to contract execution and at all times thereafter during the term of such contract, contractors must provide and continuously maintain all coverages as required by the foregoing Resolutions, and the contract documents. Failure to do so shall be grounds for suspension, discontinuation or termination of the contract.

For bidding purposes, bidders must submit with bid submission a current (valid) insurance certificate evidencing the required coverages. Failure to comply will cause bid to be rejected. The current insurance certificate will be used for proof of insurance at time of evaluation. The person who gives Form W-9 to the partnership for purposes of establishing its U.S. status and avoiding withholding on its allocable share of net income from the partnership conducting a trade or business in the United States is in the following cases:





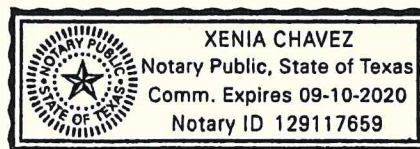
