


YARD EXTRUDED ECOGUARD VINYL; MANUFACTURING USING 33% REPROCESSED VINYL. **FABRIC:** 1000 DENIER POLYESTER FABRIC, TEAR STRENGTH TEST: WARP 78LBS., FILL 65LBS., TENSILE STRENGTH: WARP 224LBS., FILL 220 LBS., WEFT INSERTION: 9 x 9, SUPERIOR UV INHIBITORS, COLD CRACK: MINUS 50 DEGREES FAHRENHEIT, COLORS PER MANUFACTURER'S STANDARD SELECTION, AS SELECTED BY ARCHITECT.
