RESOLUTION NO. 131389

A resolution accepting the lowest responsible bid of **Bollinger Quick Repair, LLC** received on April 3, 2018, under Proposal No. 50-00122099, in the amount of \$1,554,550.00 for Replacement of Diesel Engines and Rehabilitation of Gears for Elmwood Pump Station, Phase IV for the Department of Public Works, Drainage, and Public Works Project No. 2010-057C-PS. (Council District 4)

WHEREAS, the Parish has engaged Digital Engineering and Imaging, Inc. to prepare the plans and specifications for Replacement of Diesel Engines and Rehabilitation of Gears for Elmwood Pump Station, Phase IV, JP Project 2010-057C- PS, hereinafter referred to as the Project; and,

WHEREAS, Jefferson Parish received bids on April 3, 2018, for labor, materials and equipment required for the project; and,

WHEREAS, Bollinger Quick Repair, LLC submitted the lowest responsible bid under Proposal No. 50-00122099 at the total cost of \$1,554,550.00; and,

WHEREAS, Digital Engineering and Imaging, Inc. has recommended that award of the contract be made to the lowest responsible bidder Bollinger Quick Repair, LLC; and,

WHEREAS, the bid of Bollinger Quick Repair, LLC is in order and within the available construction budget for the project.

NOW, THEREFORE, BE IT RESOLVED, by the Jefferson Parish Council of Jefferson Parish, Louisiana, acting as governing authority of the Department of Drainage of said Parish:

SECTION 1: That the lowest responsible bid of Bollinger Quick Repair, LLC received April 3, 2018, under Proposal No. 50-00122099 in the amount of \$1,554,550.00 for labor, material and equipment required for Replacement of Diesel Engines and Rehabilitation of Gears for Elmwood Pump Station, Phase IV, JP Project 2010-057C-PS be and is hereby accepted.

SECTION 2: That the cost for this construction is to be funded from Account No. 45210-4037-7454 (52110.005)

SECTION 3: That maximum expenditures shall not exceed \$1,554,550.00 without an approved change order.

SECTION 4: That the term of this contract shall commence from the date indicated on the Notice to Proceed.

SECTION 5: That the Council Chairwoman or, in her absence, the Vice- Chairman be and is hereby authorized to execute any and all documents necessary to give full force and effect to this resolution.
