Section 6.0 Frequency of Service

All monthly visits/treatments will be scheduled prior to building/facility opening hours and accompanied by library maintenance staff.

In addition to scheduled monthly visits, the contractor will be required at no additional costs to the Jefferson Parish Library Department, to visit sites and perform necessary pesticide treatments within twenty-four (24) hours after receiving notice from the Jefferson Parish Library Department that additional pest control is needed. Additionally, the contractor's management or technical staff should be available for consultation on an as needed basis, via telephone, and/or personal visit. Section 7.0 Permits

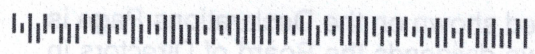
