The Jefferson Parish Purchasing Department would like to make vendors aware of the following changes:

Total Bid Price Must Include the Cost of Naming Jefferson Parish as Additional Insured:

Electronic Procurement: Beginning November 1, 2020, Jefferson Parish will no longer accept manual bid submissions; and will only accept bid submissions electronically via our e-Procurement system, Central Bidding. Central Bidding can be accessed by visiting either www.centralbidding.com or www.jeffparishbids.net. All bidders will be required to register with Central Bidding. Section 1.0 – Pre-Bid Conference:

A Pre-Bid Conference will not be necessary.

Section 2.0 – Scope:

We extend this proposal to cover all labor, materials, and necessary essentials to remove and replace nugget ice machine head onto existing bin at **Bayou Segnette Ballfield, Coach's Office, 2000 Bayou Segnette Blvd., Westwego, LA 70094**

Section 3.0 – Quantities/Inspection:

Bidders must inspect the site in order to determine the proper equipment required to complete this project.

Section 4.0 – Bid Specifications:

The successful bidder shall supply all labor, materials, and necessary essentials to perform the following at **Bayou Segnette Ballfield, Coach's Office** as described:

A. Removal

Will remove existing nugget ice machine head only and dispose of properly.

B. Supply

1. Manitowac air cooled nugget ice machine head, model no. RNF0320A, 115V, 1 phase, 16.3 amp or equal
2. Unit is to include a 3 year factory parts and labor warranty
3. Unit is also to include 1 Everpure 4FC'c water filter kit or equal
4. Storage bin from old head will be re-used.

Section 5.0 – Cleaning Area and Safety:

Contractor must perform daily housekeeping on work area and removal of job debris

Section 6.0 – Pre-Construction Conference and Notice to Proceed:

A Pre-Installation Conference shall be held between the successful bidder and the owner before any work commences.

Section 7.0 – Construction Term

Upon receiving a notice to proceed, the Bidder agrees that all work shall be completed as follows: Vendor agrees to commence actual physical work on the site with an adequate force and equipment within 10 days from the date of Notice of Proceed. All work shall be substantially completed in **NINETY (90)** consecutive calendar days from date of Notice to Proceed.

Contractors may not commence any work under any ensuing contract unless and until all required insurance and associated evidentiary requirements thereto have been met, along with any additional specifications contained in the Invitation to Bid.
