
A special meeting of the Board of Directors was called on Friday, September 27, 2019 at the offices of Economical Janitorial & Paper Supplies, LLC located at:

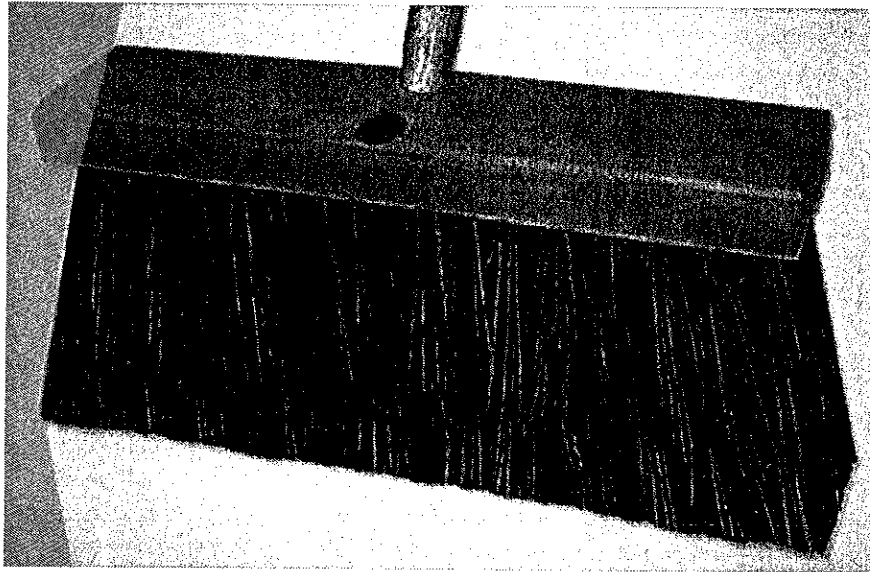

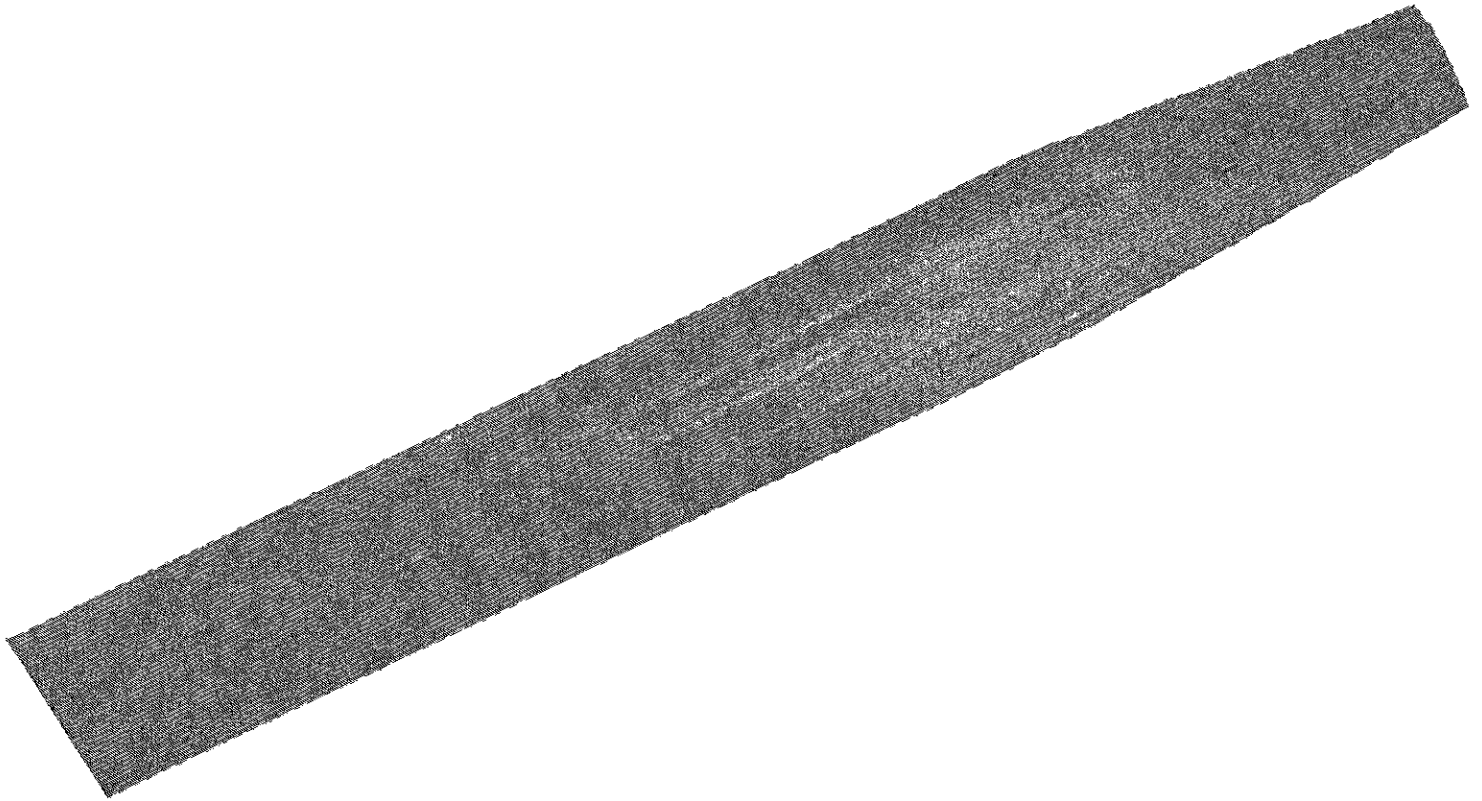

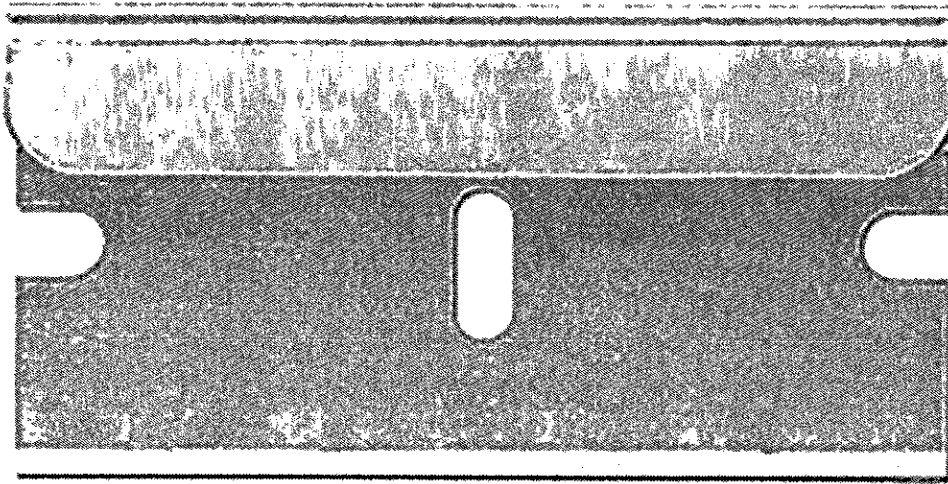
