Who is an Insured is amended to include any person(s) or organization(s) for whom you have agreed in a written contract or agreement to provide insurance, but only for damages: (a) which are covered by this insurance; and (b) which you have agreed to provide in such contract or agreement. 2. The limits of insurance afforded to such person(s) or organization(S) will be: (a) the minimum limits of insurance which you agreed to provide, or (b) the limits of this policy whichever is less. 3. This insurance will be primary to and non-contributing with any other insurance available to such person(s) or organization(s).</p> <p>2. Additional Insured Vendors: Who is an Insured is amended to include any person or organization for whom you have agreed</p>		

to provide such insurance under contract but only with respect to bodily injury or property damage arising out of your products as required by written contract or agreement.

3. Additional Insured Managers or Lessors of Premises: Who is an Insured is amended to include as an insured the person or organization where required by written contract or agreement but only with respect to liability arising out of the ownership, maintenance or use of that part of the premises leased to you.

4. Waiver of Transfer of Rights of Recovery Against Others to Us The Transfer of Rights of Recovery Against Others to Us Condition is amended by adding the following: We waive any right of recovery we may have against any person or organization when you have agreed in a written contract to such waiver prior to loss.

5. Territory - United States of America (its territories and possessions), Puerto Rico and Canada.

**Automobile Liability:**

1. Additional Insured Who is an Insured is amended to include an person(s) or organization(s) for whom you have agreed in written contract to provide insurance but only for damages (a) which are covered by this insurance; and (b) which you have agreed to provide in such contract. 2. The limits of insurance afforded to such person(s) or organization(s) will be: (a) the minimum limits of insurance which you agreed to provide or (b) the limits of insurance of this policy, whichever is less. The insurance afforded to such additional insured will be primary and non-contributory when required by such written contract.

2. Waiver of Transfer of Rights of Recovery Against Others to Us With respect to coverage provided by this endorsement, the provisions of the Coverage From apply unless modified by the endorsement.

We waive any right of recovery we may have against any person or organization to the extent required of you by a written contract executed prior to any accident, provided that the accident arises out of operations contemplated by such contract. The waiver applies only to the person or organization designated in such contract.

**Workers Compensation & Employers Liability**

1. Waiver of Our Right to Recover from Others We have the right to recover our payments from anyone liable for an injury covered by this policy. We will not enforce our right against the person or organization where required by written contract executed prior to the loss to which it applies.

**Named Insured includes:**

Avery Dennison Corporation including any subsidiary corporation thereof, of any tier, as were, are now or may hereafter be constituted and any other legal entity in which you have more than fifty percent ownership or over which you exercise management or financial control.

Insurance Company may cancel the subject policies by mailing or delivering to the First Named Insured 90 days notice of cancellation for any reason except non-payment of premium.
