Alternate No. 2 Add the cost of reducing the project completion date from 295 days to 265 days for the lump sum of:

Seventy Five Thousand Dollars (\$ 75,000.00)

Alternate No. 3 Add the cost of completing the first floor space designated as 1B: and ID: Workroom for the lump sum of:

Forty One Thousand Dollars (\$ 41,000.00)


