All bids submitted are subject to these instructions and general conditions and any special conditions and specifications contained herein, all of which are made part of this bid proposal reference. By submitting a bid, vendor agrees to comply with all provisions of Louisiana Law, as well be in compliance with the Jefferson Parish Code of Ordinances, Louisiana Code of Ethics, applicable Jefferson Parish ethical standards and Jefferson Parish Resolution No. 113646 and/or Resolution No. 113647. Delivered, anywhere within the Parish as designated by the Purchasing Department. **JEFFERSON PARISH WILL ACCEPT ONE BID ONLY FROM EACH VENDOR.** Items bid must meet specifications. **JEFFERSON PARISH** will accept one price for each item unless otherwise indicated. Two or more prices for one item will result in bid rejection. Bidders are required to complete, sign and return the bid form and/or complete and return the associated line item pricing forms as indicated. The price quoted for work shall be stated in figures. PROTESTS: Only those vendors that submit bids in response to this solicitation may protest any element of the procurement, in writing to the Director of the Purchasing Department. After consultation, the Parish Attorney's Office will then respond to protests in writing. 1. All bidders must attend the MANDATORY pre-bid conference and will be required to sign in and out as evidence of attendance. In accordance with LSA R.S. 38:2212(I), all prospective bidders shall be present at the beginning of the MANDATORY pre-bid conference and shall remain in attendance for the duration of the conference. Any prospective bidder who fails to attend the conference or remain for the duration shall be prohibited from submitting a bid for the project.
2. Attendance to this pre-bid conference is optional. However, failure to attend the pre-bid conference shall not relieve the bidder of responsibility for information discussed at the conference. Furthermore, failure to attend the pre-bid conference and inspection does not relieve the successful bidder from the necessity of furnishing materials or performing any work that may be required to complete the work in accordance with the specification with no additional cost to the owner.

All awards in excess of \$25,000.00 will require both a performance and a payment bond. 

Specifications for the Repair of Traffic Signal Controllers Traffic Engineering Division

Items included in this contract:

Solid state traffic signal controllers, electronic time clocks and time clock switches, Utilicom long ranger receiver transceivers including power supplies, stand-alone modems, electronic conflict monitors, traffic detection cameras, and rack mounted cards.

1. Repairs to be bid on hourly labor cost and parts based on percent of trade discount from manufacturers list.
2. Vendor must provide a written quotation faxed or emailed to the Traffic Engineering Division, 504-736-6256 prior to repairs. Written approval from the Traffic Engineering Division Signal Superintendent via email will be sent to contractor before repairs are to commence.
3. Maximum payment of one hour labor will be allowed to vendor for repair estimate but applies at approval of repair.
4. Equipment in need of repair will be shipped to vendor by the Traffic Engineering Division on prepaid basis and returned by vendor at his cost.

All repaired equipment should be returned within thirty days after receiving approval for repairs.

***All equipment on this contract is highly technical electronic equipment not in working order and we are unable to repair these in-house. Therefore, it is necessary to send this equipment to the manufacturer for repairs.*
