JEFFERSON PARISH will accept one price for each item unless otherwise indicated. Two or more prices for one item will result in bid rejection. In the event there is a difference in unit prices and totals, the unit prices shall prevail.

In accordance with LSA R.S. 38:2212(I), all prospective bidders shall be present at the beginning of the MANDATORY pre-bid conference and shall remain in attendance for the duration of the conference. Any prospective bidder who fails to attend the conference or remain for the duration shall be prohibited from submitting a bid for the project.
2. Attendance to this pre-bid conference is optional. However, failure to attend the pre-bid conference shall not relieve the bidder of responsibility for information discussed at the conference. **Geotab Installation Specifications**

Jefferson Parish Department of Public Works is seeking a professional installer of vehicle tracking equipment. The Tracking Devices are purchased by Jefferson Parish and this contract shall only cover the installation, un-installation and re-installation of said devices. Vendor must be a certified Geotab Installer at the time of bidding. Those interested in becoming certified Geotab installers can go the following link <https://www.geotab.com/?s=installer> to inquire about becoming a certified Geotab installer.

**Liquidated Damages:**

Water Department - Installer shall complete assigned tasks within three (3) business days of receiving a Jefferson Parish work-order or the notice to proceed. Liquidated damages are assessed at \$125 per day.

Street Department the liquidated damages are assessed at \$125 per day for the initial install and thereafter. Installer shall complete the first initial install of 135 units within a thirty (30) day period of receiving the work-order or the notice to proceed. Any devices needing installing, disconnecting, and/or relocating thereafter will have (3) business days of receiving the work-order or the notice to proceed.

**Scope:**

Installer must properly document Geotab tracking devices (hereafter referred to as devices) in such a way that Jefferson Parish vehicle number and Vehicle Identification Number can be associated with the serial number of the device installed in each vehicle. The installer will also document such information when a device is un-installed. Photographs showing the finished install for each vehicle will be furnished to Jefferson Parish on a disc. The installer will maintain copies of these photographs as well.

Jefferson Parish will provide the devices as well as any harnesses, cables, and adhesive tabs that are needed to complete the install. The installer will make certain that vehicles are out in the open and not underneath any overhangs or covered areas when performing the installs. The installs will be done in such a way that cables and devices will not interfere with the employee's ability to operate the vehicle. The device will also be installed in such a way that there is always a diagnostics port available for others to plug into. In some vehicles this will be the OBDII port and in other vehicles this will be the J-Bus port.

On occasion, the installer will be called out to uninstall a device from a vehicle that is set to be transferred to Surplus Property. A contact person from the appropriate Jefferson Parish Department will meet the installer on site to collect the device and all harnesses and cables.

In some cases, devices that have already been installed in vehicles will need to be professionally re-installed.

The bidder will provide a trip fee on the bid form for travel to the Jefferson Parish Fleet location where the work under the contract shall be performed, if the vehicle is located at Fleet.

Except as where otherwise precluded by law, the Parish Attorney or his designee, with the concurrence of the Director of Risk Management or his designee, may agree on a case-by-case basis, to deviate from Jefferson Parish's standard insurance requirements, as provided in this Section. Vendors requesting deviation therefrom shall submit such requests in writing, along with compelling substantiation, to the Purchasing Department prior to the bid's due date. Any changes to the insurance requirements will be reflected in the bid specifications and addenda. Prior to contract execution and at all times thereafter during the term of such contract, contractors must provide and continuously maintain all coverages as required by the foregoing Resolutions, and the contract documents. Failure to do so shall be grounds for suspension, discontinuation or termination of the contract.


