The price quoted for work shall be stated in figures. In the event there is a difference in unit prices and totals, the unit price shall prevail. Quotations shall be based on F.O.B. Delivered, anywhere within the Parish as designated by the Purchasing Department. JEFFERSON PARISH WILL ACCEPT ONE BID ONLY FROM EACH VENDOR. Items bid must meet specifications. JEFFERSON PARISH will accept one price for each item unless otherwise indicated. Two or more prices for one item will result in bid rejection. PROTESTS: Only those vendors that submit bids in response to this solicitation may protest any element of the procurement, in writing to the Director of the Purchasing Department. After consultation, the Parish Attorney's Office will then respond to protests in writing. Any prospective bidder who fails to attend the conference or remain for the duration shall be prohibited from submitting a bid for the project.
2. Attendance to this pre-bid conference is optional. However, failure to attend the pre-bid conference shall not relieve the bidder of responsibility for information discussed at the conference. 

Two (2) year contract for pest, rodent and insect control at various locations for the Jefferson Parish Department of Public Works – Streets.

Pest, rodent and insect control must be performed on a monthly basis.

Vendor must make an appointment to gain access to all rooms and facilities. Vendor is to contact Amy Bourg, Executive Assistant at 504-349-5800, Monday through Friday, between the hours of 8:00 AM and 4:00 PM to make an appointment. Appointments must be scheduled on Monday through Friday between the hours of 8:00 AM and 4:00 PM.

Locations to be serviced:

EASTBANK MAINTENANCE BUILDING – 200 SHREWSBURY, JEFFERSON, LA (approx. 25,000 sq. ft.)

This address includes the Eastbank Maintenance Administrative Building and Maintenance Warehouse/Shop.

ADMINISTRATIVE BUILDING – 1901 AMES BLVD, MARRERO, LA (approx. 13,350 sq. ft.)

This address includes the Streets Administrative Building and Warehouse/Shop.

WESTBANK MAINTENANCE BUILDING – 5701 BELLE TERRE RD, MARRERO, LA (approx. 22,800 sq. ft.)

This address includes the Westbank Maintenance Administrative Building, Maintenance Warehouse/Shop, and the Central Warehouse.

PARKWAYS – 1855-A AMES BLVD, MARRERO, LA (approx. 1,400 sq. ft.)

ENGINEERING/ SCADA/ 2ND JUSTICE COURT – 1887 AMES BLVD, MARRERO, LA (approx. 4,000 sq. ft.)

Services for all locations are to include the spraying of every room on each floor of the building and areas such as base-boards, under cabinets/desks and all storage areas.

General - It shall be the duty of every parish officer, employee, department, agency, special district, board, and commission; and the duty of every contractor, subcontractor, and licensee of the parish, and the duty of every applicant for certification of eligibility for a parish contract or program, to cooperate with the inspector general in any investigation, audit, inspection, performance review, or hearing pursuant to this chapter. Every parish contract and every bid, proposal, application or solicitation for a parish contract, and every application for certification of eligibility for a parish contract or program shall contain a statement that the corporation, partnership, or person understands and will abide by all provisions of this chapter.

STANDARD INSURANCE REQUIREMENTS FOR BIDDING PURPOSES

All required insurance under this bid shall conform to Jefferson Parish Resolution No. 113646 or No. 113647, as applicable. Contractors may not commence any work under any ensuing contract unless and until all required insurance and associated evidentiary requirements thereto have been met, along with any additional specifications contained in the **Invitation to Bid**. Except as where otherwise precluded by law, the Parish Attorney or his designee, with the concurrence of the Director of Risk Management or his designee, may agree on a case-by-case basis, to deviate from Jefferson Parish's standard insurance requirements, as provided in this Section. Vendors requesting deviation therefrom shall submit such requests in writing, along with compelling substantiation, to the Purchasing Department prior to the bid's due date. Any changes to the insurance requirements will be reflected in the bid specifications and addenda. Prior to contract execution and at all times thereafter during the term of such contract, contractors must provide and continuously maintain all coverages as required by the foregoing Resolutions, and the contract documents. Failure to do so shall be grounds for suspension, discontinuation or termination of the contract.

For bidding purposes, bidders must submit with bid submission a current (valid) insurance certificate evidencing the required coverages. Failure to comply will cause bid to be rejected. The current insurance certificate will be used for proof of insurance at time of evaluation.
