

Guardrail will be primed and painted with one coat of exterior enamel paint.

Post will extend 12" inches into 8" diameter by 1'-4" deep concrete footings

Contractor will probe each post location to verify the absence of roots and other obstructions before fabrication so that spacing may be adjusted.

No removal of roots, concrete, or other underground obstructions is included.
