Section 1.0 – PRE-BID CONFERENCE

Section 2.0 – Scope:

We extend this proposal to cover all labor, materials, and necessary essentials to install acoustic sound panels in gymnasium at

Pontiff Playground

1521 Palm St.

Metairie, LA 70001

Section 3.0 – License Requirement:

A Louisiana State Contractor's License will be required in the following classifications:

Signs, Scoreboards, Displays and Billboards (Electrical and Non-Electrical)

Section 4.0 – Quantities/Inspection:

Bidder must inspect the site and perform their own measurements in order to determine the proper quantity of materials and equipment required to complete this project. All measurements given in these specifications are informational only.

Section 5.0 – Bid Specifications:

The successful bidder shall supply all labor, materials, and necessary essentials to perform the following at Pontiff Playground Gymnasium.

- Install four (4) MDC Interior Solutions “Zintra Acoustic Baffles to existing interior gymnasium walls.
- Installation location of the baffles to be chosen by the Jefferson Parish Recreation Department.
- All four (4) acoustic baffles must be 160 inches wide by 88 inches high.
- All four (4) acoustic baffles must include a custom cut mitered 1.5 inch silver brushed aluminum frame 160 inches wide by 88 inches high.
- All four (4) acoustic baffles must include a single edge sided printable power stretch fabric 122 with a 5/8 inch white silicone gasket. The acoustic baffles at 160 inches wide by 88 inches high.
- Successful bidder shall design and supply all artwork and graphic advertisement graphics for fabric on each acoustic baffle. Jefferson Parish Recreation Department will approve all baffle, fabric colors, design of artwork and graphics in the project.
- All four (4) baffles will be installed to cinder block gymnasium wall. Hardware to be used for mounting installation shall be supplied by successful bidder.

Section 6.0 - Hours of Work:

Work shall be performed during normal working hours. All work must be scheduled with owner representative 5 days in advance. The successful bidder shall work normal building working hours (8:00am – 4:30pm) to provide a safe work environment at no extra charge to Jefferson Parish.

Section 7.0 – Cleaning Area and Safety:

Job site must be clean and free of all litter and debris daily and upon completion of the contract. Passageways must be kept clean and free of material, equipment, and debris at all times. Inflammable material must be removed from the job site daily, because storage will not be permitted on the premises. Precautions must be exercised at all times to safeguard the welfare and safety of the general public, employees of Jefferson Parish, and other Parish officials.

Section 8.0 – Permits:

The successful bidder shall obtain any and all permits required by the Jefferson Parish Department of Inspection and Code Enforcement. The successful bidder shall also be responsible for payment of these permits. All permits must be obtained prior to the start of the project.

Section 9.0 – Warranty:

All workmanship shall be done not to interfere with the existing One (1) year warranty in writing, from the manufacturer from the date of acceptance of the projects against defects. The bidder must agree, upon written notice from the owner, promptly and without charge, and to the satisfaction of the owner, to make changes, replacements, and corrections which may be required to make good all defects in materials and/or equipment under its intended use, within the warranty period, at no cost to the owner

Section 10.0 – Existing Structure:

Should any cutting, patching, alteration, addition, or repairs to existing structure, wall, floor, ceiling, or part of building be required of this project, the successful bidder shall restore the alteration to its original condition, with the same type materials, finish, and workmanship.

Section 11.0 – SDS:

The bidder shall notify the Jefferson Parish Department of Parks and Recreation contact person of any hazardous substances that will be brought to and/or used at the workplace. The successful bidder shall provide material safety data sheets MSDS as per this requirement to the Project Manager, Department of Parks and Recreation.

Section 12.0 – Pre-Construction Conference and Notice to Proceed:

A Pre-Construction Conference shall be held between the successful bidder and the owner before any work commences. No work shall be performed until the successful bidder receives a written “Notice to Proceed” to begin work.

Section 14.0 – Construction Term

Upon receiving a Notice to Proceed, the successful bidder agrees that all work to be completed as follows: Vendor agrees to commence actual physical work on the site with adequate force and equipment within **4 WEEKS** from the date of notice to proceed. All work shall be substantially completed in **1 MONTH**.





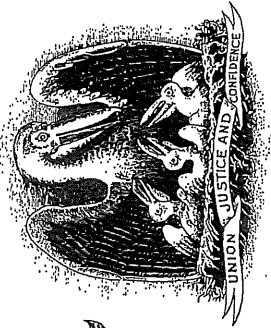
