In accordance with LSA R.S. 38:2212(I), all prospective bidders shall be present at the beginning of the MANDATORY pre-bid conference and shall remain in attendance for the duration of the conference. Any prospective bidder who fails to attend the conference or remain for the duration shall be prohibited from submitting a bid for the project.
2. Attendance to this pre-bid conference is optional. However, failure to attend the pre-bid conference shall not relieve the bidder of responsibility for information discussed at the conference. 1.0 SCOPE:

Bidder shall furnish one (1) reconditioned Siemens electrically operated draw-out style vacuum circuit breaker. The requested circuit breaker is a direct replacement and must match up to all existing equipment at the East bank Wastewater Treatment Plant. There will be no pre-bid conference.

2.0 WORK TO BE PERFORMED:

Bidder shall furnish one (1) reconditioned 4160 High Voltage, Siemens circuit breaker Product No. 5-MSV-250A-1200-58. Product shall be 1200A, 5kV Class, 250mVA Rated, Electrically Operated, Draw-out Style Vacuum Circuit Breaker. Product shall be used for the Plant's blower main breaker and must be a direct replacement.

3.0 RECONDITIONED CIRCUIT BREAKER PROCESS:

Reconditioned process shall meet or exceed the OEM specifications. Circuit Breaker shall meet all Standards for this process. All reconditioned processes will be performed or supervised by a qualified technician. Final quality assurance will be performed by another qualified technician other than the processor mentioned above. Reconditioned breaker shall be tested using calibrated test sets to original equipment manufacturing (OEM) specifications.

4.0 WARRANTY:

Circuit breaker and all parts shall have a 12 month warranty.
