Any prospective bidder who fails to attend the conference or remain for the duration shall be prohibited from submitting a bid for the project.
2. Attendance to this pre-bid conference is optional. However, failure to attend the pre-bid conference shall not relieve the bidder of responsibility for information discussed at the conference. We extend this proposal to cover all labor, materials, and necessary essentials for the installation of conductor head, scuppers and downspout as required by the bid specifications below for The Department of Public Works Rehab.

SECTION 3.0 – LICENSE REQUIREMENTS:

SECTION 4.0 – QUANTITIES/INSPECTION:

Need quantities from vendor.

SECTION 5.0 – BID SPECIFICATIONS:

The successful bidder shall supply all labor, materials, and necessary essentials to perform the following at the Rheem Building, 4901 Jefferson Highway, Suite E, Jefferson, LA 70121

- On upper metal roof cut a thru wall scupper into existing wall.
- Install a conductor head 16"x16", tie into a 6"x6" downspout ran to gutter side of building.
- Install a 6" scupper at gutter area with a 16" conductor head and down spout to ground.
- Provide owner with a 2 year workmanship warranty.

SECTION 6.0 – CLEANING AREA AND SAFETY:

Contractor must perform daily housekeeping on work area.

SECTION 7.0 – PRE-CONSTRUCTION CONFERENCE AND NOTICE TO PROCEED:

A Pre-Installation Conference is not needed.

STANDARD INSURANCE REQUIREMENTS FOR BIDDING PURPOSES

All required insurance under this bid shall conform to Jefferson Parish Resolution No. 113646 or No. 113647, as applicable. Contractors may not commence any work under any ensuing contract unless and until all required insurance and associated evidentiary requirements thereto have been met, along with any additional specifications contained in the **Invitation to Bid**. Except as where otherwise precluded by law, the Parish Attorney or his designee, with the concurrence of the Director of Risk Management or his designee, may agree on a case-by-case basis, to deviate from Jefferson Parish's standard insurance requirements, as provided in this Section. Vendors requesting deviation therefrom shall submit such requests in writing, along with compelling substantiation, to the Purchasing Department prior to the bid's due date. Any changes to the insurance requirements will be reflected in the bid specifications and addenda. Prior to contract execution and at all times thereafter during the term of such contract, contractors must provide and continuously maintain all coverages as required by the foregoing Resolutions, and the contract documents. Failure to do so shall be grounds for suspension, discontinuation or termination of the contract.

For bidding purposes, bidders must submit with bid submission a current (valid) insurance certificate evidencing the required coverages. Failure to comply will cause bid to be rejected.
