1.0 PRE BID CONFERENCE:

NFPA 17 requires the fire links be changed in the vent hoods at time of inspection; these links shall be included in the contract bid price. Nozzle caps shall also be included in the contract bid price.

5.0 BID INFORMATION

The contractor shall give unit prices for each test and or inspection as it pertains to each Fire station.

6.0 COMMUNICATION:

Immediately after conducting any test or inspection, the contractor shall inform the owner in writing the results of test or inspection. This report shall list all deficiencies and costs to make necessary repairs.






