All prospective bidders are invited to attend this non-mandatory pre-bid conference which will be held; the date and location to be determined. However, failure to attend the non-mandatory pre-bid conference shall not relieve the bidder of responsibility for information discussed at the conference. Furthermore, failure to attend the non-mandatory pre-bid conference and inspection does not relieve the successful bidder from the necessity of furnishing materials or performing any work that may be required to complete the work in accordance with the specification with no additional cost to the owner. This conference is held to allow questions to be answered and to inspect the site with the owner's representative.

**Section 2.0 - Scope:**

We extend this proposal to cover the following:

- Labor, transportation, supervision, and equipment necessary to provide a three (3) year labor-only contract to troubleshoot, repair, and install various makes and models of (HVAC) Heating, Ventilation, and Air Conditioning Systems. (Parishwide).

**Section 3.0 Bonds:**

A bid bond will be required with bid submission in the amount of 5% of the total bid. Vendors must submit an electronic bid bond through the respective online clearinghouse bond management system(s) as indicated in the electronic bid solicitation on Central Auction House. Vendor shall indicate the electronic bid bond number in the location specified on the electronic bid envelope. No scanned paper copies of any bid bond will be accepted as part of the electronic bid submission.

**Section 4.0 – License:**

A copy of the front and, if applicable, the back of all licenses listed below shall be submitted with bid submission. Failure to submit this information with bid submission will deem the bid non-responsive.

### Section 5.0 Specifications:

- A properly licensed technician shall only perform troubleshooting, replacement, and equipment repairs.
- The use of a helper will only be allowed upon approval from a Jefferson Parish representative.
- The use of a project estimator will only be allowed upon approval from a Jefferson Parish representative.
- All work shall be provided on an "as-needed" basis. There is no guarantee of the amount of work given throughout this contract.
- There shall be no minimum call-out time, work time, service time, etc., in terms of hours charged under the terms of this contract.
- Time charged to contract shall be from the time personnel arrives on site until the time personnel departs the site.
- Hourly pricing for a Project Estimator, if approved, shall include the following:
  - Engineering Planning
  - Consulting
  - Design
  - Cost Estimating and Construction Management
  - Provide insight and review of planned projects (*as to reduce cost and increase safety and efficiency*).
- Hourly pricing for a Technician and, if needed and approved, a helper shall include the following:
  - Labor for troubleshooting
  - Labor for repair work
  - Labor for software programming
  - Incidental equipment required to perform troubleshooting and repairs
  - Tools needed to perform troubleshooting and repairs
  - Software and computer equipment needed
  - Transportation/Travel time to and from the worksite and picking up parts, tools, equipment, etc.
- Technician and helper arriving at the worksite to perform services shall verify start time by meeting with an owner's representative and sign in (If available) on an owner-provided log book.

NOTE- Failure to sign in with a parish representative may cause non-payment of an invoice for services.
- Technician and helper departing from the work site shall verify departure time by meeting with an owner's representative and sign out (If available) on an owner-provided log book.

NOTE- Failure to sign out with a parish representative may cause non-payment of an invoice for services.
- In case of excessive downtime Jefferson Parish may provide an additional purchase order, not to exceed \$10,000.00, to the successful bidder to obtain the necessary part(s) to complete the repair work. Jefferson Parish will not allow any mark-up of the dealer's invoice cost.

**Section 6.0 – Response Time:**

Bidder must provide a workforce and necessary equipment and tools to respond to multiple facilities simultaneously if need be.

Bidder must respond within four (4) hours after receiving a reference number on non-emergency calls and within two (2) hours for emergency calls. If the bidder fails to respond to the site/location, Jefferson Parish shall reserve the right to cancel this contract.

**Section 7.0 – Safety Precautions:**

Safety precautions must be exercised to safeguard the welfare and safety of the people while any work is being performed.

**Section 8.0 – Permits:**

Bidder shall obtain any permits as required by the Jefferson Parish Department of Inspection and Code Enforcement and any municipality where work is performed.

The bidder shall be responsible for the payment of these permits. All permits must be obtained before the start of any project requiring permits.

**Section 9.0 – Warranty:**

The successful Bidder shall provide a minimum thirty (30) day warranty on all Labor. All parts purchased by the successful bidder shall have a full manufacturer warranty.

**Section 10.0 – Second Opinion:**

Jefferson Parish reserves the right to call for a second opinion on all work diagnoses before approving any repairs.
