**SECTION 3.0 –LICENSE REQUIREMENTS:**

- Commercial Contractors License with a Louisiana State Specialty License in roofing and Sheet Metal Siding

- Drains shall be properly sealed to prevent leaks.
- Clean, re-fill, and perma flash one (1) pitch pocket. Location of pitch pocket will be given at mandatory pre-bid meeting.
- Re-install one (1) downspout. Owner will provide downspout.
- Patch all holes in the exterior panels from the previous fasteners at the missing downspout with new 24 gauge silver kynar metal.
- Supply and install new 24 gauge silver kynar metal straps to mount gutter.
- Supply and install a single ply of roof membrane under each downspout.

### **SECTION 6.0 - HOURS OF WORK:**

The work that is to be performed shall be scheduled during normal working hours, Monday thru Friday, 8:00 AM till 5:00 PM.



## **SECTION 7.0 – CLEANING AREA AND SAFETY:**

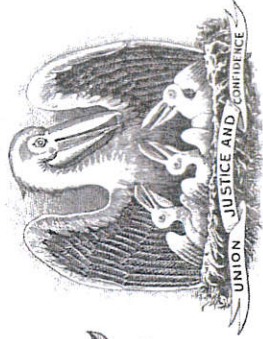

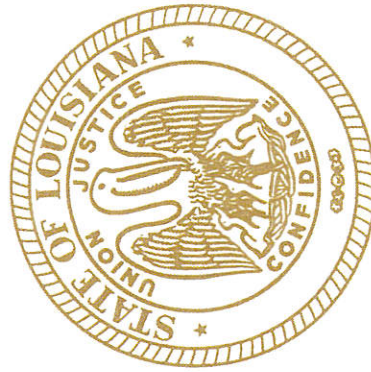
