EJECTORS/CHECK VALVE

- A. Provide (5) Each of EJ2000C1 ejectors. The Ejectors shall be DeNora ejector/check valve assembly shall be of the chlorine water solution feed type and shall create the vacuum necessary to operate the system. The ejector shall be a DeNora Model EJ2000C1. These ejectors already exist in our plant and proved adequate vacuum for our chlorine delivery system which is critical to our plant operation.
- B. The ejector/check valve assembly shall be a spring-opposed, O-ring seal, diaphragm type. The ejector/check valve shall be suitable for 2000 PPD. The springs shall be tantalum alloy.
- C. The ejector shall have a 1-inch vacuum connection.
- D. 2-inch flanged connection to fit in existing piping and compatible with the floor mounted chlorinators. *The ejectors will fit into an existing system and must provide adequate vacuum to operate existing chlorinators. No substitutions will be acceptable. GAS FEEDERS, METER ASSEMBLIES

Provide three (3) – 2000 PPD Meter Panels, two (2) 1000 PPD Meter Panels and one (1) 500 PPD Meter Panels as per spec below.

- A. Meter Assemblies shall be provided to indicate gas flow rate. A rotameter and rate control valve shall be furnished for each distribution point. The number of distribution points, their location, the location of their respective rotameters and rate control valves and the type of rate control valve for each point. The vacuum inlet and outlet shall be 1" FNPT.
- B. A meter assembly having a 20:1 range shall be provided to indicate the gas feed rate. The meter shall be calibrated for the gas being fed and shall be direct reading in both English and metric units and the meter scale shall be 10 inches. It shall be suitable for mounting on a wall. It shall be provided with a manual rate valve for manual control.
- C. The gas flowmeter shall have dual scale (English/metric) and be sized for an operating maximum capacity of 3,000 PPD for chlorine and sized for 2000 PPD and 1000 PPD respectively.
- D. The Meter Assembly shall be constructed of molded PVC, suitable for wet or dry gas service.
- F. The meter assembly shall be DE NORA WATER TECHNOLOGIES, INC. Series High Capacity MA31 Meter Assembly and will work the with existing vacuum system in our plant. No vacuum changes will be made to our system.
- G. All equipment and parts associated with DeNora chlorine meter panel must be OEM and be in original packaging and shall be furnished by the area authorized factory representative for Jefferson Parish, Louisiana, and for the brand being offered. No substitutions will be accepted. DeNora meter panels bidder shall have an authorized representative of the proposed panels within one (1) hour travel time of project site. 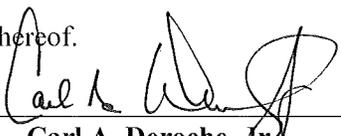
