JEFFERSON PARISH will accept one price for each item unless otherwise indicated. Two or more prices for one item will result in bid rejection. After consultation, the Parish Attorney's Office will then respond to protests in writing. TORQUE AND CURRENT VS SPEED CURVE









VFD OPERATION CURVE




