The Jefferson Parish Purchasing Department would like to make vendors aware of the following changes:

Total Bid Price Must Include the Cost of Naming Jefferson Parish as Additional Insured:

Bidder acknowledges that Bidder recovered the cost of any required insurance in the contract price as required by La.R.S. 9:2780.1 and that Bidder recovered any such cost for the purposes of insuring an obligation to indemnify Jefferson Parish, defend Jefferson Parish, or hold Jefferson Parish harmless and that Bidder's indemnity liability is limited to the amount of the proceeds that are payable under the insurance policy or policies that Bidder has obtained.

Electronic Procurement: Beginning November 1, 2020, Jefferson Parish will no longer accept manual bid submissions; and will only accept bid submissions electronically via our e-Procurement system, Central Bidding. Central Bidding can be accessed by visiting either www.centralbidding.com or www.jeffparishbids.net. All bidders will be required to register with Central Bidding. - This item can ship via UPS, although larger quantities may ship via truck to save you money.
- This item typically ships from Hyattsville, MD 20785.

Assembly

- **Assembly Required:** Ships in flat pack boxes for lower shipping costs. Tools may be needed and may require more than one person for set up.

Functions

- **Swivel-Tilt:** Center tilt point with backrest and seat pan reclining at the same angle; a 1-1 ratio of recline.
- **Tilt-Tension Control:** Increase/decrease force required to cause the chair to tilt.
- **Tilt-Lock:** Locks seat/back in any position from horizontal to furthest incline; infinite or set lock positions.
- **Pneumatic Seat Height Adjustment:** Lever or button by which the seat height is adjusted to accommodate different leg lengths.
- **Arm Height Adjustment:** Raises/lowers armrests to keep forearms supported.
- **Arm Width Adjustment:** Moves/pivots armrests side-to-side to keep forearms supported.
