WARRANTIES: Seller warrants that the material furnished here under is of the grade, size, configuration and properties ordered by Buyer and Seller makes no other warranty either expressed or implied. FREIGHT DAMAGE, CLAIMS, RETURNS & RE-STOCKING FEE: Buyer agrees to check material received against shipping papers "immediately" upon delivery at destination. Freight damage must be reported to carrier on delivery paperwork at time of delivery and Reliable Investments LLC needs to be notified within 48 hrs. Most freight carriers will not cover freight damage if it is not noted on paperwork at time of delivery. All Buyers' claims must be reported to Seller within 10 days after Buyer's receipt of material. Claims will not be honored, unless Seller is given ample opportunity to investigate such claims. All returns or exchange must be done within 30 days after delivery. Any return or exchange request done beyond 30 days after delivery will not be honored. All returns or exchange requires a
