**Section 1.0 – Site Visits:**

**Section 2.0 – Scope:**

We extend this bid to supply Restroom wall partitions, hardware, and delivery, For the 3<sup>rd</sup> and 4<sup>th</sup> floor men and women's restrooms, 4 restrooms total. A total of 12 toilet partitions and 2 urinal partitions.

**Section 3.0 – Quantities/Inspection:**

Bidders must inspect the site and perform their own measurements in order to determine the proper quantity of materials and hardware required to complete this project. All measurements given in these specifications are informational only.

**Section 4.0 Submittals:**

All submitted materials shall be equal to or greater than owner specified.

If bidder intends to provide materials other than what is specified in Section 3.0 and 4.0 bidder must include with their bid submittal all literature indicating the submitted equipment and materials are greater than or equal to the owner specifications.

Submittals shall include but not limited to the following information:

- Manufacturer
- Manufacture specifications
- Product data sheets

Failure to provide the requested information with the bid will result in the bid being deemed non-responsive.

**Section 5.0 –Specifications:**

- All materials shall be bidder supplied new.
- All materials shall be as specified or owner reviewed and approved equal.
- Bidder shall be responsible for all shipping, crating, and delivery cost.
- All materials shall be delivered to the Jefferson Parish Department of General Services at 1221 Elmwood Park Blvd. Harahan La. 70123
- Packaging shall not exceed the limitations of a small forklift rated at 1900 lbs. of lift capacity for ease of offloading.

- All measurement given in Attachment “A” are for reference use only.

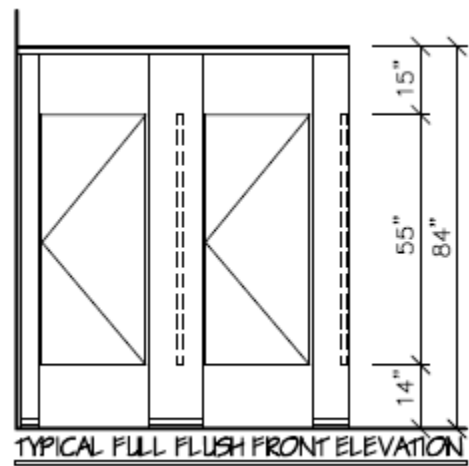
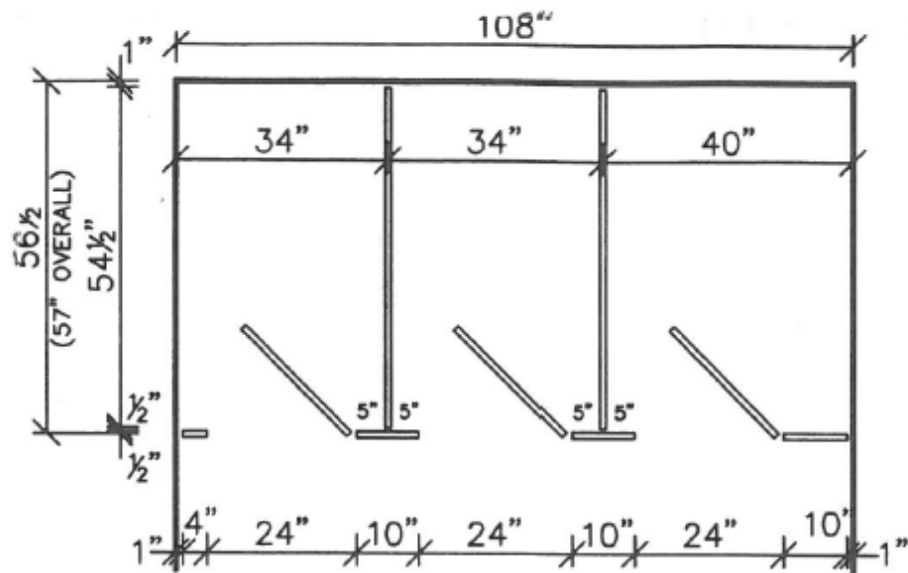
**5.1 Partitions and Hardware:**

- Use BL00 Black for the HDPE solid plastic color.
- Toilet compartments shall be Type SP-FF full flush.
- Stiles, panels and doors shall be Class B fire rated high density poly-ethylene (HDPE) resins.
- Partitions shall be fabricated from polymer resins, compounded under high pressure, forming a single component section which is waterproof, non-absorbent and has a self-lubricating surface that resists markings from pens, pencils, markers, and other writing instruments.
- Stiles, panels and doors shall be made of high density poly-ethylene to a correct dimension producing a stile panel, and door unit of not less than 1 inch thick.
- Doors and panels are to be 55” high. Full flush stiles will be 84” tall with headrail.
- All brackets shall be aluminum stirrup brackets except continuous aluminum brackets for urinal screens.
- All brackets adjustable to keep panels and stiles clear of walls.
- Stile cover bases shall be 4 inches high 18 ga. of No. 304 stainless steel.
- Doors shall be equipped with heavy duty 8” aluminum wrap around hinge sets (2 per standard and 3 per handicap).
- Slide latch, combination bumper keepers and coat hooks shall be anodized aluminum.
- All door hardware shall be through bolted.
- Theft proof screws and fasteners shall be provided for all hardware.

**Section 5.0 – Warranty:**

A minimum of one (1) year warranty against defects in material and hardware. HDPE solid plastic will also carry an extended warranty of 15 years against breakage, delamination, and corrosion).


