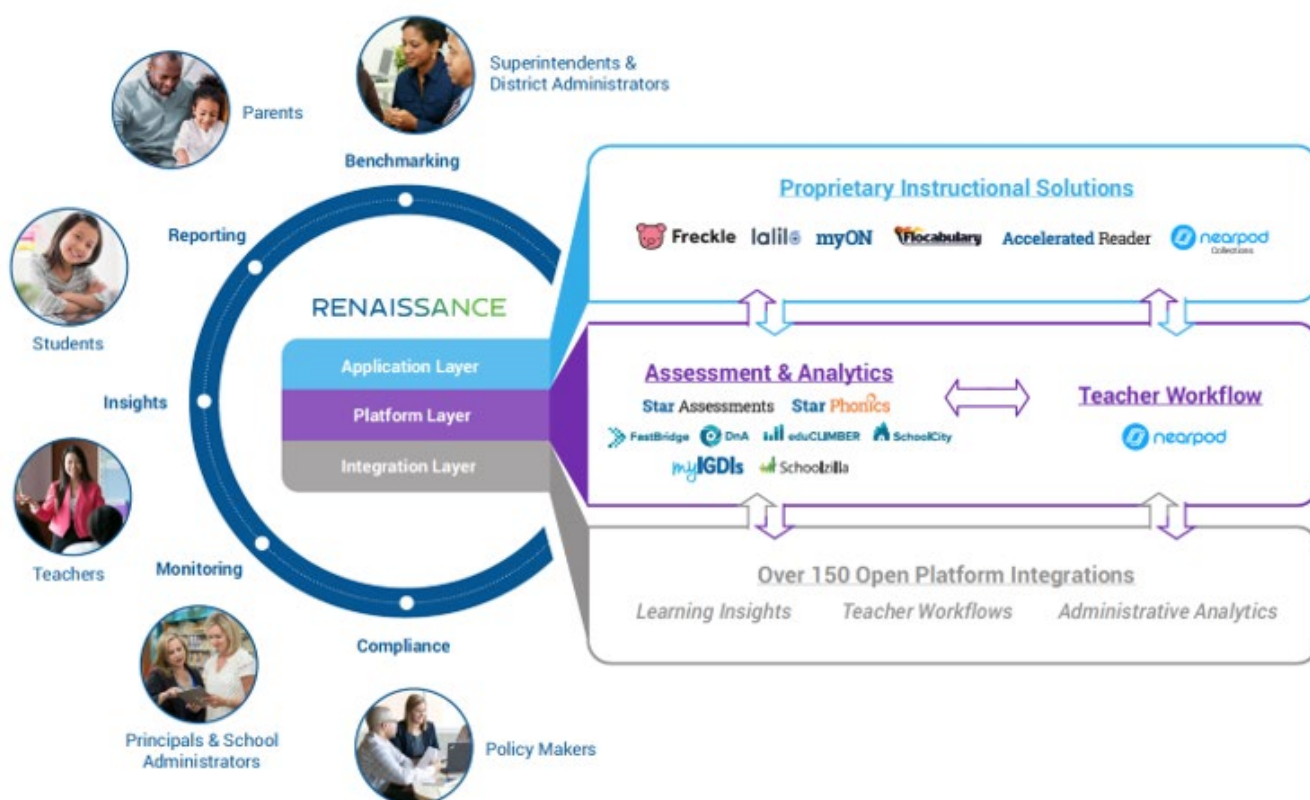

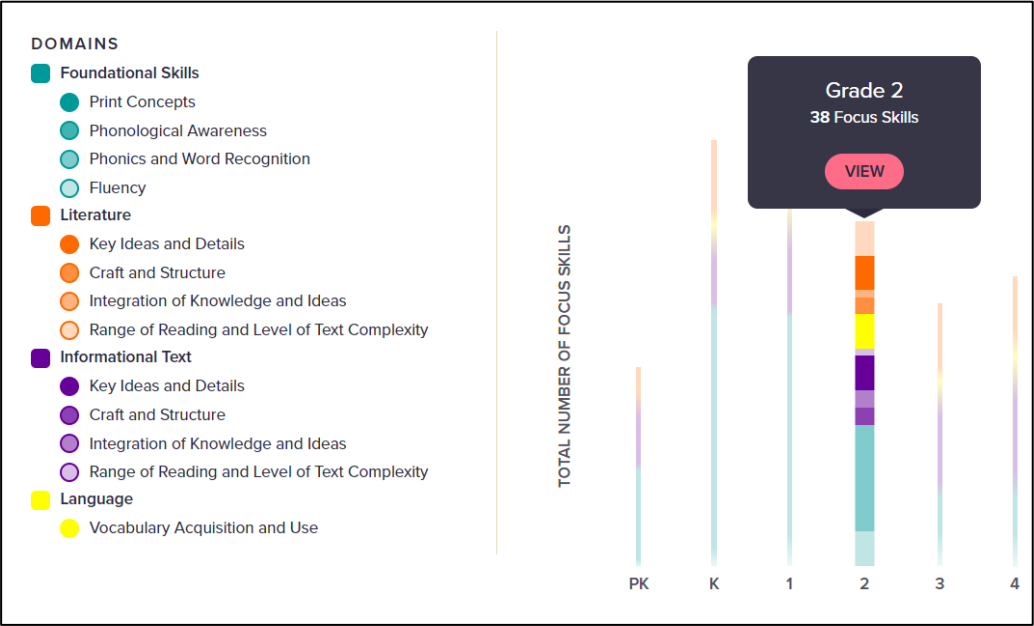

# Service specifications and provisions

## *1. Assesses as a screening instrument for Prek-8th grades for Reading and Math*

### **Universal screening for reading and math**

The Star 360 assessment suite provides screening assessments in reading and math for grades Pre-K–12.

The Star 360 suite of assessments will equip JCSD educators with the right universal screening tools at the right time in both reading and math. The Star 360 assessments provide an effective blend of curriculum-based measures (CBMs) and computer-adaptive tests (CATs) on one streamlined, state-of-the-art platform.

The computer-adaptive Star 360 tests support screening and general progress monitoring by concentrating content at a student's current performance level—regardless of if it is at, above, or below grade level. Curriculum-based measures and formative assessments help educators monitor progress on specific skills key to development in reading and math. The assessment components in Star 360 are:

- **Star Early Literacy** tests a child's understanding of word knowledge and skills, comprehension, meaning, and numbers and operations. This computer-adaptive test is normed for grades pre-K–3.
- **Star Reading** measures a student's understanding of vocabulary, ability to comprehend texts, and ability to analyze, understand, and evaluate literary and informational texts. This computer-adaptive test is normed for grades K–12.
- **Star Math** assesses a student's grasp of concepts including numbers and operations, algebraic thinking, geometry, measurement, data analysis, statistics, and probability. This computer-adaptive test is normed for grades K–12.
- **Star CBM Reading and Star CBM Math** allow teachers to screen and monitor progress of students' development of crucial reading (K–6) and math (K–3) skills through curriculum-based measures (CBMs). Literacy measures include letter naming, letter sounds, phoneme segmentation, receptive and expressive nonsense words, sight and high-frequency words, passage oral reading, encoding, and rapid automatic naming, all of which relate directly to the latest research in early literacy assessment as well as dyslexia screening. Math measures include numeral recognition, quantity comparison, and addition, subtraction, and multiplication facts.
- **Star Spanish** includes Star Early Literacy Spanish (K–3), Star Reading Spanish (K–12), Star Math Spanish (K–12), and Star CBM Lectura (K–6). The content of the assessments is written authentically in Spanish and follows a rigorous review process by our Spanish-speaking editorial team in Mexico City and in the US.
- **Star Custom** is a K–12 formative assessment platform that includes pre-written reading and math skill probes to affirm students' skills mastery; reading, math, and science items; additionally, test-creation tools allow teachers to efficiently build and administer quizzes or tests for any content area.



The Star 360 assessments are more than reliable and valid tests with industry-leading technology. The Star 360 assessments help facilitate the conversation between JCSD teachers and students; parents and classrooms; and students and parents. With Renaissance delivering the Star assessments to JCSD, the implementation will be streamlined and efficient.

## **Deliver key assessment data through universal screening**

The Star computer-adaptive assessments can be used for universal screening purposes, generally three times per year (fall [Beginning of Year/BOY], winter [Middle of Year/MOY], and spring [End of Year/EOY]) and allow for districts and schools to create up to five of their own screening windows.

Universal screening, during which the assessments are administered to every student, helps educators plan and deliver the most appropriate instruction by giving them reliable data and information about each student. For example, assessments help teachers determine whether students are working on grade level, as well as how they are performing in relation to school or district benchmarks and cut scores. The reports have been designed so that it is easy for teachers to use them to set priorities for instruction and intervention.

Star computer-adaptive test reports use benchmarks to identify achievement against target levels of proficiency. There are three types of customizable benchmarks within the Star computer-adaptive assessments:

- School benchmarks are targets that apply to every student in a school (each grade has its own benchmarks).
- District benchmarks are targets that apply to every student in a school district.
- A Mississippi benchmark correlates Star test scores to the Mississippi state standards.

Scores are reported on the Star Unified Scale—which has the desirable measurement properties of a Rasch score scale—range from 0–1400. A student’s scaled score corresponds to the skills a student likely has mastered, still needs to practice, and is ready to learn based upon Renaissance’s learning progressions for reading and math.

The Screening Report (pictured below) provides a graph that shows the distribution of students above and below a benchmark performance level. The report also indicates which students fall into each performance level, together with their test scores. The report can also be customized to compare student groups.

## **Comprehensive phonics screener**

The Phonics Screener in Star Phonics covers 12 of the most critical phonics categories. Class-level data (see below for an example report) shows performance patterns across all students so teachers can plan for instruction at the whole-class, group, and individual levels to support all learners.

**Screener Report: Classroom Matrix.** Classroom teachers appreciate the ability to quickly see where instruction should be focused.

*If an already taught phonics category has a class mastery percentage below 60 percent, the screener indicates that the skill should be taught whole class again.*

*Teachers can quickly see which phonics categories should be taught in small group and which students should be placed in the group.*

*Students who will need individualized help, and may need to be administered diagnostic assessments, are easily identified.*

## 2. Assesses in a computer adaptive platform

The Star Early Literacy, Star Early Literacy Spanish, Star Reading, Star Reading Spanish, Star Math, and Star Math Spanish computer-adaptive tests (CATs) measure students' literacy and math skills in brief and efficient assessments. The software provides valuable, reliable, and valid information for teachers, based on the Star CATs' adaptive format that adjusts to each student's responses, closely matching their achievement levels. With the computer-adaptive model, teachers gain reliable and valid data in a shorter amount of time, valuing data and information alongside efficiency.

Star CAT items adjust in difficulty based on student performance and are not bound to the students' grade level. If appropriate, students will be given test items from lower grade levels to match their needs and determine which skills they have acquired, and which skills are deficient. Additionally, students will also be given test items from higher grade levels to match their needs if appropriate.

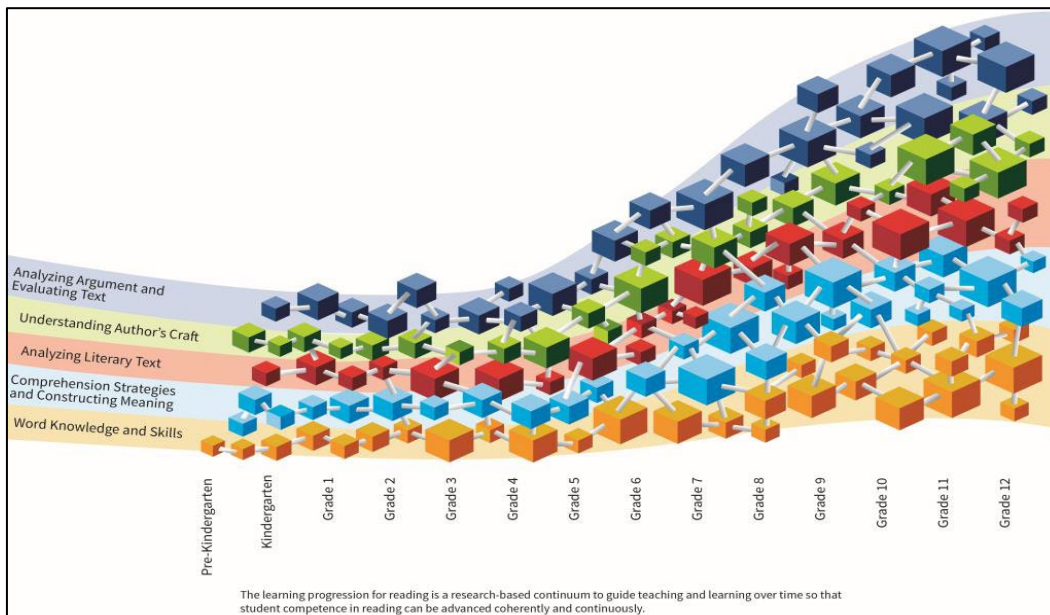
One of the fundamental Star CAT design decisions involved the choice of how to administer the test. The primary advantage of using computer software to administer Star CATs is the ability to tailor each student's

test based on their responses to previous items. Conventional assessments, including paper-and-pencil tests, typically entail fixed test forms: every student must respond to the same items in the same sequence. Using computer-adaptive procedures, it is possible for students to test items that appropriately match their current level of proficiency.

The item selection procedures, termed Adaptive Branching, effectively customize the test for each student's achievement level. Adaptive Branching offers significant advantages in terms of test reliability, testing time, and student motivation. Reliability improves over fixed-form tests because the test difficulty is adjusted to individual performance levels; students do not have to fit a "one test fits all" model.

Most of the test items that students respond to are at levels of difficulty that closely match their achievement level. This means that testing time decreases. Unlike in paper-and-pencil tests, there is no need to expose every student to a broad range of material—portions of which are inappropriate because they are either too easy for high achievers or too difficult for those with low current levels of performance. Finally, student motivation improves simply because of these advantages—test time is minimized, and test content is neither too difficult nor too easy.

*Learning Progression with sample domains.*

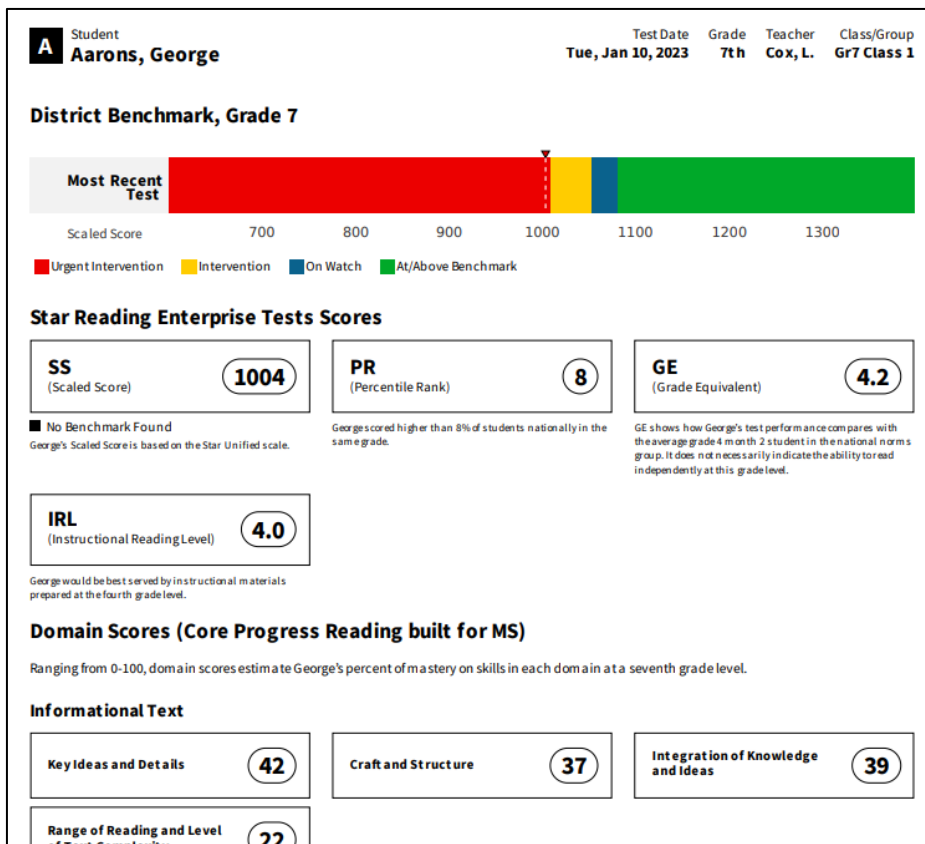


### 3. Provides diagnostic measures

## Access diagnostic information on student performance from your universal screening tool

Because educators can administer Star 360 assessments throughout the year, the results provide in-depth diagnostic information on students' strengths, weaknesses, and needs for intervention. Immediately after students test, teachers can access diagnostic information through the Diagnostic Report (pictured below). Star data gives teachers the information they need to identify strengths and weaknesses in a student's overall math achievement. The lower section provides domain scores, aligned to the MS CCRS, which estimate the student's percentage of mastery of skills in each of the math domains for the student's grade level.

*Assess at a glance.* The Student Diagnostic Report details multiple key test and domain scores for each student.



## Dive deeper into skills areas

Once universal screening is complete, teachers may want additional details on student mastery within domains such as "Which short vowels are my students struggling with?" or "What is the specific misconception blocking their understanding of multiplying fractions?". Star Phonics and DnA provide educators with the ability to assess skills at the most granular level to further diagnose student needs.

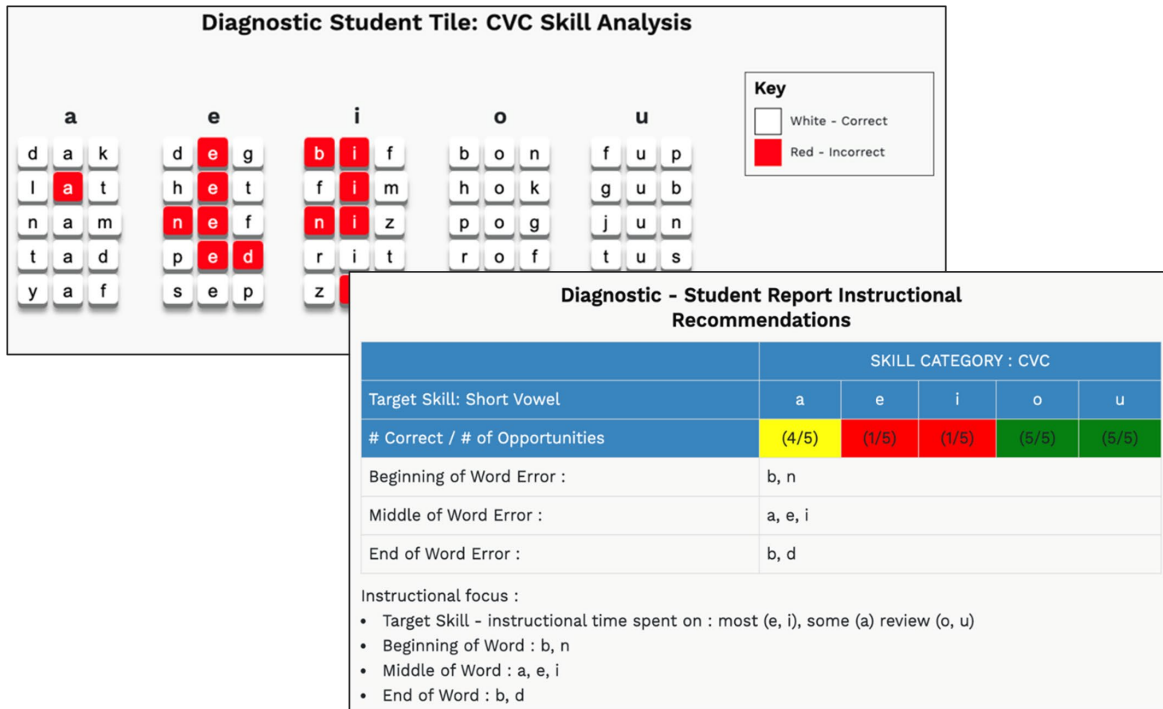


## Diagnose specific areas of need in phonics.

Educators use the results from the Phonics Screener to select which diagnostic assessments to administer to a student. Diagnostic assessments test for each of the 12 critical phonics categories. Error-level reporting (see below) shows which phonic skills and categories need extra attention, so teachers know where to intervene. Other reports, such as Instructional Recommendations, give information on where to focus instruction next.

Star Phonics is designed to provide information not only to understand *who* needs help but also to identify *what* to teach.

**Star Phonics diagnostic reports.** A robust set of diagnostic report options allow educators to drill down to the specific errors that students are making and access recommendations on what to teach next.



## Dive deeper with formative and custom assessments

Differentiation is critical to an MTSS framework. To effectively differentiate, DnA can be used as a formative assessment for targeted instruction. This data can be used to see what the students learned and where there are gaps in skills. When teachers use this data to make changes to their Tier 1 instruction, this data is useful for progress monitoring. When a large percentage of students in a class are below grade-level standards, the implementation of classwide interventions is the most efficient way to ensure that all students receive needed assistance. DnA can be used to progress monitor learning targets for this purpose.

DnA is a K–12 standards-based assessment creation and administration platform providing instant scoring, formative feedback, and interactive reporting. 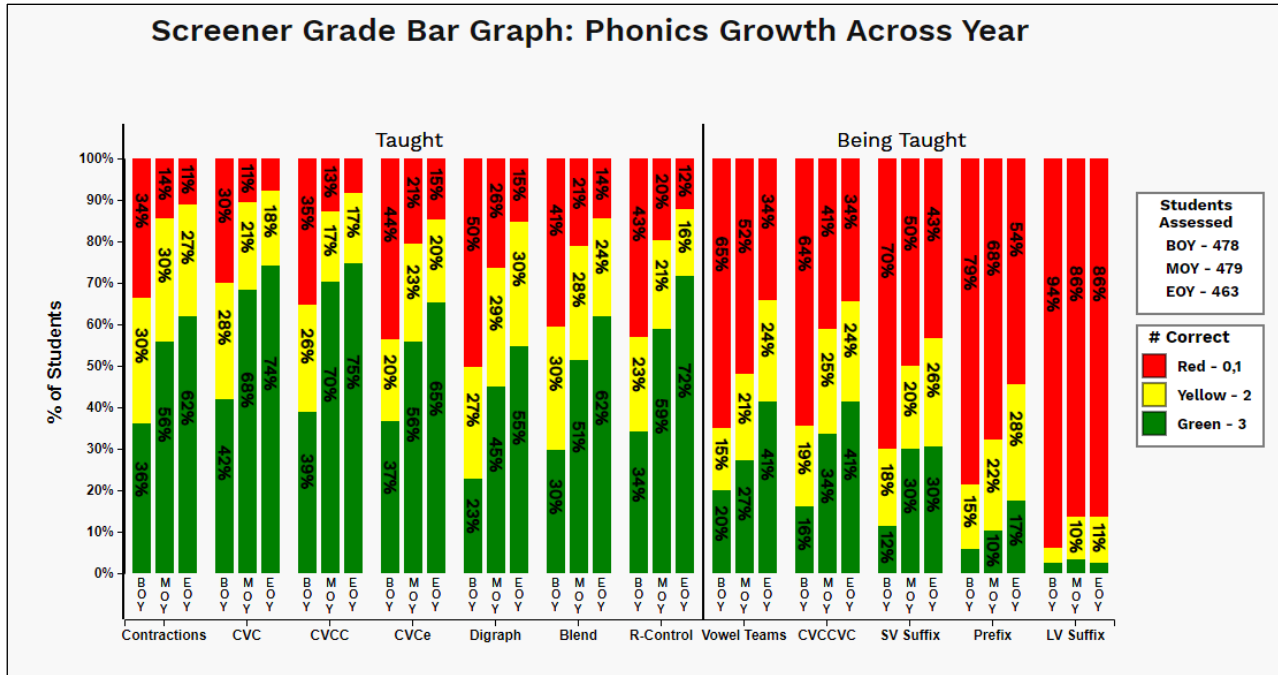

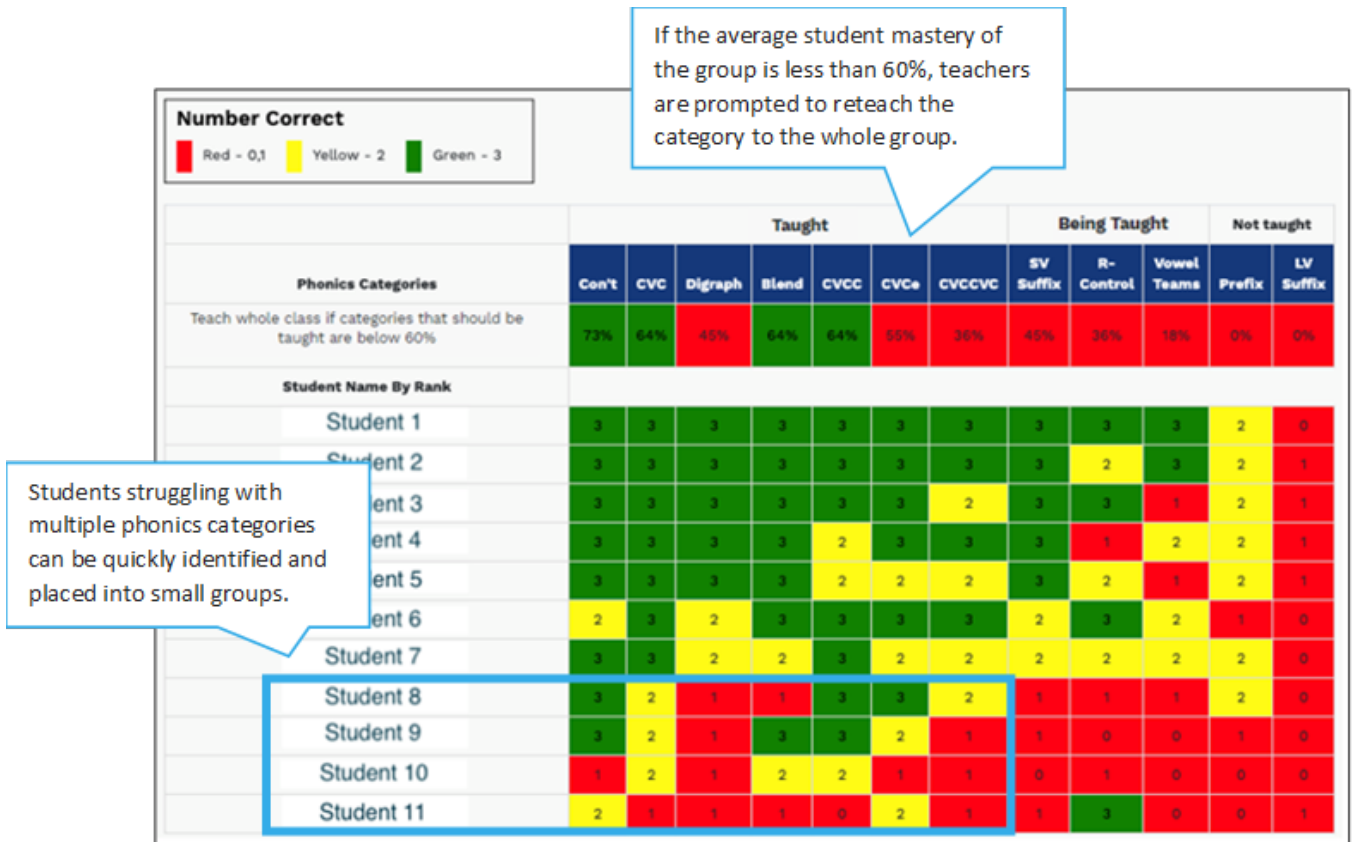

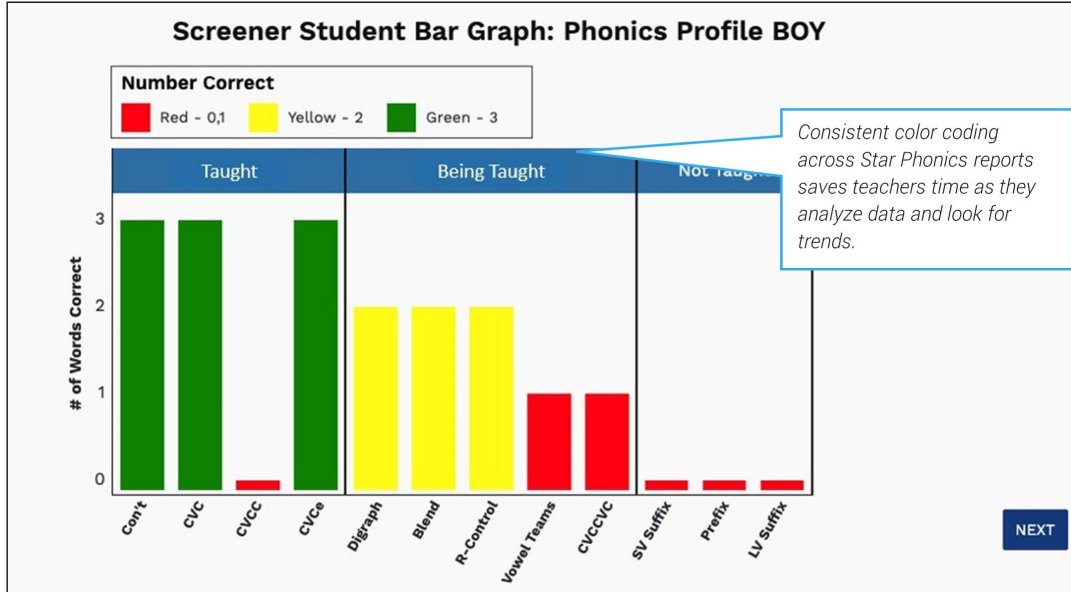

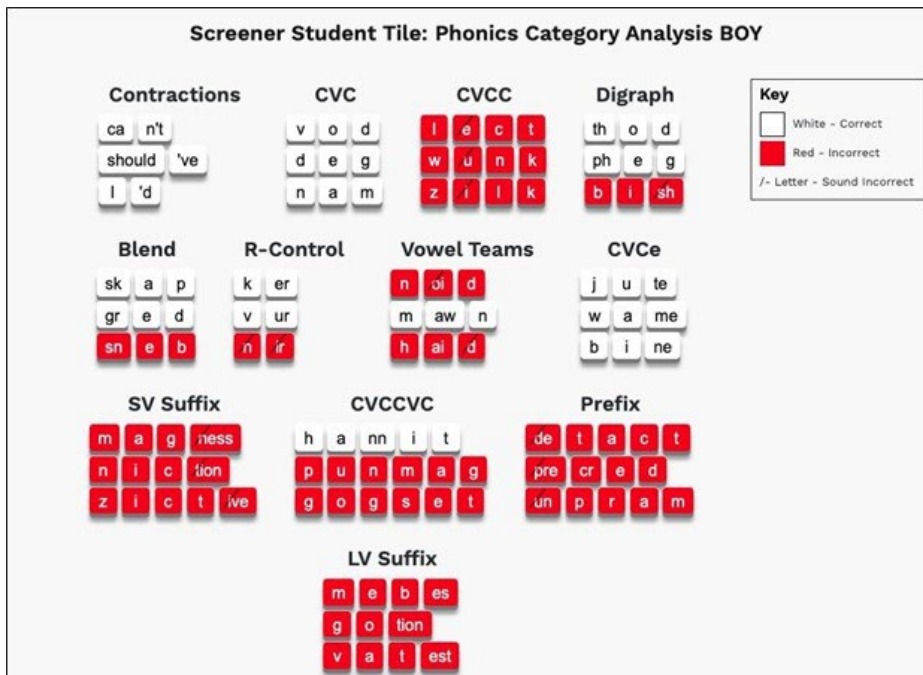

This report helps teachers determine which students should be grouped together for phonics interventions. Students from multiple grades can be included so that reading specialists can view the results of any student with whom they work in a single report.

### Individual student reports

The Diagnostic Student Tile report offers a phonics target skill analysis. The assessment results for each diagnostic are separated out into target skills so teachers can see which specific skills, such as the /e/ and /i/ sounds within the CVC phonics category, the student is struggling with.

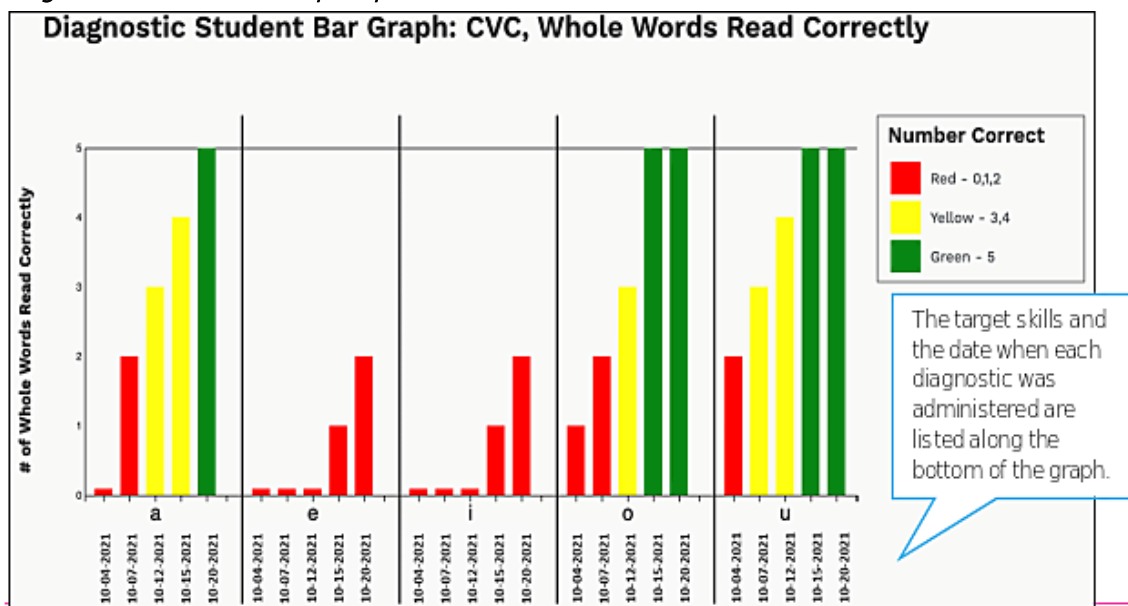

Once interventions are in place, the Diagnostic Student Bar Graph report helps educators monitor a student's progress—not just on the assessed category in general but on the target skills within each category. It shows the number of whole words read correctly, regardless of where an error in the word may have occurred.

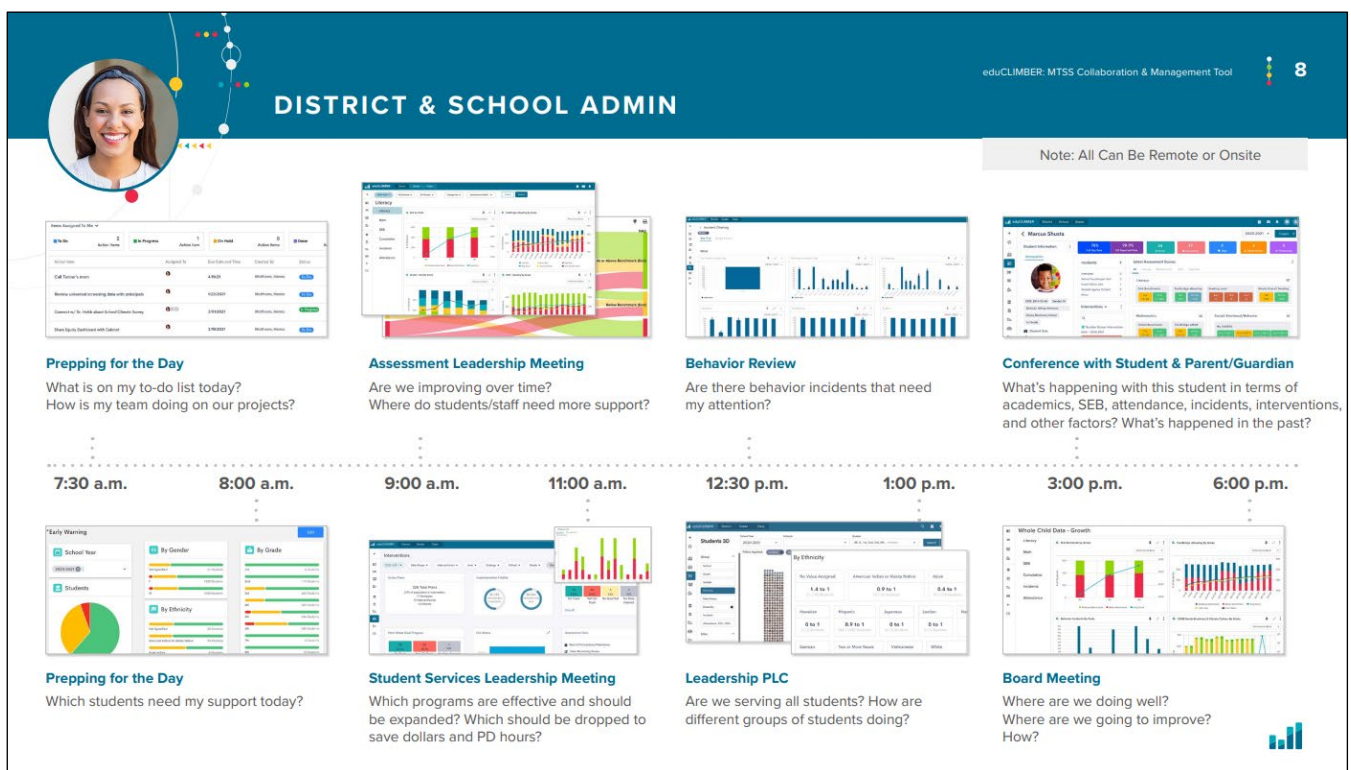

## 5. Provides supplemental software enhancements to drive student instruction

As noted previously, the Star assessments can inform placement into our differentiated practice solutions. Components of the Star suite are used to provide placement in the following ways:

- Accelerated Reader determines a student's reading level via Star Reading test scores.
- Freckle uses Star Reading and/or Star Math assessment scores to automatically place students at the correct level of adaptive practice.
- Lalilo uses assessment data to place students into the learning path. When students log in for the first time, they will begin with a placement test at their grade level. When Star Early Literacy scores are present, Lalilo can use those scores to pre-place students into the precision placement test, instead of

starting them on their assigned grade level. This minimizes any student frustration by beginning the placement test on a level that is never too easy or too difficult. The Lalilo precision placement provides granular skill data so Lalilo can build out their unique learning progression. Lalilo then places students at a starting lesson that is appropriate for their skill level.

- A student's results on either a Star Early Literacy or Star Reading assessment will provide direct placement into myON.

Additionally, Star is built on learning progressions that are tied to skills and resources that support them. Our response to *Requirement 6* immediately following details how placement on the progression and recommended skills and resources works.

eduCLIMBER acts as another tool to drive instruction by identifying areas of concern that affect students' academic achievement and notifying educators in real time so they can provide additional support.

Creating thresholds is a simple process.

JCSD administrators will initially define their desired indicators and threshold levels. Thresholds can be set up for metrics such as test scores, grades, chronic absence, and more.

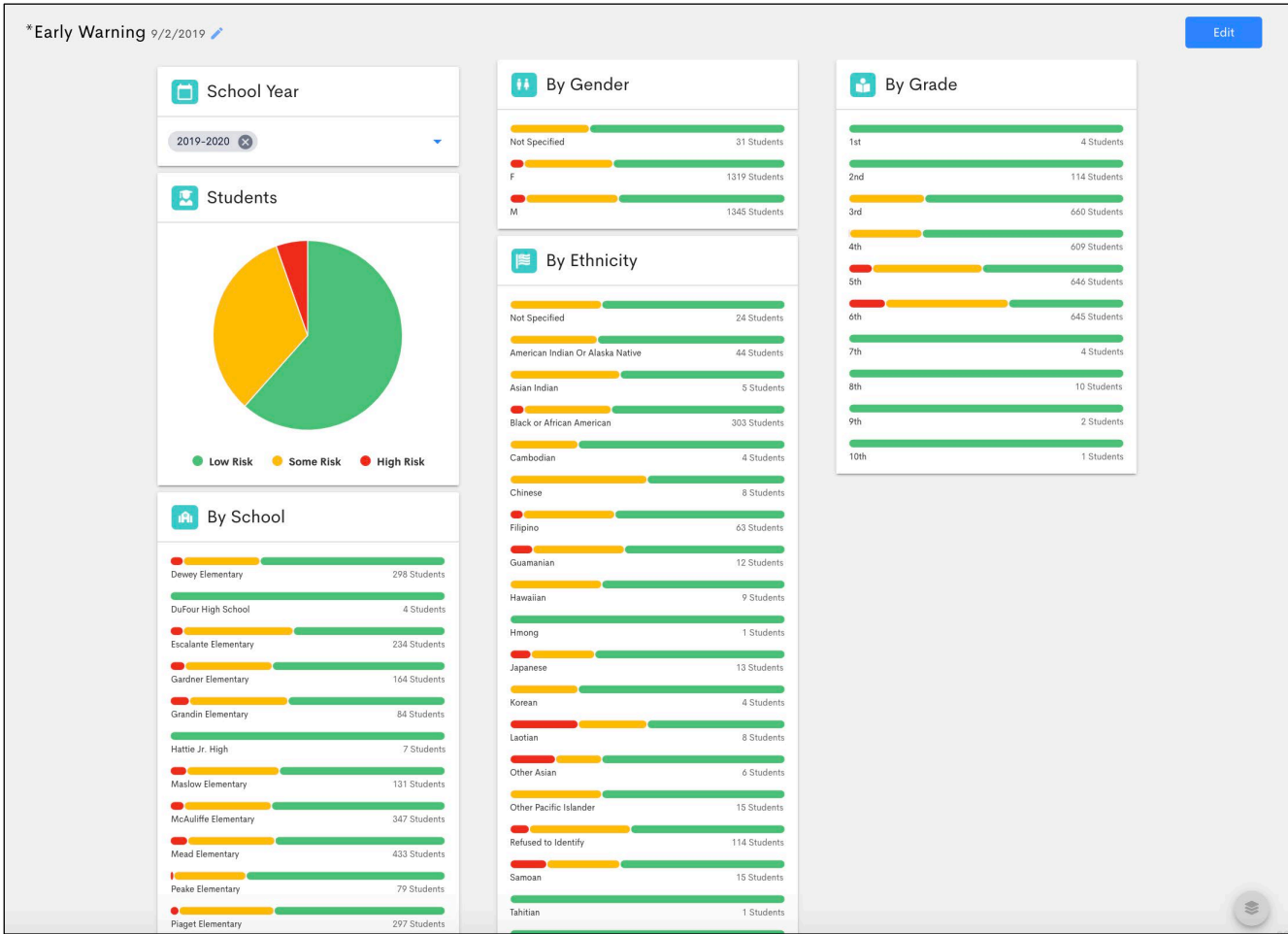

### Instructional resources aligned to MS CCRS

The Star Instructional Planner also includes tens of thousands of instructional resources that teachers can use to provide individual students, groups, or an entire class with additional skills-based practice. These resources are online and assignable to the student on their homepage for practice and printable. They include teacher instructional lesson plans, created by Renaissance, as well as instructional lesson plans that are online and printable. This large bank of resources provides educators with a single place to easily search for a large range of resources that are aligned to the exact skills they need for their lessons.

The Planner and the Star Record Book are the venues for accessing and navigating the MS learning progression. Each tool highlights prerequisite skill mapping and provides a skill elements table for each Focus Skill that identifies vocabulary, conceptual knowledge, and linguistic competencies needed to understand the skill, along with suggestions for supporting English language learners. Learning progressions inform instruction within Star assessments. These tools bridge assessment and instruction by using a Star scaled score to suggest skills to focus on to advance from one level of understanding to the next. These suggested skills can also be viewed using the Instructional Planning reports.

Once a student is plotted on the MS Learning Progression, JCSD educators can plan instructional resources to provide the right instruction and practice at the right time.

The Planner included in Star assessments provides access to the learning progression for reading and key features help clarify the continuum of skills, display connections of skills to strategies and behaviors, and support the development of reading. These key features are described below.

- **Grade-level domain statements.** Each domain has a grade-level domain statement for each area within the domain, from kindergarten through grade 12, describing the desired level of student understanding by the end of the year.
- **Imperative skill statements.** A skill statement describes a discrete academic expectation. Skill statements, which encompass the expectation of a student's knowledge and define learning outcomes, represent the skills inherent in each standard from kindergarten through grade 12.
- **Focus Skills®.** Focus Skills are the most critical reading skills for a student to learn at a grade level. The Renaissance reading and math learning progressions identify the Focus Skills for MS. These key building blocks are non-negotiable skills. Students need proficiency with Focus Skills to be successful in reading and math at their grade levels and to progress in the grades that follow. We will further detail Focus Skills in subsequent pages.
- **Prerequisite skills.** Prerequisite skills are references to skills in the learning progression upon which subsequent skills are dependent. An example will follow.
  - Requisite: Explain how characters' motives and actions contribute to the sequence of events.
  - Prerequisite: Describe characters including their traits, motives, and feelings.
- **Skill information cards.** These cards include instructional information about the skills to support the teacher during skill selection and instruction preparation. Examples of information include standards information, skill area, prerequisites, and English language learner support.

## Differentiate practice and instruction with Lalilo

Once teachers have delivered direct instruction, students need differentiated practice. Delivering differentiated practice is simple with Lalilo. Driven by adaptive learning algorithms, Lalilo removes the need for teachers to spend hours sifting through resources to find just right lessons. The algorithms detect a student's strengths and areas of need in real time to provide personalized, adapted content that reflects a child's unique learning pathway.

## Personalize instruction and practice with Freckle

Freckle balances the needs for student agency and teacher-paced learning. With Freckle for ELA and Freckle for Math students can work independently at their level or on assigned work, which teachers can integrate from lessons or assign specific practice to embed concepts. Freckle Social Studies and Freckle Science include additional literacy-based units of study.

Freckle has a fully developed adaptable pathway for math and English language arts that adapts up as students answer problems correctly and adapts down when students answer problems incorrectly. This pathway adapts the entire span of when a standard is first taught to when the standard is expected to be mastered. This means that regardless of student proficiency, each student will be provided a skills entry point.

Freckle for Math delivers adaptive math practice (K–8), high school math practice (algebra I, geometry, and algebra II) targeted math skills practice (K–12), math fact practice (K–9), number facts (K–2), and inquiry-based lessons. All K–8 math questions are available in both English and Spanish. Pretests place students at the right levels of practice in each domain or, to save time, Star Math assessment scores place students automatically.

Picking up where Lalilo leaves off for foundational skills instruction, Word Study in Freckle for ELA offers K–12 students a systematic approach to word recognition instruction via phonics, vocabulary, and spelling instruction. Freckle for ELA provides adaptive skills practice for students in grades 1–8; adaptive fiction and nonfiction reading practice for grades K–12; adaptive word study practice for grades K–12; decodable books for grades K–2; and sight words practice for grades K–2. Pretests place students at the right levels of practice in each domain or Star Reading assessment scores integrate to place students automatically.

The Freckle for ELA library offers access to more than 800 nonfiction texts written at five or more reading levels. Genres include biographies, careers, food, personal interest, science, social studies, and technology.

More than 300 fiction texts are offered at three reading levels. Genres include fables, historical fiction, fantasy, realistic fiction, mystery, and science fiction. Students may choose from the different genres in each category or be assigned text to read as part of teacher assignments.

Freckle Social Studies—available as a bundle with Freckle for ELA—consists of 26 literacy-focused social studies domains with units built around a curated list of included nonfiction texts, each of which is differentiated for at least five reading levels. Each domain includes primary sources, discussion questions, and interactive maps and timelines to pair with the texts, along with engaging activities that span diverse mediums: simulations and role-plays, gallery walks, Socratic Seminars, video clips, diary entries, and literature connections.

The Freckle Science program includes literacy-focused science units for grades K–8 that are built around a curated list of Freckle articles, each available at various reading levels. Interspersed throughout each unit are engaging explorations that span diverse mediums including experiments, gallery walks, video clips, and simulations. In each unit, teachers will also find material lists, important vocabulary, science journal prompts, and much more. Freckle Science includes a reading pretest to determine the student’s ideal differentiated reading level for articles.

A robust set of easy-to-use reports quickly lets teachers see how students are performing across standards and skills within Freckle. With that information in hand, teachers can issue assignments on specific standards and monitor student progress toward completion, accuracy, and growth.

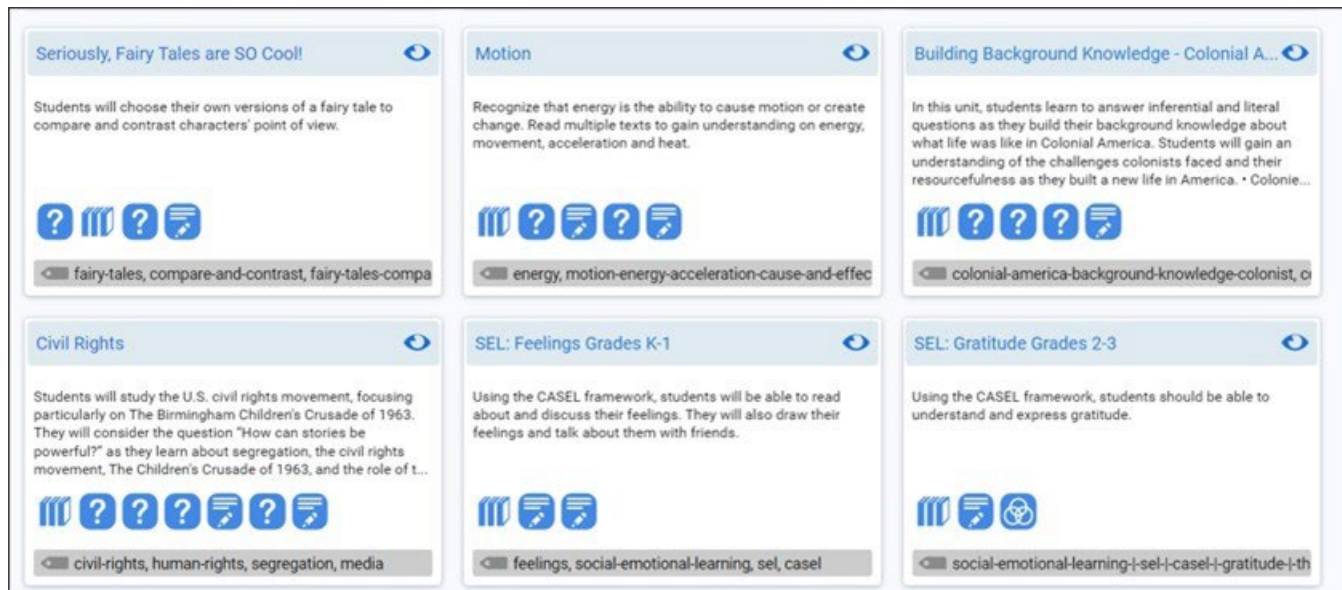
## **Create teacher-led lessons, assign students, and monitor assignment status with myON**

myON’s writing tools make it possible for students to respond to the text and complete projects that have been created and assigned by educators, right from their dashboards. Educators can create assignments, complete with writing checklists, that direct students to write essays and integrate items that may include their reading journal entries. Educators have the option to allow students to review each other’s work and review comments provided by their peers. This exchange provides a dynamic, interactive way of building language skills.

Within the educator resources, teachers can access a variety of lesson plans that incorporate mini-lessons and guided practice activities. Using the Projects tool, teachers can access projects that have been created by other educators or create a new project. Teachers can create a reading assignment by searching the library or provide guidelines for students to allow them to select books or articles to support the assignment. Writing tools in the myON platform include:

- Essay writer—helps students build upon authentic literature and targeted reading practice by allowing them to work seamlessly between instructions, graphic organizers, their notes from the text and the writing platform. Students can easily move in and out of the text, respond to the text, and monitor their work, down to word count, for their entries.
- Checklist—set by educators to show students how their work will be evaluated.
- Peer reviews—allow students to see and comment on each other’s work, providing an additional source of review for group projects. This is an optional setting within the student essay section.

## Personalize assignments with the Projects tool

myON's Projects tool enables educators to efficiently create and assign lessons like reading assignments, writing assignments, or reminders to complete assessments. Student progress on assignments can be tracked and educators can provide notes and support to students within the platform. Educators at the class, building, and district levels have access to real-time, actionable data on individual learners, groups, and classes to better inform their teaching, support differentiated instruction and build collaboration.

From the Project dashboard, educators create and assign lessons for a classroom, a group, or an individual. Project tasks can be as simple as assigning one or more books from the myON library for reading. Assignments can also be more complex, like setting guidelines on selecting books for a research project or incorporating graphic organizers in a writing assignment. Teachers can even instruct students to highlight text in a reading and make notes within the platform before completing a writing assignment.


## 7. Provides literature and informational texts online with correlating assessments

### Personalize growth by pinpointing each student's reading ability in myON

myON matches readers with texts that both reflect their reading levels and fuel growth. A student's results on either a Star Early Literacy or Star Reading assessment will provide direct placement into myON. In just 15 minutes of average testing time, these computer-adaptive assessments are fast and efficient measures for screening that provide valid and reliable data about individual student skill levels.

Students can also receive placement within myON through an optional 10-minute placement test within the platform (powered by Star Reading). Because Star Assessments sync automatically with myON, the platform always uses the most current assessment results for connecting students to texts of the appropriate reading level. If a teacher suspects that a student needs to be reassessed and matched with more accurate texts, or if a student requires more frequent progress monitoring—for example, participating in an intervention program—teachers can direct students to complete a Star assessment.

MetaMetrics' Lexile Framework for Reading is a cornerstone of myON's personalized environment. It provides educators at JCSD with a numeric measure of a student's reading ability that is also used to rate the complexity of books. myON ascribes a Lexile measure to all books presented within the platform. The Lexile Framework for Reading is based on more than two decades of research funded by the National Institute of Child Health and Human Development. As students demonstrate improvement, myON presents readers with texts of increasing complexity. This ensures that readers are always reading texts that challenge but do not frustrate. The right level of challenge encourages steady, rewarding growth.

### **myON News**

In addition to the vast selection of titles in myON, myON News delivers five fresh news articles five days a week that are perfect for daily reading practice. Each article is written just for students by a professional journalist and reviewed by a child psychologist prior to publication. Articles are offered in three English-language reading levels, as well as Spanish, French, Mandarin, and Arabic, to support English language learners and students participating in foreign language courses. This online newspaper includes multimedia features and comprehension quizzes and recommends related myON books to inspire additional exploration. Teacher guides are included with each edition to extend learning in the classroom.

Audio is provided for many books and for all news articles. The audio features real speakers modeling fluent reading and allows students to access books they might not be able to read independently—opening teachers' options to provide even more access to background knowledge and vocabulary acquisition.

Through connected texts, articles in multiple languages, and audio supports, myON News provides daily, age-appropriate news articles that enrich content-area classes and bring more opportunities for reading into the school day.

### **Access engaging Lalilo texts through myON**

With Lalilo books added to the myON Core Collection, JCSD educators can take advantage of these additional titles when looking for independent reading material for developing readers (see examples, next page). To access the Lalilo books in myON, teachers and students can search for "Lalilo" to see the full list of titles and begin reading. The majority of the Lalilo books are nonfiction, with a variety of topics including animals, birds, plants, outer space, science, and more. Students can even use myON's recorded read-aloud feature for these books to practice oral reading fluency.





Together, Lalilo and myON empower educators to see every student and drive greater foundational literacy growth for every learner. Teachers or students can select these new Lalilo books for additional opportunities to strengthen foundational reading skills and become independent, confident readers.

## Practice reading comprehension by testing knowledge

Lexile measures, as discussed previously, are widely used in the US and around the world. They can be translated into other reading scales, such as ATOS, a readability scale that drives Renaissance's Accelerated Reader practice program. If educators work to improve literacy with the help of more than one solution, these shared measures provide educators with the insights necessary to gain a consistent and comparable view of performance across solutions.

Accelerated Reader has helped teachers to personalize reading practice for their K–12 students since 1986. Accelerated Reader encourages growth by delivering engaging quizzes and activities to help hone students'

reading skills with authentic practice. The student-driven and teacher-guided Accelerated Reader practice program:

- **Uses authentic text.** Students must be able to read and comprehend authentic text to be prepared for college and careers. With Accelerated Reader, students practice and sharpen their command of these essential literacy skills with fiction and nonfiction books and articles.
- **Empowers teachers.** Teachers can set goals for time spent reading daily, average percent correct on quizzes, points earned, and average book level or average Lexile measure. Teachers use data-rich reports and dashboards to quickly spot literacy skills gaps, track mastery, and guide progress.
- **Personalizes practice.** Students read text that is appropriate for them—at their personal reading level, and about topics that interest them—as they work toward challenging but attainable reading goals. This motivates students and helps them to take ownership of their academic growth.
- **Nurtures growth.** Accelerated Reader transforms decades of data about student learning into rich insights for educators, helping them to engage all students in high-quality reading practice that accelerates reading growth. Accelerated Reader is proven highly effective at raising reading achievement for students of all ability levels—including students in special populations.

In addition to ensuring that students understand the materials they choose to read, Accelerated Reader quizzes capture valuable information about comprehension, literacy, and vocabulary skills growth and gaps. This data helps teachers refine instruction, intervene as needed, and adjust goals to ensure students are reading texts at the right level of challenge and for the right amount of time each day to yield the greatest growth.

Nearly 215,000 quizzes are available for fiction and nonfiction books and brief nonfiction articles. Approximately 12,000 quizzes are available in Spanish to support native Spanish-speaking students as they build their literacy skills and work toward English language literacy. Renaissance continuously adds new Accelerated Reader quizzes to support readers' diverse tastes. These quizzes align with one of three categories:

- **Reading practice quizzes.** After independent, read-aloud, or paired reading, a short Reading Practice Quiz measures comprehension. These quizzes ask literal questions that measure understanding of a text.

- **Vocabulary practice quizzes.** Teachers assign vocabulary practice quizzes to gauge how well students understand the new words they encounter in the context of their independent reading. Detailed reports give teachers feedback to foster further growth.

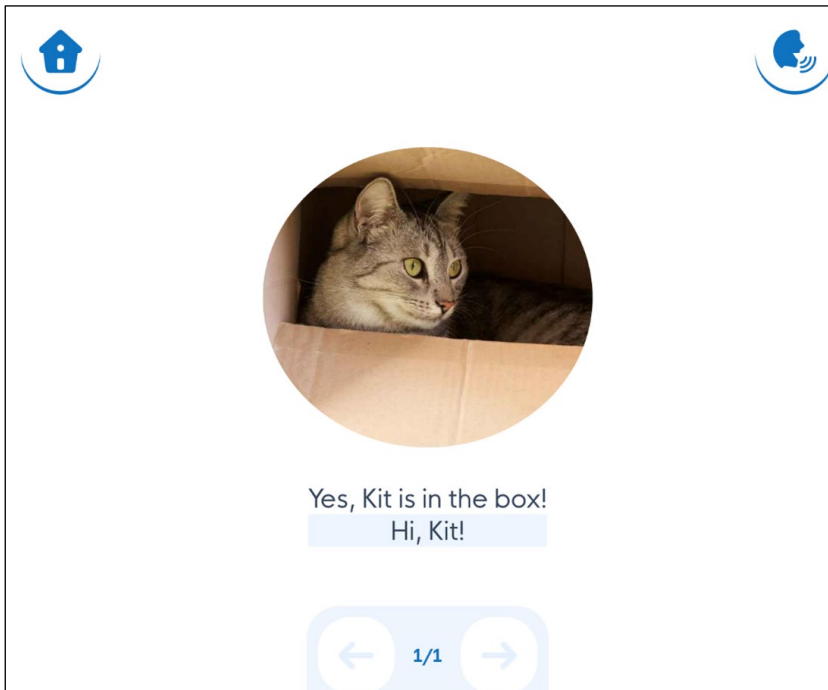

## Additional texts tied directly to comprehension practice in Freckle and Lalilo

In addition to adaptive and assignable foundational skills exercises, Lalilo features comprehension books, including decodables, where students answer questions about what they read or hear. Through these texts, students can practice skills including those such as phonics patterns and sight words.

*Decodables built into Lalilo. Lalilo is a great resource to practice decoding skills and build fluency.*



In grade-level listening comprehension texts, students listen and follow along with a highlighted text as it is read aloud.

In independent reading books, students read the text on their own with supporting features such as clicking on individual words to hear them read aloud. Independent reading books enable students to practice mastered phonics and word recognition skills in an authentic context.

Both types of books are enriched with features that allow students to practice grade-level comprehension strategies through narrated and written texts in a positive and supportive context. Some features they encounter in books are:

- Book introductions and vocabulary presentations that prepare students to read the text and set objectives for reading
- MS CCRS standards-based comprehension questions interspersed throughout the text, allowing students to monitor for understanding as they read or listen with feedback for both correct and incorrect answers
- Topics related to K–2 science and social studies curricula
- Texts and images that reflect diverse cultures, perspectives, and experiences
- Images on every page that support content

Structured around the Science of Reading, Lalilo is a place where students can practice decoding skills, build vocabulary and conceptual knowledge, learn comprehension strategies, and refine thinking and reasoning skills. These activities are critical to developing skill- and knowledge-based literacy competencies.

When students have moved beyond the foundational literacy skills covered by Lalilo, Freckle for ELA continues to support students with more than 1,200+ adaptive and teacher-assigned fiction and nonfiction texts with reading comprehension questions aligned to specific skills.

After taking the Freckle pretest (or being placed by Star Reading when licensed), students have access to powerful, differentiated resources that help them develop strong ELA skills. The ELA skills practice area allows students to practice seven anchor skills under the nonfiction skills practice area and three under the fiction practice area.

Nonfiction skills practice areas include:

- explicit information

What is the text mostly about?

The reading level of the brief passages and the challenge level of the questions continuously adjust to match each student's skill level. When students struggle to answer questions correctly, they'll get the opportunity to review a skill. In the review, students view a brief, instructional video about the skill. Then, they're presented with scaffolded questions that start off basic and get progressively more challenging. This comes in the form of questions that get at the sub-skills that help build up to the broader skill.

For adaptive texts, the student's adaptive level is constantly changing, depending on performance. When assigning articles or stories, educators can preview assigned articles (at multiple reading levels, as applicable) as well as the reading comprehension questions and writing prompts that can be presented to students.

To support comprehension skills, Freckle:

- Delivers scaffolded support to build the sub-skills required to master the targeted comprehension skills.
- Includes adaptive and teacher-assigned practice and support for targeted nonfiction comprehension skills including explicit information, summarizing and main ideas, analyzing connections, word meaning and choice, text structure and development author's intent, claims and evidence.

### ***8. Provides mathematics lessons and assignments to progress at individual student's pace***

Teachers can use the Star Record Book to see which students need additional attention and plan appropriate instruction with Star's linked instructional materials. Instructional recommendations are based on Renaissance's MS Learning Progression for math, which identifies the sequence of math concepts that need to be learned spanning from early numeracy through high-school level algebra and geometry. Through this learning progression, Star will recommend specific skill areas and focus skills for students to practice and receive further instruction on. Star Math links to the Instructional Planner. Based on their scale score, the Instructional Planner recommends next steps for instruction, linking educators to over 100,000 resources to support instruction or plan lessons both digitally and on paper. About 90 percent of skills have a corresponding Nearpod lesson. Additionally, the Instructional Planner can link to lessons in Renaissance practice products such as Lalilo, Accelerated Reader, myON, and Freckle, providing lessons that differentiate instruction to see every student.

### **Personalize the journey with Freckle**

Teachers can differentiate practice and instruction in Freckle for Math, which balances the need for student agency and teacher-paced learning. Students can practice independently at their level or on assigned work, while teachers can integrate lesson opportunities or assign specific practice to embed concepts. Freckle for Math has a fully developed adaptable pathway that adjusts up as students answer problems correctly and down when students answer problems incorrectly.

Freckle for Math offers nearly 70,000 math questions that cover practice for grades K–12 as well as algebra I, geometry, and algebra II practice content. Teachers can assign practice for specific domains, standards, or a combination of both. To monitor students' learning and the effectiveness of their lessons, teachers may administer customizable benchmark assessments. Adaptive practice allows students to independently challenge their math skills in a safe environment, receiving remediation problems if they struggle, and more advanced concepts if they do well. All standards for all grades within the domain are available for teachers to choose from and teachers can view sample questions for a standard.

Available assignment types include:

- **Number facts (K–2).** These assignments introduce arithmetic, helping early learners develop important math skills by focusing on basic operations. This guided program comes complete with audio and an emphasis on visuals and instruction, ensuring younger students are given the support they need to grasp the very basics of math.
- **Adaptive practice (K–8).** Teachers choose the domain in which they want students to work and can send the assignment to their entire class or selected students. Each student's practice session will be personalized so they are answering questions at their level within the chosen domain.

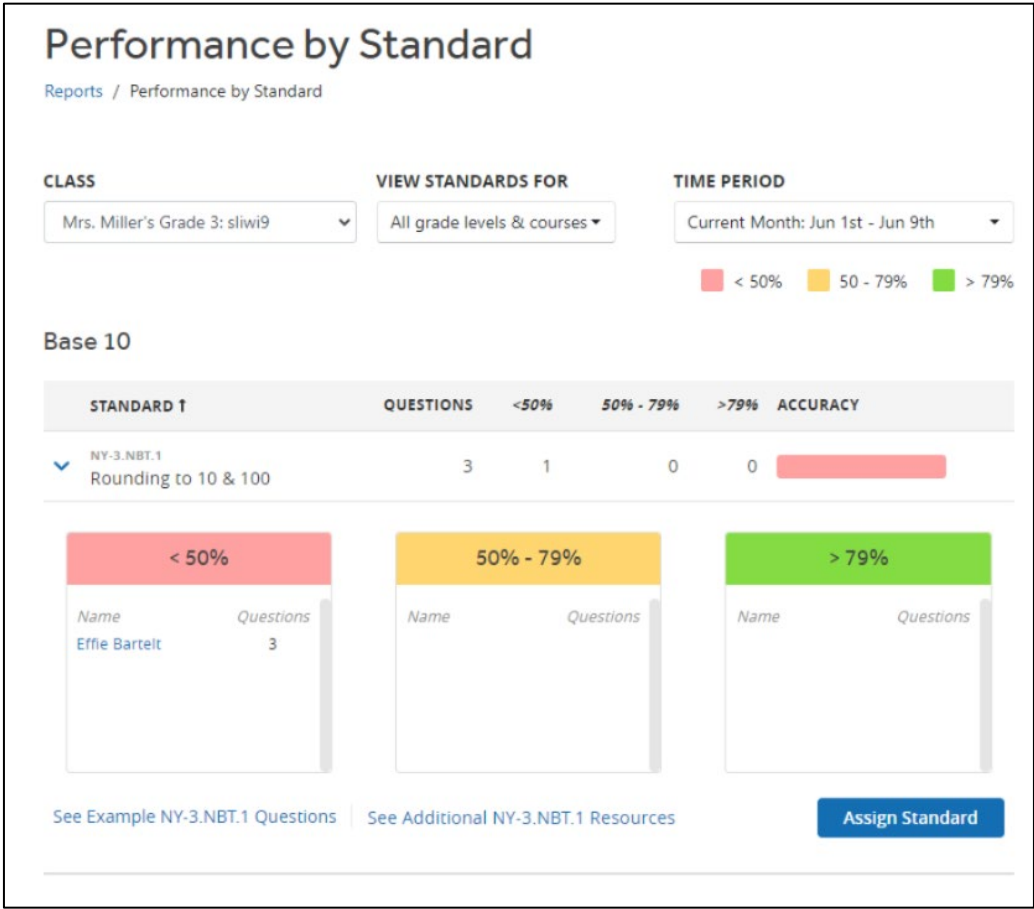
## Reports produce a clear picture of student performance

Freckle for Math provides a variety of reports organized in graphic representations, available in the teacher dashboard in real time as students complete work. ### Reliable data integration

#### Sync your SIS data with your Renaissance centralized website

CDI is Renaissance's Custom Data Integration service, providing a secure and easy way to automate the rostering of Renaissance-hosted applications (Star 360, Accelerated Reader, Freckle, Lalilo, and myON), using data from a district's Student Information System (SIS). This data will automatically populate Renaissance-

hosted applications, saving JCSD time and eliminating the need to duplicate efforts by managing the same information in two separate locations.

OneRoster is included in our CDI service and our product hub, Renaissance Growth Platform, is OneRoster 1.1 certified.

We have over 20 years of Data Integration Experience with our first Data Integration happening in August of 2001. Our Data Integration Specialists average over 10 years working with Renaissance software programs, and will be dedicated to supporting JCSD educators through a four-step implementation process:

- **Project planning.** You will be assigned a dedicated New Setup Coordinator that will work directly with your district. The DnA onboarding data team will work with district technical personnel to setup nightly extracts to pull your Student Information System (SIS) data into the platform. The DnA API can be utilized to extract certain data from DnA to a target source.

Renaissance has implemented SFTP, Clever, and OneRoster for data exchange with our assessment solutions, including DnA, for many clients nationwide.

### **Sync your SIS data with eduCLIMBER**

eduCLIMBER will utilize a data integration to gather comprehensive data, and Renaissance will work with the district's data team to put that in place. The sourced data elements include roster data, but also additional data elements beyond those include in standard OneRoster data integrations. As such, a OneRoster integration with eduCLIMBER would be redundant and unnecessary.

eduCLIMBER provides not just the user interface to understand the data and support various workflows, but also provides the data warehouse to store the data necessary for these insights. This includes the data integration from a wide variety of other platforms the district may be using including Skyward, various assessment systems including Star, and other systems the district may want to integrate data from to provide a comprehensive understanding of students. The integration with Skyward is a fully automated process and updates take place nightly. Information pulled from the SIS is entirely in the JCSD's control. Customers typically pull academics, attendance, and behavior.

Assessment, behavior, and other student data are imported during implementation to ensure the data needed for eduCLIMBER resides in the platform. All data remains within eduCLIMBER for historical reporting. No data is deleted unless requested by the district. As the changes in courses, classes, teachers, or other student-related information occur within the SIS, eduCLIMBER is updated. Errors in the data are diagnosed and corrected immediately.

eduCLIMBER supports additional data uploads with additional district systems. Some uploads are automated while others are accomplished via .csv data file exchange. eduCLIMBER automates data exchange with Star, NWEA, FastBridge, i-Ready, and other vendors that allow automation on their end. This automation adds data from the vendor sites directly into eduCLIMBER. eduCLIMBER currently has over 100 importers that support various datasets. For an additional fee, custom data imports are available to be created as required.

All data imported goes through a validation process—when errors are found, we work with your district support group to assist with cleaning the data. The time required to clean up the data depends on current district data

and its accuracy. All data can be exported on demand if needed to assist with the data clean-up during the onboarding process.



**GENERAL CONDITION:** Any products and associated support and services provided by Renaissance to the Customer shall be exclusively governed by the terms and conditions of Renaissance's then-current Terms of Service and License Agreement(s) with any accompanying schedules and policies applicable to the offering ("Agreement"). Renaissance's Agreement has been drafted specifically for use with Renaissance products and services, and as such, is better suited to operate as the Customer's agreement with Renaissance, rather than relying exclusively on Customer's RFP documents. Renaissance is willing to negotiate modifications and/or additions (either from the RFP or to address any other Customer concerns) to its Agreement and any schedules and policies, in discussion with Customer. Renaissance's current Agreement is attached for your review.

**SPECIFIC CONDITIONS/EXCEPTIONS:** Without in any way limiting the generality of the foregoing, Renaissance's response to the RFP is subject to the following specific conditions and exceptions to RFP provisions, wherever located and/or if a singular term is located in multiple locations and Renaissance only references one location. Again, Renaissance is willing to discuss these conditions and exceptions, as well as any other proposed agreement terms with the Customer.

1. **Page 4, Section 5. Schedule, Paragraph 2:** These services shall be provided to the Jones County School District during the 2023 – 2024 school year. Upon satisfactory evaluation of the provided services, services may be extended by mutual agreement to include services during the 2024-2025 school term.
2. **Page 4, Section 7. Minimum Eligibility Requirement for Contract Award:** Applicants must comply with all applicable licensing and certification requirements specific to the proposed services, be registered through the site of sam.gov., and agree to the terms/agreement and any addendum set forth by the school district's school board attorney. The terms of the RFP alone are not sufficient to reflect the full nature of Contractor's products and services offering. Therefore, Contractor proposes good faith discussion of a final contract with the Terms of Service and License Agreement as a basis, of course along with the RFP documents, upon which the parties can engage in good faith negotiations.
3. **Page 5, Section 11. Special Terms/Conditions - Subject to Appropriation:** Funds for the bid/project are subject to federal/state appropriations and ability of the district's Federal Program's Application to accommodate this expense prior to the start of the Agreement Term.
4. **Page 5, Section 11. Special Terms/Conditions – Termination for Convenience:** In the event the vendor is unable to provide the contracted services and mutually acceptable alternatives cannot be arranged, the contract can be terminated with written notification by either party. The JCSD shall give written notice of the termination to the vendor specifying the part of the contract terminated and when termination becomes effective. The Vendor shall incur no further obligations in connection with the terminated work and on the date set in the notice of termination the vendor will stop work to the extent specified. The vendor must still complete the work not terminated by the notice of termination and incur obligations as are necessary to do so. Customer may terminate contract with ninety (90) days written notice to Contractor. If notice of termination is sent due to Breach, Contractor requests the industry standard 30 days for cure period. If the Customer exercises its right to terminate for Convenience, any such termination will not result in any refund or credit for products and services already delivered, or for the remaining balance of any unused subscription period.

Access may be restricted during Renaissance's maintenance and updating of the Products.
    - ii. **Quantity.** The Quote sets forth a quantity for each identified Product or Service. Customer may not exceed the quantities stated in the Quote without further written agreement by the parties.
    - iii. **Access and Use Restrictions.** Customer shall not access or use the Products for any purpose beyond the limited license granted in these Terms of Service. Without limiting the foregoing, Customer shall not: (A) copy, modify, or create derivative works of the Products, in whole or in part; (B) rent, lease, lend, sell, sublicense, assign, distribute, publish, transfer, or otherwise make available the Products; (C) reverse engineer, disassemble, decompile, decode, adapt, or otherwise attempt to derive or gain access to the source code of the Products, in whole or in part; (D) remove any proprietary notices from the Products; (E) allow anyone other than Customer or its Authorized Users to access or use the Products; (F) use the Products in any manner or for any purpose that infringes, misappropriates, or otherwise violates any Intellectual Property Rights or other right of any Person, or that violates any applicable law; (G) access or use the Products for any purpose not authorized under these Terms of Service; (H) share, transfer or sell Valid Login Information to anyone other than Authorized Users, and shall be responsible for any access to, or use of, the Products resulting from Customer's failure to safeguard Valid Login Information; or (I) allow multiple Persons to access or use the Products in a manner intended to avoid incurring fees.     - vi. **Customer Hardware, Other Software and Services.** Renaissance does not bear any responsibility or liability for any Third-Party Services and does not guarantee that any Third-Party Services will operate correctly or that they are compatible or interoperable with the Products.
3. **Services.** Renaissance shall provide the Services identified in the Quote and any Statement of Work agreed to by the parties in writing. All Services identified in the Quote or any applicable Statement of Work shall be governed by these Terms of Service, including, without limitation, Exhibit B.

4. **Payment Obligations.**

- a. Fees. Customer shall pay Renaissance all amounts listed in the Quote ("Fees") within 30 days of invoice. Customer may not withhold or setoff any amounts due under the Agreement. Renaissance may charge interest from the time payment was due until the time paid at the higher rate of (A) 1% per month compounded monthly, or (B) the highest rate allowed by law in Customer's state. Customer agrees that any of Renaissance's Affiliates may issue invoices for amounts owed under the Agreement. Amounts paid for Products and Services are not refundable, regardless of the extent they are utilized.

Recipient shall treat the Disclosed Information with the same level of care that it holds its own Confidential Information. In addition to disclosure to Recipient Representatives as set forth above, Recipient may disclose Disclosed Information to the extent compelled by law, provided Recipient gives the other party prompt prior written notice of the compelled disclosure to the extent legally permitted to permit the other party to seek a protective order, and if disclosed to a government agency seek confidentiality protection if available under applicable laws and regulations. Recipient acquires no licenses or other rights to the Disclosed Information except as otherwise set forth in the

Agreement. Notwithstanding anything to the contrary above, Customer PII is governed by the Data Protection Addendum and not this Section 7.

8. **Data.**

- a. Customer PII. Renaissance shall comply with its privacy and security obligations for Customer PII as set forth in the Data Protection Addendum.
- b. Data Ownership and License. As between Renaissance and Customer, Customer owns the Customer Data. Customer grants Renaissance a non-exclusive, royalty-free, worldwide license to use the Customer Data throughout the Term to perform under the Agreement and as further described in the Data Protection Addendum. As between Renaissance and Customer, Renaissance owns the Renaissance Data. Renaissance Data is not subject to the use or disclosure restrictions of this Agreement that apply to Customer Data.

Customer shall defend and indemnify Renaissance, its Affiliates, and the directors, officers, shareholders, members employees, agents and representatives of each of the foregoing, against all Claims (including reasonable attorneys' fees) brought against or incurred by Renaissance: (i) alleging that the combination of a Third-Party Service or configuration provided by Customer when used with the Products, infringes or misappropriates a third party's Intellectual Property Rights, or arising from (ii) Customer's use of the Products in an unlawful manner or in violation of the Agreement, (iii) Customer's use of a Third-Party Service (iv) any breach of Customer's obligations under the Agreement; or (v) the negligence or intentional misconduct of Customer or its Authorized Users, employees contractors, agents or representatives.
- c. Indemnification Procedure. As a condition of the defense and indemnification obligations under Section 9.a or 9.b (as applicable), each party agrees to: (i) promptly notify the other in writing of any third-party Claim for which a party seeks defense or indemnification under these Terms of Service; (ii) provide the defending or indemnifying party sole control of the defense of the Claim; (iii) cooperate at the defending or indemnifying party's expense with reasonable requests in support of the defense Claim; and (iv) refrain from agreeing to or acknowledging liability for the Claim.

10. **Warranties and Liabilities.**

- a. WARRANTIES. RENAISSANCE PROVIDES THE PRODUCTS AND SERVICES "AS IS". RENAISSANCE MAKES NO WARRANTY OR OTHER PROMISE THAT THE PRODUCTS WILL BE UNINTERRUPTED, SECURE, OR ERROR FREE, OR THAT POSSIBLE DEFECTS WILL BE CORRECTED. RENAISSANCE SPECIFICALLY DISCLAIMS ANY REPRESENTATIONS OR WARRANTIES, EXPRESS, IMPLIED, OR STATUTORY, REGARDING THE PRODUCTS OR SERVICES, INCLUDING WITHOUT LIMITATION TO ANY IMPLIED WARRANTY OF MERCHANTABILITY, FITNESS FOR A PARTICULAR PURPOSE, GUARANTEED OUTCOME, RESULT OR SUCCESS, OR NON-INFRINGEMENT OR TITLE, OR ANY WARRANTY OR PROMISE ARISING FROM COURSE OF DEALING, USAGE OR PERFORMANCE.
- b. CONSEQUENTIAL, SPECIAL AND SIMILAR DAMAGES. IN NO EVENT WILL EITHER PARTY OR ITS AFFILIATES HAVE ANY LIABILITY ARISING OUT OF OR RELATED TO THE AGREEMENT FOR ANY LOST PROFITS, REVENUES, GOODWILL, OR INDIRECT, SPECIAL, INCIDENTAL, CONSEQUENTIAL, COVER, BUSINESS INTERRUPTION OR PUNITIVE DAMAGES, WHETHER AN ACTION IS IN CONTRACT OR TORT AND REGARDLESS OF THE THEORY OF LIABILITY EXCEPT AS TO DAMAGES INDEMNIFIED UNDER SECTION 9, EVEN IF A PARTY OR ITS AFFILIATES HAVE BEEN ADVISED OF THE POSSIBILITY OF SUCH DAMAGES OR IF A PARTY'S OR ITS AFFILIATES' REMEDY OTHERWISE FAILS OF ITS ESSENTIAL PURPOSE. THE FOREGOING DISCLAIMER WILL NOT APPLY TO THE EXTENT PROHIBITED BY LAW.
- c. OTHER LIMITS. RENAISSANCE'S LIABILITY UNDER THESE TERMS OF SERVICE: (I) WILL BE LIMITED TO DIRECT DAMAGES, AND DOES NOT INCLUDE ANY INDIRECT, CONSEQUENTIAL, SPECIAL, EXEMPLARY, PUNITIVE OR SIMILAR DAMAGES; AND (II) WILL NOT EXCEED THE LESSER OF (A) THE FEES, OR (B) \$100,000 AND (C) WITH RESPECT TO SERVICES OR DELIVERABLES, WILL

BE LIMITED TO CORRECTION OF SUCH SERVICES OR DELIVERABLES. IF CORRECTION IS IMPRACTICAL, RENAISSANCE WILL REFUND THE FEES RELATED TO NON-CORRECTABLE SERVICES OR DELIVERABLES ON A *PRO RATA* BASIS.

11. **Miscellaneous.**

- a. **Compliance with Applicable Laws.** Renaissance shall comply with the laws governing it as a provider of the Products and Services. Customer shall comply with the laws governing it as an educational organization or entity or its usage of the Products and Services.
- b. **Entire Agreement.** The Agreement, notwithstanding anything to the contrary in any purchase order, constitutes the entire agreement between the parties with respect to its subject matter and supersedes all other agreements or communications, whether written or oral. Any amendments or other changes to the Agreement must be made in writing and signed by both parties.
- c. **Severability.** If a provision of these Terms of Service is held to be invalid or unenforceable, the remaining provisions shall continue to be valid and enforceable as if such provision had not been set forth in these Terms of Service. Both parties agree to substitute a valid provision most closely approximating the intent of the severed provision.
- d. **Waiver.** No waiver by a party of a right or obligation under the Agreement is binding unless it is stated in writing to the other party. Failure of a party to enforce a breach of an obligation of another party under the Agreement does not limit that party's right to enforce a subsequent or different breach of that obligation.
- e. **Dispute Resolution.** Before prosecuting a Claim, the party asserting the Claim must provide the other party written notice of the Claim and not file a Claim until 60 days after that notice is delivered. During those 60 days, the parties each shall make a good faith effort to resolve the dispute. This sub-Section does not apply to or limit either party's right to seek equitable relief, or Renaissance's right to suspend or terminate Customer's access to or use of the Products under these Terms of Service.
- f. **Limitation of Action.** Any Claim by Customer must be brought within two years after the cause of action arose or such shorter period of time as required by applicable law.
- g. **Governing Law.** For United States-based Customers, the Agreement and all disputes or Claims arising under them are governed and shall be decided under the laws of the state, commonwealth or territory in which Customer resides based on the address set forth in the Quote, without regard to that state's, commonwealth's or territory's choice of law rules. For Customers based outside of the United States, all disputes or Claims arising under the Agreement shall be governed and decided under the laws of the State of Wisconsin.
- h. **Notices.** Notices under the Agreement shall be in writing and shall be deemed effective when delivered to the addresses set forth in the Quote (i) in-person, (ii) via the USPS, certified or registered mail, (iii) via reputable courier, addressed to the addresses set forth in the Quote, or (iv) via e-mail, in the case of notice to Renaissance at [legal@renaissance.com](mailto:legal@renaissance.com), and in the case of notice to Customer, to Renaissance's address of record for Customer.
- i. **Assignment.** The Agreement may be assigned only with the prior written consent of the other party which shall not be unreasonably withheld or delayed, except that Renaissance reserves the right to assign the Agreement without restriction to an Affiliate or in connection with a merger, acquisition, corporate reorganization, or sale of all or substantially all of its or an Affiliate's assets. Upon valid transfer, the Agreement inures to the benefit of, and binds, the successors and assigns of the parties. Any assignment in violation of this Section 11(i) is invalid.
- j. **Relationship of the Parties.** The parties are independent contractors, having no other business affiliation. Neither party may assume or create any obligation or make any representation or warranty on behalf of the other party. There are no third-party beneficiaries to the Agreement.
- k. **Anti-Corruption.** Customer represents that it has not received or been offered any bribe, kickback or payment, or any gift or thing of value from Renaissance or its employees or agents that violates any law or policy applicable to Customer. Both parties agree to comply with all anti-corruption laws applicable to it.
- l. **Duplicates.** The Agreement may be signed separately by the parties and the signature pages combined to create an original. Authorized electronic signatures are valid. Digitized copies of an original copy of the Agreement shall be treated as an original for all purposes.
- m. **Compliance with Export and Sanction Laws and Regulations.** The Products and Services may be subject to export laws and regulations of the United States and other jurisdictions. Renaissance and Customer each represent that it is not on any U.S. government denied-party list. Customer shall not permit Authorized User access to any Products or Services in violation of any U.S. export or sanction law or regulation.
- n. **Representations.** Each party represents and warrants that it is duly authorized to enter into the Agreement.
- o. **Equitable Rights.** Each party acknowledges that a breach or threatened breach of Section 6 (Intellectual Property) or Section 7 (Confidentiality) may cause the non-breaching party irreparable damage, entitling it to seek equitable relief, in addition to any other remedy.
- p. **Force Majeure.** Except for the obligation to make payments, neither party will be liable for any failure or delay in its performance under the Agreement due to any cause beyond its reasonable control, including, without limitation, acts of war or terrorism, acts of God, earthquake, flood, pandemic, embargo, labor shortage, governmental act or failure of the Internet (not resulting from the



actions or inactions of Renaissance); provided that the delayed party (i) gives the other party prompt notice of such cause, (ii) uses its reasonable commercial efforts to promptly correct such failure or delay in performance, and (iii) will; not be considered in breach during the duration of the Force Majeure Event. In the event a Force Majeure Event continues for a period of 90 calendar days, either party may elect to terminate the Agreement upon notice to the other party.

## EXHIBIT A

### Definitions

**"Affiliate"** of an entity means any entity controlling, controlled by or under common control with that entity. For the purposes of this definition, "control" means the possession, directly or indirectly, of the power to direct the management and policies of an entity through the ownership of voting securities or other equity.

**"Agreement"** means these Terms of Service together with any Quote or Statement of Work agreed to by the parties to which these Terms of Service are attached or into which these Terms of Service are incorporated by reference, together with any amendments, modifications, or renewals of such Quote or Statement of Work agreed by the parties in writing.

**"Authorized User"** means Customer's faculty, staff, administrators, teachers, and students accounted for in the Quote and, if applicable, the parents or legal guardians of those students, in each case who are authorized by Customer to access and use the Products under the strictly limited rights granted to Customer pursuant to the Agreement.

**"Claim"** means any lawsuit, administrative proceeding, arbitration, or other legal claim for relief.

**"Confidential Information"** means all technical and non-technical information, including without limitation patent, copyright, trade secret, and proprietary information, techniques, sketches, drawings, models, inventions, know-how, processes, apparatus, equipment, software programs and software source documents related to the current, future and proposed products and services of each of the parties, and includes without limitation, each party's respective information concerning research, experimental work, development, design details and specifications, engineering, financial information, business forecasts and marketing plans and information. Confidential Information does not include any information that (i) is or becomes generally known to the public without breach of any obligation owed to the disclosing party, (ii) was known to the receiving party prior to its disclosure by the disclosing party without breach of any obligation owed to the disclosing party, (iii) is received from a third party without knowledge of any breach of any obligation owed to the disclosing party, or (iv) was independently developed by the receiving party.

**"Content"** means all types of information including, without limitation, books, articles, recordings, documentation, photographs, graphics, video, databases or any other compilations rendered available by Renaissance or accessible through the Products, as well as all related Intellectual Property Rights. For the avoidance of doubt, Content includes all original expressions in any media, as well as any derivations of such original expressions.

**"Customer"** means the school, school district, educational institution or other organization that signed the Quote.

**"Customer Data"** means: (i) data provided by the Customer in connection with the Products; and (ii) data generated by Authorized Users' use of the Products that is associated with an individual person. The categories of data collected by Products are described in the Categories of Data Collected by Product available at <https://doc.renlearn.com/KMNet/R62941.pdf>. For the avoidance of doubt, Customer Data does not include Deidentified Data or system performance, transactional, or other similar statistics or analytics.

**"Data Protection Addendum"** means Exhibit D to these Terms of Service and applies to PII based on the location of the applicable individual as set forth in the Data Protection Addendum. Renaissance reserves the right to update Exhibit D in its sole discretion.

**"Deidentified Data"** means Customer Data that has had any PII removed to such a degree that there is no reasonable basis to believe that the remaining data can be used to identify an individual.

**"Deliverables"** means any work product or materials to be developed or delivered by Renaissance in connection with the Products or Services, as well as all related Intellectual Property Rights.

**"Intellectual Property Rights"** means patents, patent rights, patent applications, and continuing (continuation, divisional, or continuation-in-part) applications, re-issues, extensions, renewals, and re-examinations of patents; registered and unregistered trademarks and service marks, trademark and service mark rights, trade names, and domain names; registered and unregistered copyrights; trade secrets and inventions, whether patentable or unpatentable; all other intellectual, industrial, or proprietary rights as now existing or that come into existence; and pending applications for and registrations of any of the foregoing; whether arising under the laws of the United States or laws of any other state, country, or jurisdiction in the world.

**"Person"** means a person, entity or organization.

**"Personally Identifiable Information or PII"** is defined in the Data Protection Addendum.

**"Premium Hybrid Products"** means the paid and free versions of the educational online software products (including, without limitation, all related Intellectual Property Rights, Deliverables and Content) listed on Exhibit C, access to which is being provided to Customer under the Agreement. Renaissance reserves the right to update Exhibit C in its sole discretion.

**"Products"** means the Premium Hybrid Products and other educational online software products identified in the Quote (including, without limitation, all related Intellectual Property Rights, Deliverables and Content) distributed by Renaissance or one of its Affiliates.

**"Quote"** means that certain document identified as a sales quote, provided by Renaissance to Customer and accepted by Customer, setting forth certain Products or Services being obtained by Customer from Renaissance for a specified Subscription Period, as well as such other business terms to which the parties agree to be bound, and which expressly incorporates these Terms of Services.

**"Recipient"** means a party or its Affiliate that receives Confidential Information of the other party.

**"Renaissance"** means Renaissance Learning, Inc., a Wisconsin corporation.

**"Renaissance Data"** means the Deidentified Data and the performance, system and operational data created by Renaissance.

**"Services"** means those professional services identified in the Quote and any other professional, technical or support services that Renaissance provides to Customer as set forth in a Quote or Statement of Work.

**"Service Suspension"** means the term as described in Section 2(b)(v).

**"Subscription Period"** means the time during which Customer's Authorized User are authorized under the Agreement to access the Products. The Subscription Period starts and ends on the dates proscribed in the Quote, unless the Agreement is terminated early by either party; then, the Subscription Period ends on the date of termination.

**"Term"** means the term as described in Section 5(a).

**"Terms of Service"** means this Terms of Service and License document and all of the exhibits to it, each of **which is incorporated and made part of the Terms of Service**.

**"Third-Party Services"** means hardware, software, content, data or services not provided by Renaissance.

**"Valid Login Information"** means usernames and passwords or other credentials that Customers or Authorized Users use to access the Products.

## EXHIBIT B

### Additional Terms and Conditions - Services

Customer agrees to the following for any Services ("Training") made available to it either remotely or on-site:

- a. To provide facilities that are conducive to adult learning, including, without limitation, a computer, broadband Internet connection and two-way sound for each of Customer's participants.
- b. To participate in a pre-planning meeting with Renaissance (at least four weeks for on-site; and, at least three days for remote) before the Training, allowing Renaissance to tailor the Training content to the specific needs of the participants. Renaissance will focus the Training on learning outcomes agreed to during the pre-planning meeting. Renaissance will also strive to adapt the Training to meet needs raised at the Training.

- d. To use any Services within the Subscription Period. Otherwise, Customer risks losing those services, in Renaissance's discretion.
- e. To Renaissance's using third parties to assist with the Services (Renaissance will be responsible for ensuring their integrity and compliance with the Agreement, as well as their compensation and expenses).
- f. To refrain, without Renaissance's written consent, from recording the Training and from copying or sharing any materials or Content.
