SECTION 1.0 –MANDATORY PRE-BID CONFERENCE:

A mandatory Pre-Bid Conference and inspection of the site shall be held:

All bidders must attend the Mandatory pre-bid conference and will be required to sign in and out as evidence of attendance. In accordance with LSA R.S. 38:2212(I), all prospective bidders shall be present at the beginning of the Mandatory pre-bid conference and shall remain in attendance for the duration of the conference. Any prospective bidder who fails to attend the conference or remain for the duration shall be prohibited from submitting a bid for the project.

SECTION 2.0 – SCOPE:

We extend this bid to supply all labor, materials, delivery, shipping, and all other incidentals necessary to remove the existing floor tiles, grout, cove base, etc. and supply and install new bidder supplied porcelain floor tiles, grout, floor patch and cove base on the first floor of the Joseph S. Yenni Building located at 1221 Elmwood Park Boulevard Harahan, LA 70123.

SECTION 3.0 –LICENSE REQUIREMENTS:

The following Louisiana State license shall be required for this project:

Commercial License with a **Specialty License in one of the following categories:**

- Stone, Granite, Slate, Resilient Floor Installations, Carpeting
- Flooring and decking

SECTION 4.0 – PERFORMANCE BOND:

A Performance Bond in the amount of 100% of the total contract price will be required. Performance bond shall be produced upon contract execution.

SECTION 5.0 – PAYMENT BOND:

A payment bond in the amount of 100% of the total contract amount will be required. Payment bond shall be produced upon contract execution.

SECTION 6.0 – QUANTITIES/INSPECTION:

Bidders must inspect the site and perform their own measurements in order to determine the proper quantity of labor and materials and equipment required to complete this project.

SECTION 7.0 – BID SPECIFICATIONS:

7.1 The following shall be performed prior to the installation of the new flooring:

A: Demolition:

- Remove and properly dispose of all existing floor covering, grout and cove base. See Attachment "A" for location.
- Location shall be field verified with a Jefferson Parish Department of General Services representative prior to start of work.
- Phasing of the removal of the existing flooring will be discussed and planned at the pre-construction meeting. All work must allow for normal business to be conducted.

B: Preparation:

- Prepare existing subflooring as per new flooring manufacturer guidelines.
- Supply and install ten (10) twenty five pound bags of Bostik Webcrete® 95 floor leveler to level floor surface.

7.2 The following shall be performed during installation of new floor covering and cove base:

A: Floor tile:

- Supply and install new DALTILE Colorbody™ Haut Monde, HM07 Aristocrat Cream 24"x 24" porcelain tile. See Attachment "B" for location. Location shall be field verified with a Jefferson Parish Department of General Services representative prior to start of work.
- Bostik™ Big Tile and Stone Smart Adhesive shall be used to adhere tile to floor.
- Tile shall be installed level with all existing thresholds and landings.
- Tile shall be installed as per all manufacturer recommendations and guidelines.
- Supply and install Bostik™ H199 timber grout.
- Grout lines shall be 3/16 inch thick.
- Starting from the South Entrance (entrance indicated on attachment "B") a 3/16 inch wide expansion joint shall be installed every twenty (20) feet. (Approximately three expansion joints)
- Expansion joints shall be made of Bostik™ siliconized acrylic tub and tile caulk.
- Color of expansion joint caulking shall match the color of the grout. In the area where the expansion joint falls out.
- Supply one full case of DALTILE Colorbody™ Haut Monde, HM07 Aristocrat Cream 24"x 24" porcelain tile as attic stock.

B: Floor tiles (Elevator lobby inserts):

- Supply and install new ANATOILIA Prima™ charcoal 24"x 24" high polished porcelain tile. See Attachment "C" for location. Location shall be field verified with a Jefferson Parish Department of General Services representative prior to start of work.
- Supply and install new DALTILE Colorbody™ Trellis Oak, TR21 Natural Ash 9"x36" porcelain tile. See attachment "C" for location.
- Bostik™ Big Tile and Stone Smart Adhesive shall be used to adhere tile to floor.
- Tile shall be installed as per all manufacturer recommendations and guidelines.
- Supply and install Bostik™ H142 vivid French gray grout.
- Grout lines shall be 3/16 inch thick.
- Supply one full case of ANATOILIA Prima™ charcoal 24"x 24" porcelain tile.

C: Border tile and elevator lobby:

- Supply and install new DALTILE Colorbody™ Trellis Oak, TR21 Natural Ash 9"x36" porcelain tile. See attachment "D" for location. Location shall be field verified with a Jefferson Parish Department of General Services representative prior to start of work.
- Border tiles shall be installed ¼ inch off all walls to allow for expansion.
- Bostik™ Big Tile and Stone Smart Adhesive shall be used to adhere tile to floor.
- Tile shall be installed level with all existing thresholds and landings.
- Tile shall be installed as per all manufacturer recommendations and guidelines.
- Supply and install new bidder supplied low profile Large Vinyl T-Insert #175 snap down floor transitions at all tile to marble, tile to vinyl tile, tile to carpet, and tile to concrete.
- Transitions shall meet or exceed all Americans with Disabilities Act (ADA) guidelines.
- Supply one full case of DALTILE Colorbody™ Trellis Oak, TR21 Natural Ash 9"x36" porcelain tile for attic stock

D: Wall base:

- Supply and install new Roppe 700 Series 4.5 inch black vinyl wall base with toe.
- Wall base shall be installed as per all manufacturer recommendations and guidelines.
- Install wall base in lengths as long as possible without gaps at seams and with tops of adjacent pieces aligned.
- Tightly adhere wall base to substrate throughout length of each piece, with base in continuous contact with horizontal and vertical substrates.

SECTION 9.0 - HOURS OF WORK:

Work shall be performed after normal working hours Friday 6:00 p.m. to Monday 5:00 a.m. Flooring shall be ready for use at open of business on Monday. All unfinished work shall be free of hazards.

SECTION 10.0 – CLEANING AREA AND SAFETY:

Job site must be clean and free of all litter and debris daily and upon completion of the project. Passageways must be kept clean and free of material, equipment, and debris at all times. Inflammable material must be removed from the job site daily, because storage will not be permitted on the premises. Precautions must be exercised at all times to safeguard the welfare and safety of the general public, employees of Jefferson Parish, and other Parish officials.

Trash and debris shall be removed daily, shall become the property of the successful bidder and shall be placed in appropriate dumpsters and hauled away by the successful bidder.

SECTION 11.0 – EXISTING STRUCTURE

Should any damage be caused by this work the successful bidder shall restore the damage to its original condition, with the same type materials, finish, and workmanship.

SECTION 12.0 – WARRANTY:

A minimum of one (1) year labor and materials warranty shall be provided in writing from the manufacturer starting from the date of acceptance of the project against defects. The bidder must agree, upon written notice from the owner, promptly and without charge, and to the satisfaction of the owner, to make changes, replacements, and corrections which may be required to make good all defects in materials and/or equipment under its intended use, within the warranty period, at no cost to the owner.

SECTION 13.0 – LIQUIDATED DAMAGES:

Commencing on the ninety-first day following the notice to proceed until work is substantially complete, liquidated damages will be assessed in the amount of \$500 per day.

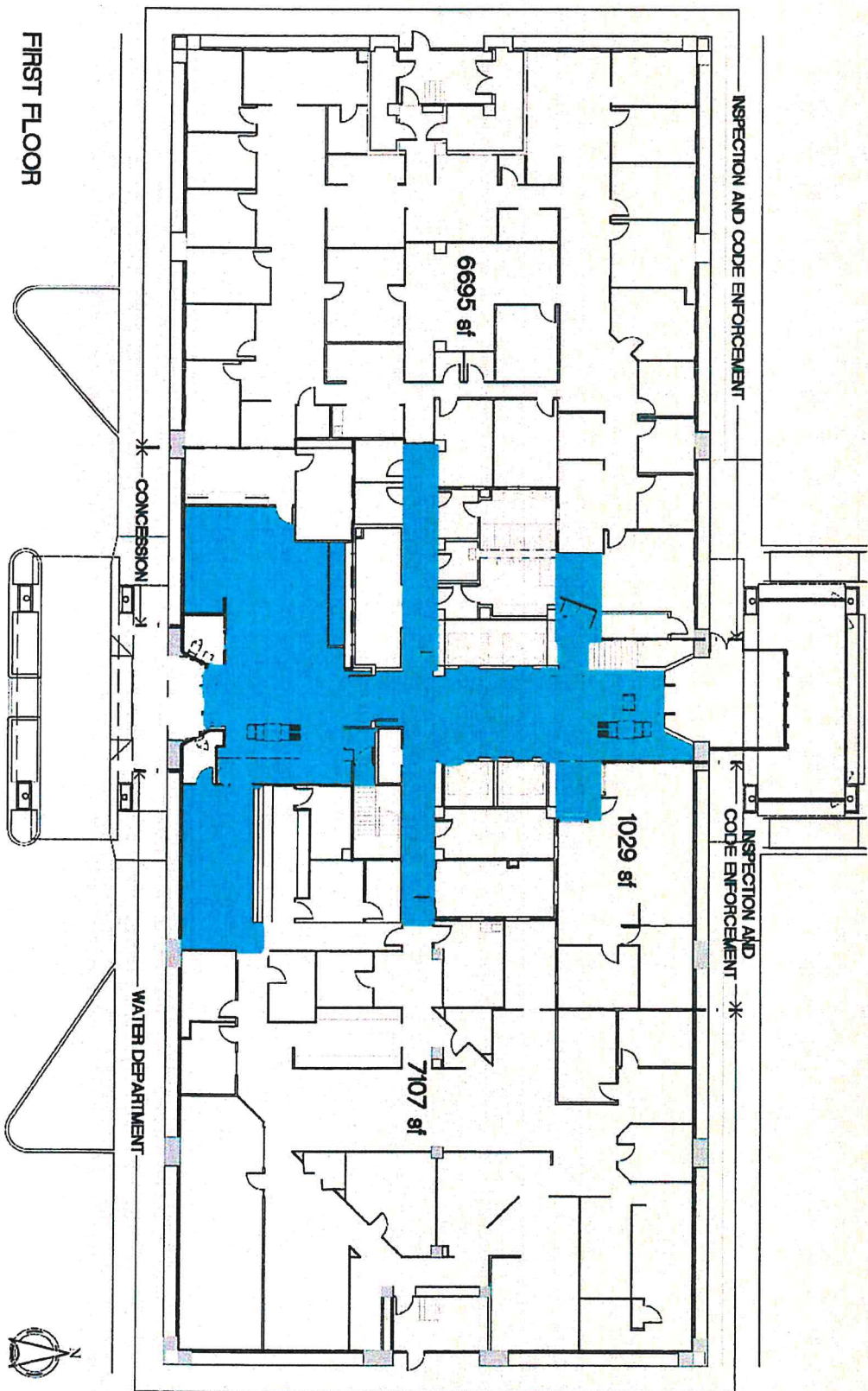
SECTION 14.0 – PRE-CONSTRUCTION CONFERENCE AND NOTICE TO PROCEED:

A Pre-Construction Conference shall be held between the successful bidder and the owner before any work commences.

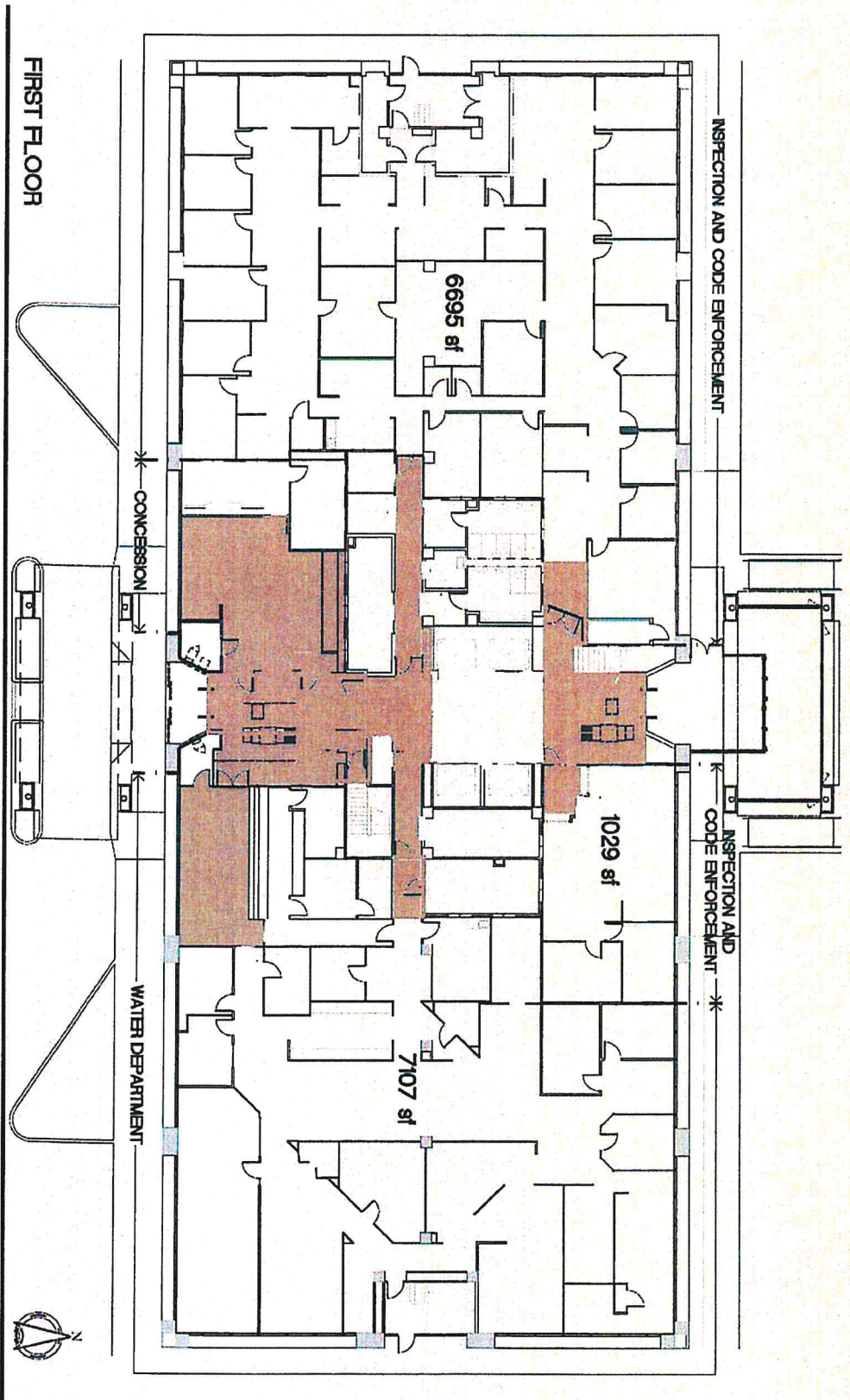
No materials shall be ordered until the successful bidder receives a written "Notice to Order Materials" from the Department of General Services.

No work shall be performed until the successful bidder receives a written "Notice to Proceed" to begin work, from the Department of General Services.

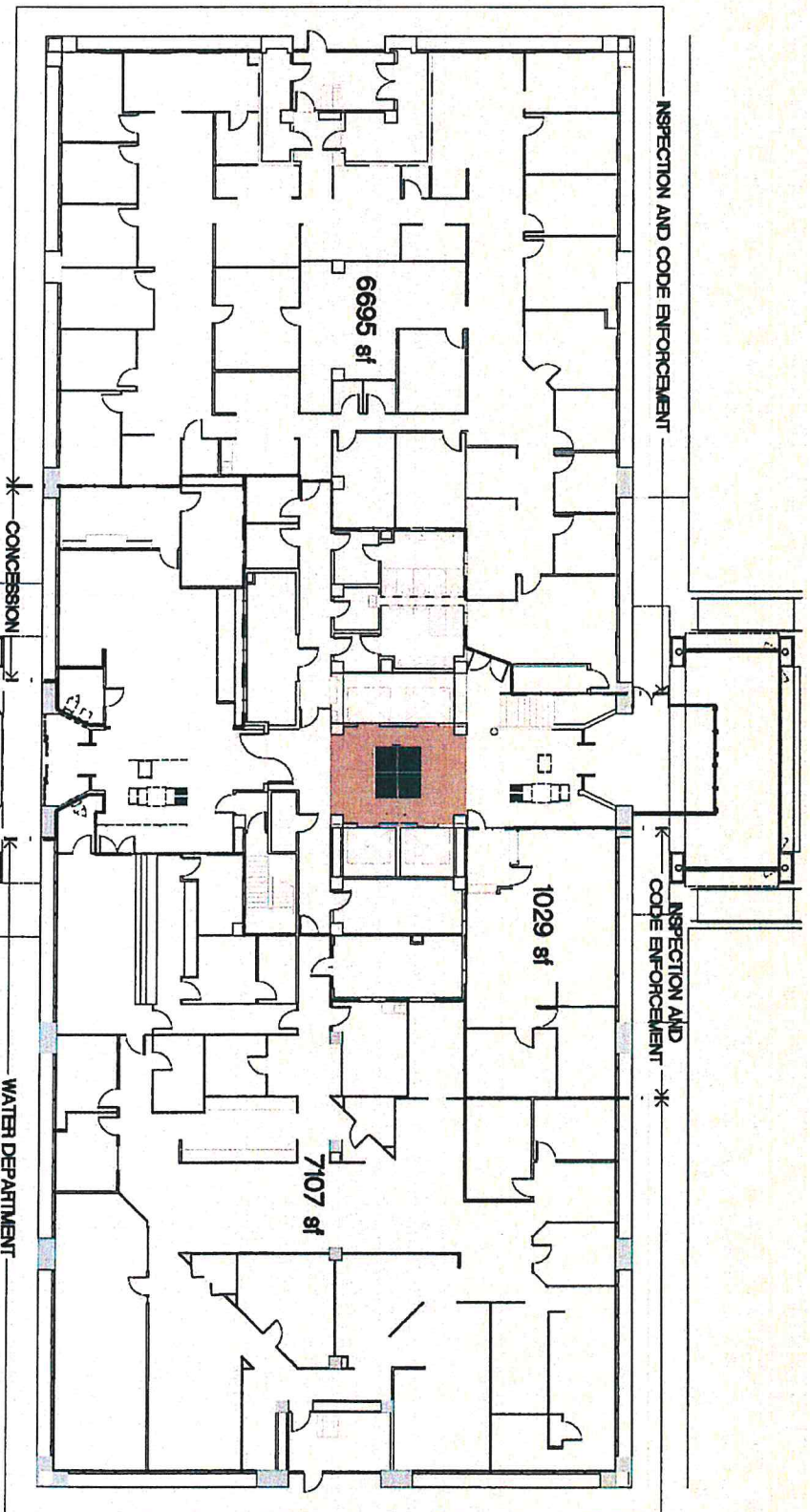

Contractors may not commence any work under any ensuing contract unless and until all required insurance and associated evidentiary requirements thereto have been met, along with any additional specifications contained in the **Invitation to Bid**. Except as where otherwise precluded by law, the Parish Attorney or his designee, with the concurrence of the Director of Risk Management or his designee, may agree on a case-by-case basis, to deviate from Jefferson Parish's standard insurance requirements, as provided in this Section. Vendors requesting deviation therefrom shall submit such requests in writing, along with compelling substantiation, to the Purchasing Department prior to the bid's due date. Any changes to the insurance requirements will be reflected in the bid specifications and addenda. Prior to contract execution and at all times thereafter during the term of such contract, contractors must provide and continuously maintain all coverages as required by the foregoing Resolutions, and the contract documents. Failure to do so shall be grounds for suspension, discontinuation or termination of the contract.

For bidding purposes, bidders must submit with bid submission a current (valid) insurance certificate evidencing the required coverages. Failure to comply will cause bid to be rejected. The current insurance certificate will be used for proof of insurance at time of evaluation. Thereafter, and prior to contract execution, the low bidder will be required to provide final insurance certificates to the Parish which shall name **the Jefferson Parish, its Districts Departments and Agencies under the direction of the Parish President and the Parish Council** as additional insureds regarding negligence by the contractor for the Commercial General Liability, Workmen's Compensation Insurance and the Comprehensive Automobile Liability policies. Additionally, said certificates should reflect the name of the Parish Department receiving goods and services and reference the respective Jefferson Parish bid number.

DEDUCTIBLES - The Parish Attorney with concurrence of the Director of Risk Management have waived the deductible section of the Terms and Conditions for all Invitations to Bid, until further notice.

UMBRELLA LIABILITY COVERAGE

An umbrella policy or excess may be used to meet minimum requirements.

FOR CONSTRUCTION AND RENOVATION PROJECTS:

The following are required unless otherwise specified in the bid. Such insurance is due upon contract execution.

1) **OWNER'S PROTECTIVE LIABILITY**

To be for the same limits of liability for bodily injury and property damage liability established for commercial general liability.

2) **BUILDER'S RISK INSURANCE**

The contractor shall maintain Builder's Risk Insurance at his own expense to insure both the owner (Parish of Jefferson) and contractor as their interest may appear.
