
Q1 On the 2 new net systems are you wanting to replace the existing tennis nets or on the court with the 2 pickleball courts install permanent pickleball nets?

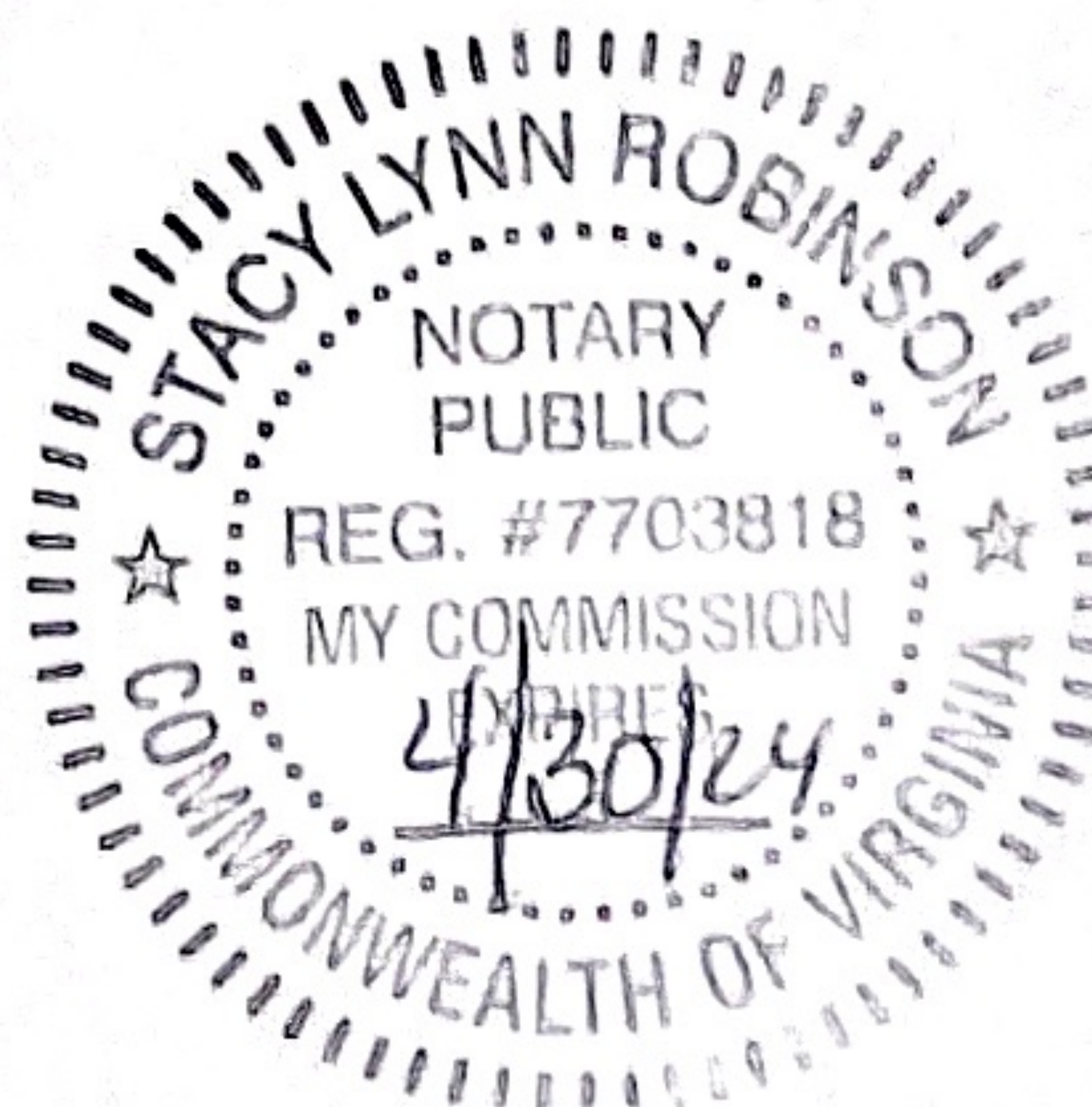
