PLAN OF OPENING

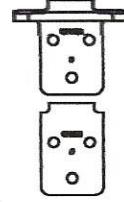

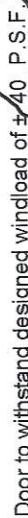

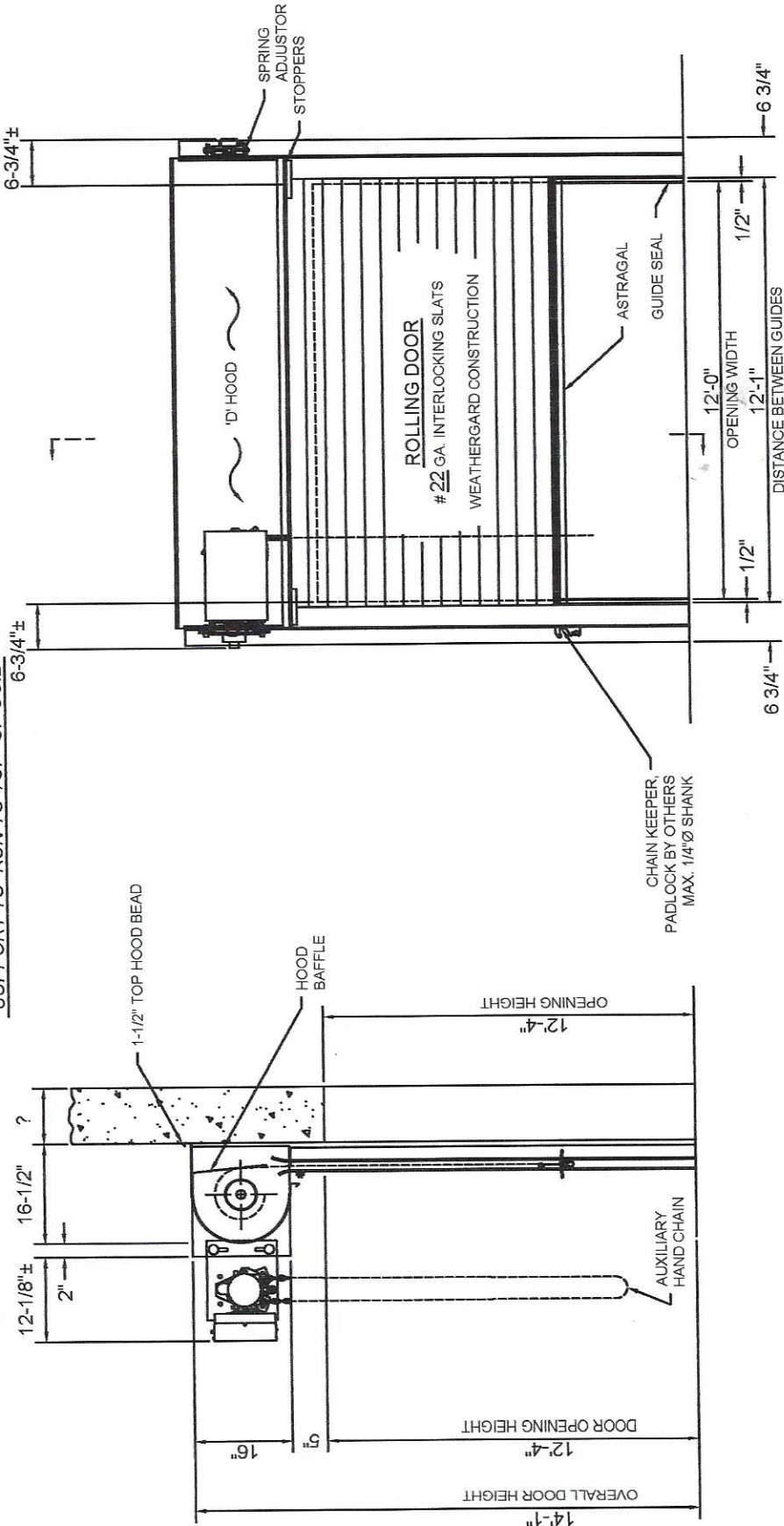
