If evidence is submitted substantiating that a false attestation has been made and the project must be readvertised or the contract cancelled, the awarded entity making the false attestation shall be responsible to the public entity for the costs of rebidding, additional costs due to increased costs of bids and any and all delay costs due to the rebid or cancellation of this project.



The East bank Office of Purchasing is now open! We are located in the Joseph S. Yenni Building, 1221 Elmwood Park Blvd, Suite 404, Jefferson, LA 70123. Bidders may submit bid responses at this location, pending authorization in each bid package. Bidders should carefully read and must respond accordingly per the requirements of the bid packages. **NOTE: Bidders submitting bids on the day of bid opening, bidders must submit at the West Bank location only.**

#### Other Changes Continued:

- Effective June 1, 2017, bidders may no longer send bid responses via facsimile, as some bid solicitations may provide.
