Any prospective bidder who fails to attend the conference or remain for the duration shall be prohibited from submitting a bid for the project.

### **Section 1.0 – Pre-Bid Conference:**

A Pre-Bid Conference will not be necessary. A site visit is required.

### **Section 2.0 – Scope:**

We extend this proposal to supply materials, equipment and labor to install 2 top windows, and 8 bottom windows with safety, tempered and insulated glass at Estelle Community Center

### **Section 3.0 – Bid Specifications:**

The successful bidder shall supply all materials, equipment, and labor to install 10 insulated, tempered and safety glass windows at Estelle Community Center as follows:

- Replace 2 top windows with insulated, and tempered safety glass
- Replace 8 bottom windows with insulated, and tempered safety glass
- All bidders must visit site to perform their own measurements to determine the proper quantity of materials and equipment to properly complete this project.
- Contractor shall be responsible for daily housekeeping and any damage that may occur while performing this project


