All bidders are required to attend a mandatory pre-bid conference. This conference is to inspect the existing baseball backstop and the new location with the Library and Owner's representative, to allow for questions to be asked, for clarifications, etc.

The Mandatory Pre-Bid conference and inspection, does not relieve the successful bidder from the necessity of furnishing materials or performing any work that may be required to complete the bid, in accordance with the written specifications without any additional costs to the Owner.

All bidders must attend the Mandatory pre-bid conference and will be required to sign in and out as evidence of attendance. In accordance with LSA R.S. 38:2212(I), all prospective bidders shall be present at the beginning of the mandatory pre-bid conference and shall remain in attendance for the duration of the conference. Any prospective bidder who fails to attend the conference or remain for the duration shall be prohibited from submitting a bid for this project.

Section 2.0 Scope:

We extend this proposal to cover all labor, materials and equipment necessary to remove the existing baseball backstop and build a new baseball backstop (location and installation time to be determined) at the Riverdale Middle School located at 3900 Jefferson Highway, Jefferson, Louisiana 70121.

Section 3.0 – License Requirements:

The following Louisiana State license shall be required for this project:

- Louisiana State Commercial License

Section 4.0 Quantities/Inspections:

Bidders must inspect the site and perform their own inspections, measurements, and surveys to determine the proper quantities of labor, hours, equipment, supplies, materials, etc. required for this bid.

Section 5.0 Specifications:

The successful bidder will provide all labor, materials, and equipment necessary to demolish the existing baseball backstop and the removal of subsurface concrete and fill all holes.

The successful bidder will provide all labor, materials, and equipment necessary to build a new 60' x 22' baseball backstop with sloped top to include 3" galvanized scheduled 40 post, 9 gauge fabric and steel ties.

All work shall be performed by industry standards.

The successful bidder will be responsible for the disposal of the old backstop.

NOTE: ALL WORK WILL BE DONE AT THE RIVERDALE MIDDLE SCHOOL LOCATED AT 3900 JEFFERSON HIGHWAY, JEFFERSON, LOUISIANA 70121.

Section 6.0 Safety:

Safety must be exercised at all times to safeguard the welfare and safety of the general public, the students and employees of Riverdale Middle School, Jefferson Parish, and the Library. Job site must remain clean and without excessive litter and debris, without obstructions to walkways, driveways, and the parking lot. These areas must remain unobstructed and free in ingress and egress, and pedestrian safety.

Section 7.0 – Cleaning Area and Safety:

Job site must be clean and free of all litter and debris daily and upon completion of the contract. Passageways must be kept clean and free of material, equipment, and debris at all times. Inflammable material must be removed from the job site daily, because storage will not be permitted on the premises. Precautions must be exercised at all times to safeguard the welfare and safety of the general public, employees of Jefferson Parish, and other Parish officials.

Section 8.0 – Permits:

The successful bidder shall obtain any and all permits required by the Jefferson Parish Department of Inspection and Code Enforcement. The successful bidder shall also be responsible for payment of these permits. All permits must be obtained prior to the start of the project.

STANDARD INSURANCE REQUIREMENTS – BIDS UNDER \$30k

All required insurance under this bid shall conform to Jefferson Parish Resolution No. 113646 or No. 113647, as applicable. Contractors may not commence any work under any ensuing contract unless and until all required insurance and associated evidentiary requirements thereto have been met, along with any additional specifications contained in the bid. Except as where otherwise precluded by law, the Parish Attorney or his designee, with the concurrence of the Director of Risk Management or his designee, may agree on a case-by-case basis, to deviate from Jefferson Parish's standard insurance requirements, as provided in this Section. Vendors requesting deviation therefrom shall submit such requests in writing, along with compelling substantiation, to the Purchasing Department prior to the bid's due date. Any changes to the insurance requirements will be reflected in the bid specifications and addenda. However, if a bidder has on file with the Purchasing Department a current (valid) insurance certificate that fulfills the requirements in this document, then this will be accepted as evidence of same.
