BOARD OF COMMISSIONERS GREATER LAFOURCHE PORT COMMISSION

The undersigned bidder, having familiarized itself with the advertised Bid Notice and this Proposal (all of which are made a part hereof) hereby proposes, in compliance with these stipulations, to furnish the Greater Lafourche Port Commission, the following or any part thereof, complete as herein specified, which includes all applicable taxes (except sales tax which the GLPC is exempt).

GLPC will award the Proposal with the lowest "Company Mark Up." In the event of a tie on low "Company Mark Up," GLPC will base its award on which such tied Proposal would result in the lowest administrative expense to the GLPC.

The price to be billed by the successful Vendor will be the Oil Price Information Service ("OPIS") Calendar Day Average price at the Garyville/Port Allen/Convent Terminal for said fuel on date of delivery plus "Company Mark Up" bid and applicable taxes. For deliveries on Saturday and Sunday, the immediately prior OPIS Calendar Day Average price for the immediately preceding Friday will be used. "Company Mark Up" entered on the bid form shall include all charges which the bidder seeks to be compensated for (over and above the OPIS index price, but excluding applicable taxes) on a "per gallon" basis, including but not limited to all overhead and profit. "Company Mark Up" is the only factor which will be compared for the purpose of determining the low bidder. Please note that the successful Vendor shall bill based upon the OPIS index price plus the "Company Mark Up," not on the actual cost from the refinery or distributor to the Vendor plus the "Company Mark Up."

GLPC shall receive an OPIS index price report from the Vendor with each purchase.

"Applicable Taxes" excluding sales tax and "Bid Price for Day" are for informational purposes only.

It is not a requirement that all bidders submit a bid for each line item fuels. Bidders are free to select which line item fuels for which they wish to submit a bid. The Commission at its discretion, may elect to award all or any portion of the following items.

The selected bidder(s) will be required to execute both the Attestation Clause and Affidavit Regarding Employment Verification, as required by Louisiana's Public Bid Law, within 10 days after the bid opening date (January 5, 2018).

GLPC hours of operations to receive deliveries are 7:00AM to 3:00PM Monday thru Friday. The selected bidder(s) shall deliver fuel within the hours of operations listed above at the earliest time but no later than 3 days after order.
